Brenda Wells, Human Affairs Committee member and founder of i-5 Freedom Network, recommended taking this issue to Code Compliance and to the City Council for further review and regulation.

- A. Homelessness Town Hall The Human Affairs Subcommittee provided an update on the community town hall on homeless issues. The City Council will be taking the lead on organizing the town hall. The date is yet to be determined. Mayor Pro Tem Bane and Councilmember Ferguson requested that the HAC provide the following assistance:
 - Provide a booth and contact organizations such as FAM and Mercy House to also have booths.
 - Create a handout for distribution to town hall attendees that includes facts and figures related to homelessness.
 - Curate questions to be asked.

A. San Clemente High School Student Award — City staff distributed nomination forms to the Guidance Counselors' at San Clemente High School. Seven outstanding juniors were nominated and are completing the Human Relations Leadership Award Nominee Questionnaire. The completed questionnaires will be forwarded to HAC members, Paula Kohl and Toby Huddle, prior to interviewing the nominees on April 16, 2019 and April 17, 2019.
