1 Pursuant to Local Rule 8-3, Plaintiffs Housing Is A Human Right Orange

6 **RECITALS**

7 WHEREAS, Plaintiffs filed their Complaint in this action in the United States
8 District Court for the Central District of California on or about February 27, 2019
9 (Dkt. No. 1);

10 WHEREAS, Plaintiffs filed their First Amended Complaint in this action on
11 or about May 22, 2019 (Dkt. 28);

12 WHEREAS, on May 24, 2019, Defendant City of San Clemente was served
13 with the Complaint and First Amended Complaint in this action;

14 WHEREAS, on May 28, 2019, Defendants City of San Juan Capistrano and
15 City of Aliso Viejo were served with the Complaint and First Amended Complaint
16 in this action;

17 WHEREAS, the deadline to respond to the First Amended Complaint is
18 currently June 14, 2019, for San Clemente and June 18, 2019, for San Juan Capistrano
19 and Aliso Viejo;

20 WHEREAS, on June 3, 2019, the parties entered into a stipulation extending
21 the time for Defendant Cities to respond to the First Amended Complaint by 30 days
