# Subject: Agenda Item 7: Staff Report

**Discussion:** Summer has been extremely busy for us. It has been all hands on deck to complete the regular mowing tasks as the grass is growing aggressively. The course is taking on a reddish brown hue at the moment, a telltale sign of the presence of gray leaf spot disease. You may remember that we opted not to treat the fairways with fungicide this year since last season we spent a small fortune on fungicides without much control to show for it. Thus far the course is holding out reasonably well so it appears the approach of little to no treatment was reasonably successful. We are looking forward to the fall when the course will green up again and we will be able to begin verticutting and topdressing greens.
