Subject: *APPEAL OF CONDITIONAL USE PERMIT 18-534, AT&T SMALL CELL (MSVJO 014) IN THE RIGHT-OF-WAY AT 3018 CAMINO VERA CRUZ CS*

Fiscal Impact: There is no fiscal impact for the tabling of this item.

Summary: This item is a continuation of an item heard at the October 1, 2019 regular City Council meeting. The project concerns an appeal of the Planning Commission’s August 21, 2019 decision to deny without prejudice Conditional Use Permit (CUP) 18-534 for a proposed small cell wireless telecommunications facility (MSVJO 014) on a replacement streetlight pole in the right-of-way at 3018 Camino Vera Cruz CS. The decision of the Planning Commission was appealed by the applicant, New Cingular Wireless PCS, LLC dba AT&T Mobility (“AT&T”).

After discussions between the parties, the applicant and the City agreed it is mutually beneficial for the City to have in place an ordinance addressing the siting and design of small cell facilities prior to these applications being approved or denied. The City anticipates this Ordinance will be in place in March 2020 or soon thereafter. The applicant has agreed to toll the shotclock until March 17, 2020 (see Attachment 1), at which time if the application is still pending, the project would be scheduled for decision by the City Council, and the hearing will be re-noticed.

This letter shall serve as an agreement (the "Letter Agreement") between the City of San Clemente (the "City") and AT&T (the "Applicant") regarding the above referenced applications (the "Applications"), which the City initially received on August 31, 2018 and which were resubmitted on May 28, 2019 after the City issued a Notice of Incompleteness on September 28, 2018.

On August 21, 2019, the City of San Clemente Planning Commission considered the above-referenced applications and denied both applications. AT&T appealed the Planning Commission's decision to the City Council. The appeal was originally scheduled to be heard at the September 17, 2019 City Council meeting, that is, in advance of the September 27th expiration of the applicable shot clock. However, AT&T requested that the hearing be continued until the October 1, 2019 meeting and agreed to toll the shot clock until October 16, 2019.

On October 1, 2019, at the City Council public hearing for the Applications, AT&T's representative agreed on the record to toll the shot clock on these applications until November 19, 2019 to allow AT&T additional time to submit necessary information to the City Council for consideration as part of the appeal hearing, as memorialized in Tolling Agreement No. 2, dated October 7, 2019.

Subsequently, after discussions between the parties, the applicant and the City agreed that it is mutually beneficial for the City to have in place an ordinance addressing the siting and design of small cell facilities prior to these applications being approved or denied. The City anticipates this Ordinance will be in place in March 2020 or soon thereafter. Based on the foregoing, the parties agree to extend the time for action on the Applications as follows: until March 17, 2020.

This Letter Agreement shall not be construed as an admission by the City that absent this extension it would have failed to act within time periods required by applicable federal, state, or local laws or regulations; or that its failure to act on the Applications on or before March 17, 2020 would be a violation of the same. This Letter Agreement is not intended to imply or assure any particular outcome of the City's processing of the Applications. Except as required to give effect to this extension, neither party waives any claims or defenses it might otherwise have.
