PAYMENT AUTHORIZATION FOR PURCHASE, INSTALLATION AND LICENSING OF TIGHTROPF

CABLECAST SERVER TO REPLACE FAILED 360 SERVER.

Fiscal Impact: Yes. The combined purchase price of \$35,474.28 is budgeted in account #018-245-

45500-000-00000.

Summary:

Staff seeks City Council authorization to purchase and install a Tightrope Cablecast

Server, related software, and installation services in the amount of \$35,474.28 in FY

2019-20.

Background:

The majority of the equipment in the City's video broadcast room has been functioning for well over a decade. Throughout that time the City has added equipment and functionality to the room in order to facilitate new technologies such as online streaming. However, the core function of the room continues to be the delivery of

public meeting content to the City's public access cable television channel.

Discussion:

For over ten years, the City has relied on the 360 System Server to record, schedule and playback video content, including City Council and Planning Commission meetings and Around Town videos. The 360 System Server recently became unstable and despite several attempts to repair, the system has failed. Due to the failed system's antiquated hardware and design, the proposed replacement for this component will include additional functionality and will be compatible with future equipment upgrades.

Staff sought competitive quotes from media/broadcast companies that regularly do business with municipalities in Southern California. Three proposals were received from Burst Communications, Media Control Systems, and Triton Technology Solutions. The lowest quote came from Triton Technology Solutions in the amount of \$35.474.28 including tax, delivery, installation, and configuration.

This purchase will be funded from the Local Cable Infrastructure Fund, a Special Revenue Fund which accounts for cable franchise fees governed by the State of California "Digital Infrastructure and Video Competition Act" (DIVCA), set forth in Public Utilities Code Section 5800. These funds are restricted for equipment and infrastructure costs for public, educational, or government (PEG) access programming.

Recommended

Action:

1. STAFF RECOMMENDS THAT the City Council authorize payment to Triton Technology Solutions in the amount of \$35,474.28 in Fiscal Year 2019-20 for the purchase, installation, and licensing of a Tightrope Cablecast Server.
