CONSIDERATION OF PUBLIC MURAL AT END OF PIER RESTROOM FACILITY.

Fiscal Impact: None.

Summary:

Staff recommends that the Beaches, Parks and Recreation Commission recommend the City Council approve the installation and design of public art entitled "Open Door Policy" on the end of pier restrooms. The purpose of this project is to provide artistic enhancements to a utility storage door located on the end of pier restroom facility.

Background:

City Council adopted a process for the review and approval of public art on public property. This structured process allows for individuals or organizations to apply to create and establish artwork on public property by going through a formal review process, ending with City Council approval and acceptance.

The Beaches, Parks and Recreation Department received an application for public art from PierPride Foundation (Attachment 1) with a request to install a painted mural at the end of pier restrooms on the utility door located between the men's and women's restroom doors (Attachment 2). Per the Art on Public Property process, a 30-day public notice was posted on January 17, 2020 at the proposed mural site. No comments or feedback have been received from the public regarding the posting or proposal.

Discussion:

In fall 2019, PierPride coordinated a call for public art. For the artwork selection, the organization commissioned an art jury committee consisting of two members of PierPride, the president of the San Clemente Art Association, one councilmember. and the Recreation Manager. After review, the committee selected "Open Door Policy" for its playful design and unique, eye-catching character (Attachment 3).

The artwork is designed by, and will be completed by Andriana "Andi" Goud. The mural is intended to depict a crafty octopus walking her way onto the Pier. The artistic rendering is stated to represent the San Clemente Pier in that the octopus is native to this area, and the door is meant to be seamless with the building.

Consistent with the Public Art Policy, the final mural will include an anti-graffiti coating. Should the mural be approved, it would be entered into the standard maintenance of the public art procedure and would have a lifespan of approximately 10 years.

Although the City does not have adopted design guidelines when it comes to public art, City art projects typically reflect the character of San Clemente, enhance the Spanish Village by the Sea character, and are consistent with the design of the surrounding community. This design is consistent with these measures.

The artwork will be installed and completed in conjunction with the approved Capital Improvement Project to update and renovate the Pier restroom. Alongside the public art enhancement, PierPride is also donating funds for additional improvement to the restroom, including a drinking fountain/bottle filling station and sky lights within the restrooms.
