#### **CLOSED SESSION**

**BUSINESS MEETING CONVENED**

The City Council Business Meeting of February 4, 2020 convened at 6:07 p.m., with all members present.

**INVOCATION**

Robin Margraf, M.A., M.S., Our Lady of Fatima Church, gave the invocation.

**PLEDGE OF ALLEGIANCE**

Councilmember Hamm led the Pledge of Allegiance.

**1. SPECIAL PRESENTATIONS**

**A. Implementation of California Voter's Choice Act**

Justin Berardino, Operations Manager with the Orange County Registrar of Voters, narrated a PowerPoint presentation entitled "Registrar of Voters - Vote Center Presentation". A hard copy of Mr. Berardino's presentation is on file with the City Clerk, and a link to the presentation was placed on the City's website per Council direction.

**B. Toll Road Update**

Ryan Bourque, San Clemente, reported that public comments for the South County Traffic Relief Effort (SCTRE) are due by February 7, 2020 at 5:00 p.m.; urged residents to support the "no-build" alternative.

Michelle Schumacher, San Clemente, voiced concern with regard to the SCTRE process; opined that the TCA continues to violate the Brown Act; stated that a petition is being circulated to urge Council to place a measure on the November ballot to ask voters if they support a \$40 annual household assessment to fund environmental attorneys to fight the toll road.

City Attorney Smith announced that the City's letter to the TCA outlining its concerns about the South County Traffic Relief Effort will be posted on February 5, 2020 and placed on the City's website.

C. **Update on Homeless Issue**

City Attorney Smith reported that the City of Santa Ana filed an action against the City alleging that San Clemente was "dumping" homeless individuals in Santa Ana; noted that the City's Special Counsel filed a protest and the lawsuit has since been dismissed.

2. **ORAL COMMUNICATIONS (PART 1)**

**City Council Compensation/Request for Proposals (RFP) for City Attorney Services**

Ryan Bourque, San Clemente, requested that the issue of City Council compensation be placed on a future agenda for the purpose of considering increasing the monthly pay to \$500 per month and authorizing \$500-\$1,000 per month for expense reimbursement; requested that an RFP to evaluate City Attorney contract services be placed on an upcoming Council agenda.

**San Diego Gas & Electric (SDG&E) South Orange County Reliability Enhancement (SOCRE) Project**

Duane Cave, External Relations Manager for SDG&E, provided an update on the SOCRE infrastructure project, which is being implemented to bring electric reliability to San Clemente and the region.

**Mendocino at Talega – Jamboree Housing**

Amanda Hodgin, Resident Services Coordinator for Mendocino at Talega, reported that Mendocino is an apartment complex which was developed by Jamboree Housing to serve low-income residents; expressed her desire to partner with the City to create more programs for the residents of Mendocino.

**Offer of Expertise to Help City Review Proposals for the Former San Clemente Hospital Property**

Pat Patton, San Clemente, reported that he is the Chief Nursing Officer at UCI Health; opined that San Clemente needs an emergency room and offered his expertise to help the City review proposals for the former San Clemente Hospital property.

**Stabbing at Short-Term Lodging Unit (STLU) at 126 West Avenida Cordoba**

Stan Helm, San Clemente, stated he owns the property next door to 126 West Avenida Cordoba and rents it to a family; described his rental family's experience in the aftermath of the stabbing at 126 West Avenida Cordoba; requested that the City revoke the subject STLU permit and examine the propriety of the response by the Orange County Sheriff's Department.

**Beach Access for Service Dogs**

Peter Cassimatis, San Clemente, stated that he is disabled due to a stroke; read a letter voicing concerns that Animal Services would not allow his service dog to accompany him on the beach. A hard copy of Mr. Cassimatis' letter is on file with the City Clerk.

3. MOTION BY COUNCILMEMBER WARD, SECOND BY MAYOR BANE, CARRIED 5-0, to waive reading in full of all Resolutions and Ordinances.

City Attorney Smith stated that no reportable actions were taken during this evening's Closed Session; reported that Council did not discuss Closed Session Item D, relating to Property Negotiations, due to time constraints; advised that a letter was recently received from Michael DiGiangi, of Property Nine Development, concerning Closed Session Item D, which will be provided to Council. A copy of Mr. DiGiangi's correspondence is on file with the City Clerk.

MOTION BY MAYOR BANE, SECOND BY COUNCILMEMBER WARD, CARRIED 5-0, to approve, and authorize the Mayor to execute, a Partnership Agreement by and between the City of San Clemente and the Friends of San Clemente Beaches, Parks and Recreation Foundation. (Contract C14-18)

MOTION BY MAYOR PRO TEM FERGUSON, SECOND BY COUNCILMEMBER JAMES, CARRIED 5-0, to approve the Adjourned Regular City Council meeting minutes of January 21, 2020 with the modification that the last paragraph on Page 21 be modified to read in its entirety as follows:

**“Gas-Powered Leaf Blowers**

“Mayor Pro Tem Ferguson, with the support of Councilmember James, directed that the issue of regulating gas-powered leaf blowers be agendized for the next meeting or meeting after that.”

D. **Contract Amendment – Electronic Document Indexing Services**

Council noted that it is being asked to approve the ninth amendment to the contract for electronic document indexing services; directed Staff to issue a Request for Proposals for a new electronic document indexing services contract to go into effect after the ninth amendment to the current contract expires on June 30, 2021.

MOTION BY MAYOR BANE, SECOND BY MAYOR PRO TEM FERGUSON, CARRIED 5-0, to approve, and authorize the Mayor to execute, Amendment No. 9 to Contract C14-56, by and between the City of San Clemente and Maris Imaging Solutions. This Amendment increases the maximum compensation from \$100,000 to \$120,000 (an increase of \$20,000) and extends the term of the contract until June 30, 2021.

G. **Request for Fee Waiver – Hawaiian Surf Club of San Onofre**

Paul Strauch, Hawaiian Surf Club of San Onofre, provided an overview of the Polynesian Festival and Luau which takes place annually at the Community Center; urged Council to waive rental fees for use of the Community Center grounds.

MOTION BY COUNCILMEMBER HAMM, SECOND BY COUNCILMEMBER WARD, CARRIED 5-0, to approve a one-time fee waiver of rental fees, not to exceed \$643, associated with the 2020 Polynesian Festival and Luau hosted by the Hawaiian Surf Club of San Onofre and to offer a 5-year partnership agreement to the Hawaiian Surf Club of San Onofre to commence next year.



## 7. PUBLIC HEARINGS

### A. Small Cell Ordinance (Zoning Amendment 19-189)

Public Hearing to consider a City-initiated proposal to amend portions of Chapters 17.88 (Definitions), 17.28 (Special Uses), 17.16 (Applications), and 17.12 (Development Review Process) of the Zoning Ordinance to update permitting requirements for small wireless telecommunications facilities.

Katie Crockett, Associate Planner, narrated a PowerPoint presentation entitled “Small Cell Ordinance” and responded to Council inquiries. A hard copy of Ms. Crockett’s presentation is on file with the City Clerk.

Mayor Bane opened the Public Hearing.

Bill Kreutinger, San Clemente, narrated a PowerPoint entitled “Some things to keep in mind on Public Hearing Item 7-A”, which asserted that various claims alleging harmful effects associated with 5G are inaccurate. A hard copy of Mr. Kreutinger’s presentation is on file with the City Clerk.

Tony Hays, San Clemente, spoke on the benefits of 5G technology in comparison to 4G technology; opined that 5G technology will benefit autonomous vehicles and traffic signals, and will negate the need to widen the I-5 or extend SR 241 because 5G will facilitate capacity on existing roads.

Ed Von Bartheld, San Clemente, voiced concern that small cell towers jeopardize health and safety.

Ann-Marie Hines, San Clemente, opined that 5G emissions cause cancer and asserted that children are the most vulnerable; urged Council to oppose 5G technology.

Kristin Fuller, San Clemente, spoke in opposition to the placement of small cell facilities near residences due to her belief that they negatively impact health, aesthetics and property values; urged Council to oppose the proposed ordinance. A hard copy of Ms. Fuller’s letter is on file with the City Clerk.

Jeff Perkin, San Clemente, narrated a PowerPoint presentation entitled “Zoning Amendment 19-189”, which asserted that radiofrequency exposure over extended periods increases the likelihood that health problems will result. A hard copy of Mr. Perkin’s presentation is on file with the City Clerk.

Vanessa Barr, San Clemente, continued Mr. Perkin's PowerPoint presentation, asserting that affixing private technology to public structures essentially makes the City the landlord and legally vulnerable to health and safety claims; urged Council to require that small cell towers be located at least 500' away from homes.

Kristy Neuhausen, San Clemente, urged Council to require that cell towers be located more than 100' from residences due to her concerns about health and aesthetics; urged Council to hire an independent radiofrequency engineer. Hard copies of Ms. Neuhausen's photographs are on file with the City Clerk.

Kortney Morrow, San Clemente, narrated a PowerPoint presentation entitled "Zoning Amendment 19-189", which recommended that the distance between residential properties and small cell facilities should be at least 500' and that the required separation distance between small cells should be farther than currently proposed. A hard copy of Ms. Morrow's presentation is on file with the City Clerk.

Laura Fischer, San Clemente, continued Ms. Morrow's PowerPoint presentation, focusing on National Environmental Policy Act (NEPA) regulations; urged that the City require applicants for small cell facilities to document that any exemption from NEPA is justified; urged that appeals of City actions relating to small cell facilities be considered by Council at a public hearing.

Michael Farraher, Verizon Wireless, cited statistics concerning the average number of wireless devices in a household, noting that many homes no longer have landlines; stated that cell towers represent critical wireless infrastructure, adding that service will be impaired absent the buttressing of the existing network.

Melanie Priest spoke concerning the negative health effects of 5G technology; suggested that wireless facilities will become smaller, better, and less unsightly; urged Council to postpone a decision on the cell tower issue.

Gail Trask stated that she is a nurse practitioner; provided data on the health effects of radiation; urged Council to oppose wireless telecommunication facilities.

Matthew Huefner, San Clemente, urged Council to oppose small cell towers, adding that carriers will find alternative ways to provide service.

Anna and Jane Fischer, San Clemente, stated they live 30' away from the proposed cell tower on Camino Vera Cruz; urged Council to oppose cell towers.

Dijana Jones, San Clemente, voiced concerns associated with the health and safety effects of cell towers.

Reed Poole, San Clemente, opined that cell towers should not be located within 500' of residences or schools.

There being no others desiring to speak, Mayor Bane closed the Public Hearing.

Following discussion, MOTION BY MAYOR PRO TEM FERGUSON, SECOND BY MAYOR BANE, CARRIED 3-2 (COUNCILMEMBERS HAMM AND JAMES VOTING NOE), to take action as follows:

1. Find the Amendment is not a project pursuant to CEQA (CEQA Guidelines Section 15378), or alternatively that it is exempt under the common sense exemption (CEQA Guidelines Section 15061(b)(3).
2. Introduce Ordinance No. 1690 entitled AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING PORTIONS OF CHAPTERS 17.88 (DEFINITIONS), 17.28 (SPECIAL USES), 17.16 (APPLICATIONS), AND 17.12 (DEVELOPMENT REVIEW PROCESS) OF THE ZONING ORDINANCE TO UPDATE PERMITTING REQUIREMENTS FOR SMALL CELL FACILITIES, *with the modification that Section G.1.b.ii be modified to read in its entirety as follows:*

“That the exception deviates from this Section and/or the Design and Development Standards to the least extent necessary to prevent a violation of federal or state law or both.”
3. Adopt Resolution No. 20-07 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, ADOPTING DESIGN AND DEVELOPMENT STANDARDS FOR SMALL CELL FACILITIES, *with an amendment to Exhibit A (Design and Development Standards) to provide that small cell facilities shall not be located within 500 feet of residential or mixed-use property, as measured from the property line.*

Council recessed at 8:20 p.m. and reconvened at 8:32 p.m., with all members present.

9. **NEW BUSINESS**

A. **Consideration of Approach for New Orange County Sheriff's Department (OCSD) Substation**

Report from the Public Works Director/City Engineer concerning a possible new OCSD substation.

Public Works Director/City Engineer Bonigut reviewed the contents of the Administrative Report and responded to Council inquiries.

Rick Loeffler, San Clemente, spoke in support of establishing an OCSD substation on the second floor of 910 Calle Negocio to attract quality deputies to the City; urged Council to fast track the project.

Bill Hart, San Clemente, spoke in support of locating an OCSD substation on the second floor of the 910 Calle Negocio building to help bolster positive relations between OCSD deputies and the community; spoke in support of a quality substation.

Following discussion, MOTION BY COUNCILMEMBER JAMES, SECOND BY MAYOR BANE, CARRIED 3-2 (COUNCILMEMBERS HAMM AND WARD VOTING NOE), to direct Staff to pursue an Orange County Sheriff's Department (OCSD) substation at 910 Calle Negocio (City Hall Building) and to further direct that the Interim City Manager and Assistant City Manager meet with OCSD representatives concerning site circulation and access issues to ensure that the Negocio site will serve as a feasible substation location.

10. **ORAL COMMUNICATIONS (PART 2)**

**Homeless Shelter**

Rick Loeffler, San Clemente, spoke in support of establishing a homeless shelter in San Clemente to enable the Orange County Sheriff's Department to enforce the City's 'No Camping' ordinance; opined that a portable shelter with temporary restrooms would suffice for purposes of enabling the OCSD to enforce the City's 'No Camping' laws.

Michelle Brooks, San Clemente, stressed the importance of providing an OCSD substation as soon as possible to demonstrate community support for law enforcement personnel; stated she would support a small homeless shelter in San Clemente if surrounding cities also provide shelters.

**11. REPORTS****A. Commissions and Committees**

**B. City Manager****Expression of Gratitude for Interim City Manager Appointment**

Interim City Manager Dunek thanked Council for the opportunity to serve as Interim City Manager until a new City Manager is appointed.

**Community Meeting Concerning Incident at 126 West Avenida Cordoba**

Interim City Manager Dunek reported that the City is hosting a community meeting on February 5, 2020 at the Community Center to address the stabbing that occurred at the vacation rental at 126 West Avenida Cordoba.

**C. City Attorney****Draft Ordinance Concerning Law/Code Enforcement at Short-Term Rental Properties**

City Attorney Smith reported that he is preparing a draft ordinance to provide tools to help the Orange County Sheriff's Department and City Code Enforcement intervene in situations such as the one that occurred at the short-term rental at 126 West Avenida Cordoba.

**City Policy Re Campaign Activities**

City Attorney Smith reported that he is drafting a policy for Council consideration on February 18, 2020 which addresses use of City facilities and resources in connection with campaign activities.

**City Attorney Budget Review**

City Attorney Smith reported that Council will review the City Attorney Budget at the Council meeting of February 18, 2020 at 4:30 p.m.; noted that the confidential work product segments of the presentation will be discussed in Closed Session.

D. **Council Members**

**Orange County Library Task Force**

Mayor Pro Tem Ferguson requested, and Mayor Bane supported, agendaing for the City Council meeting of February 18, 2020, the appointment of a new Council representative to the Orange County Library Task Force.

**Charter City**

Mayor Pro Tem Ferguson offered to prepare a tray memo for Council concerning possible transition of San Clemente to a Charter City.

**Public Safety Committee**

Mayor Bane reported that the City is accepting applications from persons interested in serving on the Public Safety Committee; stated that applications are due to the City Clerk by February 24, 2020.

**Toll Road Issue**

Mayor Bane reported that he recently met with State Legislators concerning the Toll Road issue and conveyed his belief that progress is being made.

**Homeless Issue**

Mayor Bane reported that he met with his colleagues in the City of Dana Point and San Juan Capistrano concerning the homeless issue; explained that progress has not been made on the issue of a regional shelter, but noted that discussions are on-going.

Mayor Bane stated that he spoke with Paul Webster of Housing and Urban Development (HUD) concerning San Clemente's approach in addressing the homeless issue.

**Regulation of Group Feedings**

Councilmember James requested, and Mayor Pro Tem Ferguson supported, agendaing the possibility of amending the City's special events ordinance to incorporate regulations with regard to group feedings.


MOTION BY COUNCILMEMBER WARD, SECOND BY MAYOR BANE, CARRIED 5-0, to adopt Ordinance No. 1684 entitled AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING CHAPTERS 2.28, 2.32, 2.36, 2.40, 2.42 AND 2.43 OF THE CODE OF THE CITY OF SAN CLEMENTE, RELATING TO THE BEACHES, PARKS AND RECREATION COMMISSION, PLANNING COMMISSION, GOLF COURSE COMMITTEE, HUMAN AFFAIRS COMMITTEE, COASTAL ADVISORY COMMITTEE AND INVESTMENT ADVISORY COMMITTEE, RESPECTIVELY.
