# D. Fee Waiver Request and Request to Use San Clemente Beach Trail for Special Event Hosted by American Cancer Society

for the American Cancer Society Relay for Life event and responded to Commission inquiries.

<u>Katie Robinson</u>, American Cancer Society representative, responded to Commission inquiries regarding the American Cancer Society Relay for Life event; established the Beach Trail users would be non-competitive supporters of the event who may need a more accessible path; and established volunteers and first-aid and water stations will be set up along the route.

Commissioners either individually or in agreement provided the following comments:

- The race should be held during a low tide.
- The Beach Trail can handle a limited number of non-competitive walkers.
- Saturday morning is prime time for public Beach Trail use, and will have the greatest impact.
- Closing a portion of the Beach rail for an athletic event would not be a problem.
- Having event participants and public on the Trail at the same time is difficult to organize.
- The public should be notified of the event.

MOTION BY COMMISSIONER DOREY, SECOND BY COMMISSIONER AYER, AND CARRIED 4-0, to recommend the Gity Council 1) Approve a fee waiver for fees associated with the American Cancer Society Relay for Life event to be held on the beach in an amount not to exceed \$460; and 2) Recommend the use of the Beach Trail for a one-time special event hosted by the American Cancer Society.
