# CITY FACILITY PUBLIC CLOSURE EFFECTIVE MONDAY, MARCH 16

San Clemente, Calif., March 16, 2020 – To retain the ability to provide essential services to the community, the City of San Clemente out of an abundance of caution is taking steps to reduce the potential exposure of Novel Coronavirus (COVID-19) to employees and the public. Effective Monday, March 16, City Hall, the Utilities Building, the Community Center, San Clemente Aquatics Center, San Clemente Municipal Golf Course, and Ole Hanson Beach Club will be closed to the public for seven days. This decision will be re-evaluated in a week to determine if an extension is warranted. City staff are available Monday through Friday from 7:30 am to 5:30 pm by phone and email (closed alternating Fridays). Also visit www.san-clemente.org for updates.

All City employees will report to work as usual and conduct City business by phone and e-mail. The only change will be that the public will not have in-person access to employees at City Hall. All field operations including police, fire, waste disposal, street maintenance, parks maintenance, etc. will continue uninterrupted. Department contact information is available on the City's website. Should you need assistance locating contact information, please call the City Hall reception desk at (949) 361-8200 and you will be directed accordingly.

We understand that some of these measures will be an inconvenience and we thank the community for its understanding as we work through this evolving situation.
