Councilmember Ferguson led the Pledge of Allegiance.

A. Toll Road Update

Assistant City Manager Sund reported that the Transportation Corridor Agency (TCA) formally concluded its scoping process for the toll road and will proceed with the Los Patrones extension with the County as the lead agency. Mr. Sund further noted that the City's press release, together with other information relating to the toll road, can be found on the City's website.

City Attorney Smith noted that Council took no reportable actions during tonight's Closed Session; explained that at the March 2, 2020 City Council meeting, Council authorized the City Attorney to renew an offer to purchase a 10-acre site at Pico Canyon originally owned by the Rancho San Clemente Business Park Association and subsequently transferred to the Emergency Shelter Coalition.

In response to Council concern about potential due process challenges by the public should the Public Hearing go forward this evening, Senior Planner Roxas pointed out that the first recommended Condition of Approval contains an indemnity clause.

Mayor Pro Tem Ferguson took a straw vote to determine if Council is in favor of deferring the Public Hearing to a future Council meeting. Councilmember Hamm and Ferguson voted to defer the Public Hearing to April 7, 2020. Mayor Bane and Councilmembers James and Ward voted to hear this item at this time.

Mayor Pro Tem Ferguson opened the Public Hearing.

<u>Mark McGuire</u>, attorney representing the applicant, stated that no public comments were received at the Planning Commission hearing on the subject project; asserted that the project is time-critical and voiced concern with delaying the Public Hearing.

<u>Keith Palmer</u>, Project Architect, thanked Council for moving forward with the Public Hearing this evening.

Senior Planner Roxas reviewed the contents of the Administrative Report.

Mayor Bane reported that the City received the COVID-19 order from the County of Orange, and will work with the County to work through questions; stated that he has been in contact with Congressman Levin's office concerning Federal funding that could be made available to the City; stated that San Clemente's declaration of a public emergency allows it to be among the first in line for COVID-19 expenditure reimbursements from State and Federal funds; reported that the City is reaching out to County Health, which is the lead on the possibility of reopening the San Clemente Hospital; commended Staff for its efforts during this crisis.

Councilmember James spoke to the importance of the community working together during this difficult time; thanked City Staff for its efforts.

Mayor Pro Tem Ferguson thanked residents for their patience and support for one another during this difficult time; noted that those members of the community that wish to volunteer to help the elderly should call (949) 361-8200.
