k. Transferability L. Use M. Utilities N. Suspension and Revocation	A home occupation granted in accordance with the provisions of Zoning Ordinance shall not be transferred, assigned or used by a person other than the permittee, nor transferred to any location other than the one (1) for which the permit was granted. If you move to another location in San Clemente and wish to maintain your permit, you will be required to complete another application and pay the appropriate fee. If you have an additional home occupation business within the same structure of premises, this will require a separate application and fee. The home occupation shall be an incidental and accessory use and shall not change the principal character of the dwelling. The home occupation shall not involve more than twenty (20) percent of habitable dwelling floor area. The home occupation shall not involve the connection of utilities or use of community facilities other than customary for residential purposes. Suspension and Revocation: Failure to comply with any application provision of the Zoning Ordinance of the City of San Clemente, or conducting a home occupation business in such a way that it becomes a public nuisance, shall result in immediate suspension of the permit, a misdemeanor fine of \$100, and/or revocation of the permit.
