TERM EXPIRATIONS ON CITY COMMISSIONS AND COMMITTEES AS WELL AS THE TALEGA

REPRESENTATIVE TO THE FRIENDS OF THE RESERVE COMMISSION

Fiscal Impact: None.

**Summary:** On February 4, 2020, the City Council adopted Ordinance No. 1684, which makes operational changes to the City's Commissions and Committees. These changes are slated to take effect on July 1, 2020. Among the changes that Ordinance No. 1684 enacts is a reduction in the number of members who serve on the City's Commissions and Committees, with the exception of the Planning Commission, which will remain a 7-member body.

Council previously extended the terms of all City Commission and Committee members that were due to expire on June 30, 2019 to June 30, 2020 to coincide with the effective date of Ordinance No. 1684. The terms of all Commission and Committee members that were due to expire on June 30, 2020 were not changed. Consequently, the terms of all members of the City's Commissions and Committees are now scheduled to expire on June 30, 2020.

Municipal Code Section 2.40.030 requires that the City Clerk report to Council at least 60 days prior to the expiration of terms of City appointees. The purpose of this provision is to enable Council to authorize the City Clerk to advertise the vacancies and to schedule a date(s) for Council to interview applicants and make appointments. Accordingly, this item is agendized for Council consideration at this time.

Because of challenges associated with recruiting applicants and conducting interviews during the current coronavirus pandemic, Council may wish to extend the terms of the existing Commission and Committee members for approximately seven months (until January 31, 2021) or for twelve months (until June 30, 2021). If Council wishes to continue the terms of all current incumbents, it is necessary for Council to adopt an Ordinance to defer the effective date of Ordinance No. 1684. A draft ordinance is attached for Council's consideration. By delaying the effective date of Ordinance No. 1684, the reduced membership of the City's Commissions and Committees will not take effect on July 1, 2020, and Council will not need to choose the Commission/Committee members who will continue to serve after July 1, 2020.

In addition to the upcoming term expirations for the City's Commissions and Committees, the term of the Talega Representative to the Friends of the Reserve Commission, currently filled by Laurie Gooch, is also scheduled to expire on June 30, 2020. Because the Friends of the Reserve Commission is not a City body, the City's representative to the Friends' organization was not affected by Ordinance No. 1684. Council can, therefore, vote to offer an extended term to the existing incumbent at this time if Jesired.

A copy of the Maddy Act Local Appointments List, which was posted pursuant to State law, is attached. (This list identifies the current incumbents of City Commissions, Committees and outside boards whose terms are due to expire this year.

## Recommended Action:

STAFF RECOMMENDS THAT the City Council:

- 1) Introduce Ordinance No. entitled AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, DELAYING THE ENACTMENT OF ORDINANCE NO. 1684, WHICH AMENDS CHAPTERS 2.28, 2.32, 2.36, 2.40, 2.42 AND 2.43 OF THE CODE OF THE CITY OF SAN CLEMENTE, RELATING TO THE BEACHES, PARKS AND RECREATION COMMISSION, PLANNING COMMISSION, GOLF COURSE COMMITTEE, HUMAN AFFAIRS COMMITTEE, COASTAL ADVISORY COMMITTEE AND INVESTMENT ADVISORY COMMITTEE RESPECTFULLY, with the insertion of the date on which the Ordinance is to become operational.
- 2) Determine whether to offer an extended term to the current Talega Representative to the Friends of the Reserve Commission for a new term to expire on January 31, 2021, June 30, 2021, or other date as desired.

#### ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, DELAYING THE ENACTMENT OF ORDINANCE NO. 1684, WHICH AMENDS CHAPTERS 2.28, 2.32, 2.36, 2.40, 2.42 AND 2.43 OF THE CODE OF THE CITY OF SAN CLEMENTE, RELATING TO THE BEACHES, PARKS AND RECREATION COMMISSION, **PLANNING** COMMISSION. GOLF COURSE COMMITTEE. HUMAN **AFFAIRS** COMMITTEE. COASTAL ADVISORY COMMITTEE AND INVESTMENT ADVISORY COMMITTEE

WHEREAS, at its meeting of February 4, 2020, the San Clemente City Council adopted Ordinance No. 1684, to modify the structure and composition of the City's Commissions and Committees, effective July 1, 2020; and

WHEREAS, among the changes that Ordinance No. 1684 enacts is a reduction in membership of all Commissions and Committees, with the exception of the Planning Commission; and

WHEREAS, the terms of the current incumbents of all City Commissions and Committees affected by Ordinance No. 1684 are scheduled to expire on June 30, 2020; and

WHEREAS, a global coronavirus pandemic is currently active, which could negatively affect the City's ability to recruit, interview and appoint individuals to fill the terms that are scheduled to terminate on June 30, 2020; and

WHEREAS, the City Council desires to extend the terms of all existing Commission and Commission incumbents until the pandemic subsides and an effective recruitment and selection process can be undertaken to fill the expiring terms; and

WHEREAS, the City Council cannot extend the terms of all Commission and Committee incumbents without first delaying the enactment of Ordinance No. 1684, which provides that the membership of certain City bodies will reduce on July 1, 2020.

**NOW, THEREFORE**, the City Council of the City of San Clemente, California, hereby ordains as follows:

Section 1: The revisions to Code Chapters 2.28, 2.32, 2.36, 2.40, 2.42 and 2.43 as set forth in Ordinance No. 1684, initially slated to take effect on July 1, 2020, shall now take effect on (insert date).

<u>Section 2.</u> The City Clerk shall certify to the adoption of this ordinance and cause it, or a summary thereof, to be published once within fifteen (15) days of adoption in a newspaper of general circulation printed and published within the City of San Clemente, and shall post a certified copy of this ordinance, including the vote for and against the same, in the Office of the City Clerk in accordance with California Government Code Section 36933.
