CITY COUNCIL ACCEPTANCE AND NOTICE OF COMPLETION FOR THE AQUATICS CENTER

DRY STORAGE ROOF, PROJECT No. 19514.

Fiscal Impact: Yes. The final project cost of \$106,582 is within the approved budget of \$135,981.

Summary:

The Stone Collector has successfully completed the construction contract within the

approved budget, and staff recommends City Council acceptance.

Discussion:

A roof needed to be installed as a measure to keep the storage area protected from wet weather at the Aquatics Center. The uncovered storage area is used for storing materials and supplies essential to operating the Aquatics Center facility. The project was awarded by the City Council on December 17, 2019 (See Attachment 1).

The City needs to formally accept the project as complete and record a Notice of Completion with the County (See Attachment 2).

AWARD CONSTRUCTION CONTRACT TO THE STONE COLLECTOR, FOR THE AQUATICS

CENTER DRY STORAGE ROOF, PROJECT No. 19514.

Fiscal Impact: Yes. There is \$135,981 budgeted for the proposed \$96,681 expenditure.

Background:

A roof is needed to be installed as a measure to keep the storage area protected from wet weather at the Aquatics Center. The currently uncovered storage area is adjacent to the Aquatics Center pool pump room building and is used for storing materials and supplies essential to operating the Aquatics Center facility.

The project specifications were advertised for public bidding and four bids were received on November 21, 2019 at 2:00 p.m. The results from the bid opening are presented in the attached Bidder's Listing. The low bidder, The Stone Collector. submitted a bid in the amount of \$96,681.

Based on the low bid, project costs are estimated as follows:




