Also, they must indicate if they are to be read during the general "oral communications" portion of the meeting. <u>Emails lacking that indication will be forwarded to the Human Affairs Committee</u>'s general email accounts. <u>Depending on the number of comments submitted on a particular item and the total amount of time allocated for the Human Affairs Committee meeting</u>, the Human Affairs Committee may, at the beginning of its deliberation of an item, limit equally the time allocated for each comment.
