Motion Waiving Reading in Full of All Resolutions and Ordinances

MOTION BY COUNCILMEMBER HAMM, SECOND BY COUNCILMEMBER JAMES, CARRIED 4-0, to waive reading in full of all Resolutions and Ordinances.

Extension of a Declaration of Local Emergency and Imposition of Curfew

City Attorney Smith reported that Resolution No. 20-55, which Council adopted yesterday to declare a local emergency and impose a curfew, expires on its own terms today; noted that Council could extend the local emergency and curfew by adopting a resolution of extension at this time; stated that in discussions with City management and the Orange County Sheriffs Department earlier today, it appears that none of the concerns that gave rise to the original declaration of emergency and imposition of curfew have materialized.

MOTION BY COUNCILMEMBER WARD, SECOND BY COUNCILMEMBER JAMES, to not impose any further emergency measures, including a curfew, at this point in time. Further, that Councilmember Hamm be designated as the sole Councilmember authorized to impose an additional curfew if deemed necessary after being contacted by appropriate authorities, with the following stipulations: 1) An Emergency Meeting will be called after Councilmember Hamm makes his decision to enable Council as a body to review the determination; and 2) Councilmember Hamm's decision shall remain in effect until such time as a Council majority meets to consider the curfew direction.

SUBSTITUTE MOTION BY MAYOR PRO TEM FERGUSON to take action as specified in the above motion, with the modification that she be designated as the Councilmember authorized to impose a curfew, if needed, **The Substitute Motion died for lack of a second.**
