**Subject:** **PARKING PROHIBITION ON EL CAMINO REAL.**

**Fiscal Impact:** None.

**Summary:** Staff recommends that the City Council approve a parking prohibition on the west side of El Camino Real, from Esplanade to Avenida Santiago (See Attachment 1).

**Discussion:** At its September 15, 2020 meeting, the City Council directed staff to implement left turn pockets on El Camino Real at the intersection of El Camino Real/Esplanade, as shown on Attachment 1. In order to install the left turn pockets, a parking prohibition is required on the west side of El Camino Real, from Esplanade to Avenida Santiago, as shown in Attachment 1 and as presented the September 15 meeting. The Resolution to formally enable the proposed parking prohibition is provided as Attachment 2.

**Recommended Action:** STAFF RECOMMENDS THAT the City Council:

1. Prohibit parking on the west side of El Camino Real, from Esplanade to Avenida Santiago; and
2. Adopt Resolution No. \_\_\_\_\_, entitled, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING MASTER TRAFFIC RESOLUTNION NO. 1846, ESTABLISHING 'NO PARKING AREAS' ON EL CAMINO REAL."

23.e-115 El Camino Real, west side, from Esplanade to Avenida Santiago.

Section 3. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
