Interim City Manager Sund reported that the proposed curfew would extend from 9:00 p.m. this evening until 6:00 a.m. tomorrow; explained the areas of the City that would be subject to the curfew.

MOTION BY COUNCILMEMBER WARD, SECOND BY COUNCILMEMBER JAMES, CARRIED 3-1 (MAYOR PRO TEM FERGUSON VOTING NOE), to adopt Resolution No. 20-55 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, DECLARING A LOCAL EMERGENCY AND IMPOSING A CURFEW, with the understanding that Section 6 of the Resolution shall read in its entirety as follows:


"Section 6. Duration of Curfew

"This curfew shall remain in effect until such time as the City Council at a noticed special meeting on Friday, September 25, 2020 can determine whether the conditions giving rise to this declaration still exist and whether its continuation is still warranted."


