AUTHORIZE THE EXECUTION OF QUITCLAIM DEEDS RELATED TO THE AVENIDA VISTA

HERMOSA INTERCHANGE.

Fiscal Impact: None.

Summary:

This request is for City Council approval to execute several Quitclaim Deeds related

to the Avenida Vista Hermosa interchange as described below.

Discussion:

As noted to the City Council in November 2013 staff, with assistance from RBF Consulting, is preparing updated easements, joint use agreements and right-of-way documentation required by Caltrans to close out the I-5/Avenida Vista Hermosa interchange project. As part of this effort, Quitclaim Deeds must be executed to remove several existing City easements from portions of parcels that will be within the final Caltrans right-of-way limits. These easements are for utilities that were relocated as part of the interchange construction and are no longer needed by the City, and the Quitclaim Deeds will help provide clear title to Caltrans prior to transfer of the remaining right-of-way. There are six (6) such easements, the legal descriptions for which are attached. Staff and the City Attorney have reviewed these legal descriptions and Quitclaim Deeds, and recommend City Council approval.

#### Recommended

Action:

STAFF RECOMMENDS THAT the City Council:

- 1. Approve and authorize the Mayor to execute six (6) Quitclaim Deeds related to the Avenida Vista Hermosa interchange; and
- 2. Authorize the City Clerk to record the Quitclaim Deeds and related documents with the County of Orange Clerk-Recorder.






