- Lack of respect for the City Manager form of government.
- Lack of respect for any City Manager during her term of office as a Councilmember.
- Lack of effective working relationships as defined in Best Practices for a City Manager Form of Government.
- Lack of respect for the City Attorney and legal counsel provided to her.
- Accusation of misconduct and insubordination against City employees when they would not do what she wanted that was in opposition to Council direction and in violation of policies for process in the San Clemente Municipal Code.
- Unprofessional conduct, attacks, disparagement of the City Manager, City Attorney and Human Resources Manager at the dais, in emails, social media and to the press that undermine the public trust in governance in the City of San Clemente.
- Unilateral actions by the Mayor Pro Tem that are beyond the authority of a Council member or beyond Council direction concerning personnel matters, recruitment, or rights of public employees.
- Violations of the Brown Act, disclosing confidential information and disclosure of documents including serial meeting conversations.
- Unilaterally ordering Staff to agendize issues without Council support in violation of policies for process in the San Clemente Municipal Code.
- Lack of cooperation and unilateral actions outside the authority of a Council member in affairs dealing with the City's insurance carrier, the California Joint Powers Insurance Authority, and their administration of claims.

- Accusations against Council members that involve Closed Session meetings, taking advantage that other Councilmembers would not break confidentiality to respond to her allegations. The most recent was when Councilmember James was running for re-election and could not respond to her allegations that he yelled at her at the top of his lungs.
- Accusing Council of Brown Act violations or being rough on her in Closed Session and yelling at her.
- Unilaterally sharing confidential information or documents after briefings where she had been advised the information is confidential, thereby waiving privilege for Council when she had no authority to do so.

- Publicly giving the City Manager 24 hours to respond to an allegation from her.

- Incorrectly casting blame on City Managers when, in fact, they are following the direction and policies of the City Council.
