Commissioners either individually or in agreement provided the following comments:

- Clear and visible rules signage would be a good solution at many public spaces.
- Turf damage from vehicles would be considered vandalism.
- E-bikes could be defined as motorized vehicles in the municipal code.
- For parks, bicycles should be prohibited from turf without further restrictions.
- Outdoor family activities should not be greatly restricted during the COVID-19 pandemic.
- Damage to turf may be unintended.
- Children do not damage turf on bicycles, but can on e-bikes.
- Wet turf can be damaged by bicycles.
- Section 10.68.060 related to motorized vehicles could also reference parks.
- The stairs on the Sea Summit Trail make it unpopular for bicycles.
- There have not been incidents on the Beach Trail reported to public safety entities.
- There should not be a ban if there is not a problem with incidents.
- Licensing, an educational program, and/or a public service announcement should be considered.
- Certain areas have been already identified as problem areas for special consideration, and the area between Dije and the pier, and the Mariposa Bridge should also be included as areas with special consideration.

- The speed limit needs to be addressed and lowered.
- The bridges are not suitable for riding.
- More areas bicycles need to be walked will cause slower speeds in between.
- 5mph is a comfortable jogging speed.
- There are alternative areas for faster transportation through the City.
- E-bikes are a problem, not bicycles.
- The problem is recklessness coming from people already not following rules.
- The increase in engagement in outdoor activities is encouraging.
- E-bikes should not be banned from the Beach Trail.
- There are many respectful cyclists on the Beach Trail.
- There are not realistic options for enforcement on the Beach Trail.
- The Beach Trail is not a transportation corridor, it is for recreation.
- E-bikes do not need to be listed as all bicycles are listed in the municipal code.
- Unicycles could also be included in the list of vehicles.
- Signage should be increased.

MOTION BY COMMISSIONER SMITH, SECOND BY COMMISSIONER WOHLFARTH, AND CARRIED 5-1 WITH COMMISSIONER AYER VOTING NOE, to include in park rules a prohibition of motorized vehicles, e-bikes, and bicycles on turf within parks.

Consensus was reached to take no action related to changes to regulations on inland trails.

MOTION BY CHAIR STREGER, SECOND BY CHAIR PRO TEM BANDARUK, AND CARRIED 5-1 WITH COMMISSIONER WOHLFARTH VOTING NOE, to amend section 12.32.130 in the following ways: 1. Subsection A, include e-bikes on the list of vehicles, 2. Subsection B, add Mariposa Bridge to the list of areas where bicycles are walked, 3. Subsection B, reduce the speed limit from 10mph to 5mph, and 4. Include that bicycles are required to yield to pedestrians.

Chair Pro Tem Bandaruk left the meeting at 7:58pm.

Commissioners requested sign designs for the Beach Trail to be brought to the Commission for review.
