City staff, Stephen Foster, recommended utilizing "NextDoor" application to help facilitate the program, as it has been successful in other jurisdictions.

Committee members discussed the Flock Safety camera system and plans to provide a thorough report and presentation to the Committee at the next meeting for consideration about forwarding a recommendation to City Council.
