Subject: RESIGNATION OF JOSEPH ZIDRON FROM THE COASTAL ADVISORY COMMITTEE

Fiscal Impact: Yes. The Clean Ocean Program budget will save approximately \$55 per month while the Coastal Advisory Committee position is vacant.

Summary: Joseph Zidron resigned from the Coastal Advisory Committee, effective May 14, 2021. A copy of Mr. Zidron's resignation email, dated May 13, 2021, is attached.

Council extended the terms of all Commission and Committee members, with the exception of the Planning Commission members, to August 30, 2021 to accommodate a review and possible Code modifications relating to the various City bodies. Among the changes being considered are body consolidations as well as reductions in the membership composition of the various Commissions and Committees. Because the Coastal Advisory Committee may be affected by this assessment, Staff recommends that Council not fill the vacancy created by Mr. Zidron's resignation pending final Council decisions with regard to the structure and composition of the various City bodies.

Recommended

Action: STAFF RECOMMENDS THAT the City Council take action as follows:

- 1. Accept the resignation of Joseph Zidron from the Coastal Advisory Committee, with regret.
2. Direct that the vacancy created by the resignation of Joseph Zidron not be filled pending Council decisions with regard to possible changes affecting various City Commissions and Committees.
