P3a. Description:

The property sits upon a raised elevation edged by a concrete retaining wall and contains a one-story single family residence with a rectangular plan and wood-frame construction. Designed in the Spanish Colonial Revival style, it has a low-pitch side-gable roof with clay tiles and exposed rafter tails. The exterior walls are clad with original smooth stucco. Other features include a chimney, courtyard, and stairwell up the property. The primary (west) facade is three bays wide. The building's main entrance occupies the southernmost bay with an original wood-paneled door. The center and northernmost bays each contain two sets of 3 by 2 casement windows. The fenestration consists of original wood casement windows throughout the residence. The residence is in good condition. Its integrity is good.

It also appears eligible at the local level as a contributor to a potential historic district. It is recommended for retention on the Historic Structures List.
