P3a. Description:

The property contains a two-story multiple family residence with a rectangular plan and wood-frame construction. Designed in the Spanish Colonial Revival style, it has a hip roof with asphalt shingles and clay tile on the edges. The exterior walls are clad with non-original smooth stucco. Spanish Colonial Revival elements of the residence include exposed rafter tails, a stucco chimney, and wing wall entry. The primary facade includes a covered side porch with wood porch supports. The residence includes a courtyard enclosed by a low stucco wall and a low stucco wall along the property line. The fenestration consists of original wood double-hung and casement windows throughout the residence. The residence is in good condition. Its integrity is good.


