DOG ACCESS ON CITY BEACHES AND PARKS

Fiscal Impact: Yes. A temporary dog run installation is estimated to cost \$25,000 in fencing and

surfacing materials. Future potential improvements are unknown at this time.

Summary:

The Beaches, Parks and Recreation Commission recommends upholding the current rules and regulations surrounding dog access on San Clemente beaches and do not recommend any location for on- or off-leash dog access to city beaches; and earmark funding for the current fiscal year for increased or improved off-leash dog amenities as it would relate to our site-specific master plans and/or immediate funding for a

temporary solution while we plan for permanent amenities.

Background:

Dog access on City beaches has been a longstanding conversation and discussion for years amongst Commissioners and Councilmembers. A complete history is storied in Attachment 1.

At its March 16, 2021 meeting, the City Council considered a resolution to allow dogs on a beach area (Attachment 2), and directed staff to bring a staff report to the Beaches, Parks & Recreation Commission for review of allowing dog access on San Clemente public beaches and provide a recommendation for a location.

On March 22, 2021, staff released a public survey seeking feedback and comment regarding dog access to city parks and beaches. While this survey is not considered or intended to be statistically valid, it is intended to provide a platform for discussion for Commission and Council.

At its April 13, 2021 meeting, the Commission reviewed a staff report concerning factors that should be considered in the review of allowing dog access on the beach. The Commission voted (6-0) to make no changes to dog access on the beach and. therefore, did not provide a recommended location due to the infrastructure of San Clemente beaches; and

Discussion:

Based on Council direction at its March 22, 2021 meeting, and the Commission discussion at its April 13, 2021 meeting, staff has provided the following areas for consideration:

Fiscal Impact

Approval of a dog beach would likely result in increased staff costs related to enforcement and monitoring. Some of these staff costs could be offset by administrative citation fines for violation of rules. Minimal costs for added signage and changes to existing signage would be required. Additional installation of pet waste stations would be reviewed and would cost an estimated \$2,500 per station install, and \$500 in ongoing maintenance and supplies.

Environmental Impact

Concerns have been raised by public comment and the Coastal Advisory Committee relating to water quality as dog waste can potentially impact bacteria counts. A report by the Environmental Programs Supervisor detailing the environmental considerations is attached (Attachment 3).

Most recently, the City's Environmental Services staff has been actively monitoring the bacteria levels in certain areas along the San Clemente coastline. The four beach segments that exceed bacteria water quality objectives at the ocean shoreline are, (1) Poche Beach; (2) North Beach; (3) Pier; and (4) T-Street. Note, the origin of the bacterial specimens is not known, and may not be fully attributed to dogs alone.

Public Safety & Enforcement

Prohibited under San Clemente Municipal Code 6.08.020 (a), individuals who currently take their dogs on the beach are subjected to a citation by either Marine Safety Officer or Animal Control Officers. In recent years, Marine Safety has taken the lead role in the enforcement of this code. Lifeguards, in the past two years, have issued ten (10) citations to dog owners for violation of SCMC 6.08.020 (a), and have recorded 260 field investigations (written warnings) to dog owners.

As the primary enforcement body at the beach, the Marine Safety Division's priority is to ensure the safety of swimmers and surfers while in the water. Although dogs are not currently permitted on City beaches, Marine Safety personnel have responded to dog-related activity and incidents, which has resulted in one staff injury from a dog bite. Allowing for dog access on the beach could result in a greater need to respond to these types of calls.

Coastal Commission Review

If dog access to beaches is approved, a Coastal Development Permit (CDP) will be required by the California Coastal Commission. A CDP is also required for a pilot program; this would be issued in the form of a temporary CDP for up to five years. Furthermore, this could trigger requirements for environmental impact surveys.

Public Input/Survey Results Summary

A community survey related to dog access was available from March 23rd through April 7th. The survey is not statistically valid but was intended to provide a localized platform for citizen response. Complete results and comments are included in Attachment 4.

A total of 1,346 submissions were received with 91% of respondents stating they are San Clemente residents and 81% are dog owners. Among responders to the survey, results indicate a desire to allow dog access on the beach with a variety of comments

on operations and regulations of the activity. Responders to the survey have indicated a preferred beach location of North Beach.

Surrounding Agency Comps

In a brief review of surrounding area beach access for dogs, the following details were discovered:

• City of Laguna Beach

- o No designated dog beach
- Dogs are allowed on all city beaches before 9 a.m. and after 6 p.m. between June 15th – September 10th, and during regular beach hours from September 11th – June 14th.
- o Dogs must be on a 6' or shorter leash at all times.
- o Owners must clean up waste.

Capistrano Beach/Hole in the Fence (County of Orange)

- o Dogs are *not* permitted from June 15 to Sept. 10, 9 a.m. and 6 p.m.
- o Dogs must be on a leash at all times
- o Dogs are allowed in the water

City of Huntington Beach

- Huntington Dog Beach designated on-leash dog beach, open daily 6 a.m. to 10 p.m.
- o Dogs must be licensed; owners must pick up waste
- o Dogs are allowed in the water.

San Diego

- o Dog Beach ("Ocean Beach"): 24 hr. off-leash
- Fiesta Island Mission Bay: Dogs are allowed in all areas daily from 6 a.m. to 10 p.m., except for the campground and nesting sites (seasonal).
- o North Beach Dog Run Coronado: 24 hr. off-leash
- o Dogs must be licensed; owners must pick up waste
- o Dogs are allowed in the water.

City of Del Mar

- South Beach: On-leash only (6-foot), year-round
- Main Beach: On-leash (6-foot), Labor Day thru June 15th; Off-leash, allowed from 25th to 29th street from dawn to 8 a.m.; No dogs are allowed June 16th thru Labor Day.
- North Beach: Off-leash dogs all day from the day after Labor Day thru June 15th, and dawn until 8 a.m. June 16th thru Labor Day. Dogs must be leashed from 8 a.m. until dawn June 16th thru Labor Day.
- o Dogs must be licensed; owners must pick up waste
- Dogs are allowed in the water in designated areas.

City of Newport Beach

- O Dogs are not allowed between 10 a.m. and 4:30 p.m.
- o Before 10 a.m. and after 4:30 p.m., dogs are allowed, if they are securely restrained by a substantial leash or chain not exceeding six feet in length and controlled by a person who is competent to restrain the dog.
- o Off-leash dogs are never allowed
- Dogs are NOT allowed on beaches in the following cities:
 - o Oceanside
 - Carlsbad
 - Seal Beach
 - Encinitas (State Beach only)

Park Opportunities for Off-Leash Dog Access

During Commission deliberations, several opportunities were identified for improvements to off-leash dog access in parks.

Existing Dog Park Improvements
 Several improvements could be made to the existing Baron Von Willard Dog
 Park site including surfacing replacement and landscape and/or shade
 additions.

- Temporary Off-Leash Dog Amenity
 Vista Hermosa Sports Park, Meadows or the vacant lot above Courtney's
 SandCastle (former lease area) are park areas for potential opportunities to
 establish a temporary dog run area.
- Permanent Off-Leash Dog Amenity
 Site-specific master plans are currently being updated for the following five
 parks, and opportunities for expanded dog access will be considered in the final
 plan proposal to Council.
 - 1. Bonito Canyon
 - 2. Linda Lane
 - 3. Richard T. Steed
 - 4. San Gorgonio
 - 5. San Luis Rey

THE BEACHES, PARKS & RECREATION COMMISSION RECOMMENDS THAT the City Council

- 1.) Uphold the current rules and regulations surrounding dog access on San Clemente beaches and do not recommend any location for on- or off-leash dog access to city beaches; and

City of San Clemente History of Dog Access in Public Spaces

1989, the then-named Parks and Recreation Commission reviewed the City ordinance that did not allow dogs on any park or beach, and recommended that the existing prohibition on dogs in parks and on the beach remain in place. Council upheld the existing prohibition of dogs in parks.

1994, the Commission reviewed the current subject City ordinance and received extensive public input on both sides of the issue, and recommended that the existing prohibition remain in place. Council upheld the Commission recommendation.

<u>2001</u>, Council requested the Parks and Recreation Commission consider whether dogs should be allowed in City parks. As a result, the Commission created a sub-committee to research and study options.

As a result of the Commission recommendation derived from the sub-committee report, Council conceptually approved the development of a permanent off-leash dog park at Richard T. Steed Memorial Park and changed the City ordinance at that time to allow currently-licensed dogs on-leash in Verde, Mira Costa, and Calafia Beach Parks for a two-year test period with oversight by the Commission and quarterly reports. (Note: Calafia Beach Park was a city-operated and maintained park but is now under the jurisdiction of the State Parks System since the 20-year lease with the State expired and was not renewed by the City.)

<u>2002</u>, Council approved the development of a permanent off-leash dog park at Richard T. Steed Memorial Park and approved changing the current ordinance to allow currently-licensed dogs on-leash in Verde, Mira Costa, and Calafia Beach Parks for a two-year test period.

<u>2003</u>, The Commission considered and agreed, by petition from Talega residents, to request that City Council consider opening Talega Park to dogs on-leash if the two-year test period was a success. (The two-year test period was successful and ended in May 2004.)

<u>2004</u>, City Council adopted a resolution that allowed currently licensed, on-leash dogs in Calafia, Mira Costa and Verde Parks.

<u>2008</u>, the Commission created a Dog Access Sub-Committee to evaluate dog access in parks and beaches. The Subcommittee submitted a progress report in late 2009, and hosted public workshops in early 2011. At that time, the Coastal Advisory Committee considered the subject of dog access to beaches and did not support a pilot program. Based on past research, the critical topics are still relevant and include health, safety, cleanliness, enforcement, environmental issues, location, and hours available on the beach.

2011, The Dog Access Subcommittee presented a report of its findings to the Beaches, Parks and Recreation Commission who considered increased access to parks and a phased program for Beach access.

2012, the City Council directed staff to (1) develop a program to allow dogs on-leash at all City parks; (2) consider a pilot/phased approach and availability of some sports fields, with attention to the Vista Hermosa Sports Park and trail; and (3) return to the Beaches, Parks and Recreation Commission and City Council with the understanding that the City is open to expanding dog presence in the park system; and (4) identify locations for new dog runs in existing parks and (5) return to the Beaches, Parks and Recreation Commission and City Council for possible amendments to existing park master plans, CEQA documentation, and amendments to Municipal Codes, with the understanding that the City is open to allowing more dogs to enjoy the park system.

The City Council directed Staff to keep the issue of increased dog access to beaches open, pending changes in circumstances relative to sand replenishment. Because of the diminishing beach space for the public, the Council voted to defer this item until there was a significant change on City beaches.

2013, as recommended by the Commission, the City Council approved dog access to Bonito Canyon, Leslie, Linda Lane, Max Berg Plaza, Marblehead Inland, Mira Costa, Parque Del Mar (excluding Park Semper Fi special use area), Rancho San Clemente, San Luis Rey, Talega, and Tierra Grande Parks, as well as the Community Center grounds. Discussion was held to explore additional opportunities for dogs including fenced dog runs in existing parks.

<u>2014</u>, as recommended by the Commission, the City Council approved a municipal code change to allow dogs on all City parks except playground areas, sport fields, and Park Semper Fi special use area.

2016, the Commission directed staff to research of the option of allowing dogs on-leash on beaches during specific hours. During discussions, the following comments were provided:

- Enforcement and related costs need to be explored.
- Signage needs to be carefully considered if access is granted.
- Beaches are very narrow and have not changed since the last discussion.
- Liability of dogs on beaches is a concern.
- Dog waste on beaches is a concern.
- Aggressive dogs and irresponsible owners are a concern.
- Impacts to lifeguards are a concern.
- Liability would be the same as other public property.
- Allowing morning and evening hours serves residents, not visitors.
- Allowing dogs to walk on the beach may free up space on the Beach Trail.

ATTACHMENT 2

City Council Meeting of March 16, 2021 - Item 9C Agendized by Councilmembers Knoblock and Ferguson

A Resolution Of The San Clemente City Council Allowing Dogs On A Designated Portion of Beach.

"San Clemente Dog Beach"

Whereas: Dog owners are currently prohibited by Municipal Ordinance No. 6.08.020 from taking their dogs to the beach.

Whereas; San Clemente dog owners are forced to drive to other beach communities to enjoy time on the beach with their beloved pets.

Whereas; San Clemente residents own approximately 16,000 dogs, a large number of whom desire to take their dog to a local beach.

Whereas; A majority of dog owners are responsible individuals who properly care for and clean up after their pets.

NOW, THEREFORE, BE IT RESOLVED:

Dogs shall be allowed on San Clemente Beaches effective immediately, for a test program of one-year from the date of passage of this Resolution. Said allowance shall be in strict conformity with the following conditions:

- 1) Dogs shall be allowed only on the following portion of San Clemente Beaches; in the area between the Dije Court stair access from the beach trail and the El Portal stairs access from the beach trail.
- 2) Dogs shall be allowed on the above referenced portion of beach during all times when the beach is open for public use.
- 3) All dogs must remain on a leash no more than 6 feet in length.
- 4) Dog owners or dog attendants shall remain with their dog at all times while on the beach.
- 5) Dog owners or dog attendants shall immediately clean up after their pets.
- 6) This program shall only apply to, and be for the benefit, residents of San Clemente.
- 7) Dogs that have been designation as vicious or potentially dangerous dogs, or are currently pending determination by Animal Control Services (CASA), or any other animal control agency, concerning the dog's possible status as vicious or potentially dangerous dogs, and even if muzzled, are prohibited from the beach access granted in this Resolution.
- 8) The enforcement of all City ordinances, rules or regulations prohibiting dogs on the beach shall be suspended for the duration of the test program as it relates to the portion of beach described above.
- 9) The City Recreation Department Manager shall report to the City Council after the one-year test program on the results, efficacy and community response to this program. This program shall remain in effect after the one-year test period pending future City Council determination of whether this program should cease, be extended or modified in any manner.

The San Clemente City Council hereby determines per Municipal Ordinance No. 6.08.020(E), that the test program described herein is not contrary to the public health, safety or welfare,

Dog Beach Access and Water Quality

Recently, there has been renewed interest in allowing dogs to access a section of beach in San Clemente. One item to consider when a dog beach is proposed is water quality in the ocean shoreline. Dog feces has potential to contribute to Fecal Indicator Bacteria (FIB) in ocean waters. FIB water quality data is used to "indicate" if ocean waters are protective of human health for people who recreate in the water. If Bacteria Water Quality Objectives (WQOs) exceed a specific level, then the beach segment is placed on an advisory list. Signs informing beach goers that water quality could cause health problems are required to be posted throughout the length of the beach segment that has exceeded water quality objectives.

AB411 requires that each of these beach segments be monitored weekly throughout the year unless there is a rain event or conditions are unsafe to collect samples, such as ocean water splashing/crashing on beach rocks/rip rap. The Clean Ocean Program contributes money to the Unified Beach Water Quality Program that streamlines ocean shoreline water sample collection and lab analysis for Orange County cities and agencies. FIB water quality data for each of these segments is publicly available at OCBeachInfo.com. The Coastal Advisory Committee is provided a spreadsheet at each of its meetings that includes the FIB data from each beach segment collected during the previous month.

Bacteria TMDL

The City of San Clemente is required to comply with the Bacteria Total Maximum Daily Load (TMDL) which is incorporated into the Municipal Separate Storm Sewer System Permit (MS4 Permit) issued by the San Diego Regional Water Quality Control Board (RWQCB). There are eleven San Clemente Pacific Ocean Shoreline beach segments listed in the Bacteria TMDL:

- Poche Beach
- Ole Hanson Beach Club Beach at Pico Drain
- San Clemente City Beach (SCCB) at El Portal Street Stairs
- SCCB at Mariposa Street

- SCCB at Linda Lane
- SCCB at South Linda Lane
- SCCB at Lifeguard Headquarters
- Under San Clemente Municipal Pier
- SCCB at Trafalgar Canyon (Trafalgar Lane)
- San Clemente State Beach (SCSB) at Riviera Beach
- SCSB at Cypress Shores

Attached to this memo is an aerial image of the San Clemente shoreline with each of the beach segments labeled.

The Bacteria TMDL has dry weather and wet weather compliance dates. The dry weather compliance date is April 4, 2021, which just passed. The wet weather compliance date is April 4, 2031. During dry weather (when there has been no rain for 72 hours or more) the City is required to meet FIB WQOs for *all* shoreline samples at each of the eleven beach segments. If a sample exceeds FIB WQOs after April 4, 2021, the city is subject to enforcement by the RWQCB.

The Bacteria TMDL was issued in 2010 giving San Clemente and other coastal cities subject to the regulation about 10 years to comply with the April 4, 2021 dry weather compliance deadline. Since that time, eight of the eleven San Clemente beach segments have come into compliance with the Bacteria TMDL. Three beach segments still exceed dry weather FIB WQOs on occasion. These beach segments are:

- Poche Beach
- Ole Hanson Beach Club Beach at Pico Drain
- Under San Clemente Municipal Pier

Dog Owner/Caretaker Responsibility

Many dog owners and caretakers are responsible about picking up after their dog when walking their dog in public places. Unfortunately, there are some people who do not pick up after their pet.

At the beginning of the Pier Bacteria Source Characterization Study, water samples were initially analyzed for the canine DNA marker to determine if dogs could be a source contributing to FIB exceedances at the pier. None of the samples analyzed detected the canine marker. A survey of Staff from other San Diego and Orange County coastal cities that have dog beaches stated that they do not analyze water samples for the canine marker.

Dogs Ingesting Salt Water

Dogs love the beach, but playing games of fetch, chasing waves, and swimming can all lead to a thirsty dog that consumes salt water. A few mouthfuls of salt water may cause diarrhea which can be difficult to pick up if deposited directly in the ocean shoreline waters. Allowing dogs to access ocean water should be a key discussion point when considering a dog beach.

Summary

When considering a dog beach, it is important to keep in mind the water quality regulations for which the City must comply with to protect the health of beachgoers. The Clean Ocean Program strives to meet water quality objectives and has been successful in improving beach water quality by implementing various components of the program. Potential implications of introducing another bacteria source to the ocean shoreline should be discussed and thought out in detail in order to protect human health, comply with environmental regulations and avoid potential enforcement actions and monetary penalties from the RWQCB.

The beach is where we relax as families and with friends and stepping in dog waste or having a child startled by a dog while managing ocean safety seems unnecessary and unsanitary.

There is one dog park in San Clemente and no beach access. I don't see the harm in allowing a leashed dog on any part of the beach, and unleashed in designated area (s) like a dog beach, similar to Huntington Beach. I am happy to see that this issue is being addressed. Whatever the outcome, it takes discussion and forward thinking to make progress of any kind.

Most cities only have 1 or 2 dog parks. There are a few challenges with the Baron Von Willard park: 1. It's remote for most residents; 2. It is not maintained well (broken seating, lack of shade, old water fountains, etc); 3. It is obviously a cheap design (no play structures or trees or shrubs).

We should improve the existing dog park and add one more off leash location, whether on a beach or in a park.

I think some attention could be paid to our existing dog park areas as well - they're very run down

how will you prevent very dangerous breeds from coming to the beach (e.g pitbulls)?

Dog owners can go to Trails or San O (Dog Patch). The city will be inundated with out of town dog owners. Our beaches are too small as it is now especially during high tide. We do not want to be surfing or hanging out on the sand with dog feces that irresponsible dog owners will leave behind.

I believe in a balanced approach that takes account of environmental and safety concerns while providing opportunities for dog lovers in our City to enjoy out beautiful beaches in a reasonable way. Restricted times or areas would be appropriate. The current prohibition on dogs at the beach and the astronomical fines are very unreasonable.

I am a local veterinarian and We would love to have a local spot, that doesn't require state passes or long lines like at San-o to take our dog who loves to swim. Maybe ideal to allow before and after peak hours to reduce incidents but I think this could be a great addition to San Clemente.... as long as dog owners respect our beaches!

Not a good fit for San Clemente beaches..plenty option elsewhere.

- 10. Likely hood dog owners do not keep dogs on leash while running in water
- 11. Increased flea problems in sand and other diseases.

Conflicting support to city / state clean ocean quality program

There are more dog owners that don't have their dog leashed at the parks even though the current code is they must be on a leash. Why have a designated dog park if all parks are open to dogs? The current code also states no dogs allowed on San Clemente beaches yet there are consistently dogs leashed & more often not leashed on the beach, particularly on low tide occasions.

As an OC resident I frequently go down to San Clemente with my dogs. It would be great to have a location at the beach for them to play.

Irresponsible dog owners are the problem, not the dogs themselves. Perhaps the solution to making the owners more responsible would be a privilege system similar to a driver's license. Perhaps an owner comes to the humane society, registers, pays a nominal fee to cover costs and maybe a slight premium to help fund the shelter, takes a responsibility quiz to the owner, then gives a quick basic discipline test to the dog (sit, stay, come, etc.), also giving the opportunity to view a dogs aggressive tendencies. With a pass the dog owner gets a card to wear around their neck when they take their dog to the beach. If they abuse the privilege (leaving waste, bothering other beachgoers, etc.) they can have the privilege/card revoked.

Dogs are not the ones littering on the beach- it's their humans so make sure there are poop bags and disposible containers available to dispose of the poop bags.

some dogs just adore playing in water but not have access to pools. let them enjoy the water As a dog owner and surfer who lives at 204's I would personally LOVE to bring my dog down there to run around off leash but the beach is WAY too small most of the time, and I'm afraid the parking here is already really limited when there is any type of swell or is a nice day during the summer.

It is also clear that many dog owners can not be courteous enough to clean up after their dogs on the beach trail currently, which I'm afraid would only result in a nasty situation for anyone who uses the 204's beach to hang or surf.

I would be more apt to vote to allow dogs on the beach for certain early hours (ie until 8am) and only during off months like October to March. Otherwise I am hugely against this.

In San Clemente, people do not pick up after their animals on the beach trails and/or leave the bags just sitting on the trail. So this will all end up in the ocean with the lack of people picking up after them, just like the beach trail. Plus kids play in the sand, they do not need to be playing and come in contact with feces.

A dog beach would be ideal and more beaches that allow access with a leash.

San clemente needed a dog beach for a long time!

Make penalties and enforcement on dog waste cleanup heavy and immediate! However, dog beaches are incredible places to meet and are good for everyone.

We should start by improving our dog park. The lage dog park is pathetic.

People who own dogs pick up and clean up after them and are very responsible ♥

During certain times of the day or times of the year. The locations I chose were based on the amount of parking, stairs, and visitor/resident traffic. Thank you for providing this opportunity. Trash containers, poop bags and signs enforcing the laws referring to littering by not picking up after your dog and disposing properly.

Responsible dog care should be encouraged. And perhaps even education for non dog owners to help them understand the need for dogs to have some independence and play as well as social time with their humans having fun. Dogs are and have been such an integral part of many human's worlds - especially in this pandemic! And dogs need places to play and be dogs!

I've seen the condition of dog beach in Huntington Beach and it's gross. Dog poop and fleas everywhere. I also have seen many dogs get hit on PCH from running away from the beach.

I love my dogs but I do not like them on the beach or the beach trail. There are to many ppl that will not follow the rules now on the trail and on the beach if allowed. Law enforcement can not handle the problems we have now. Just my two cents.

I feel that since DP pay their tags to SC, that the first question about living in SC should also apply to those who live in DP.

Unless it's a designated dog beach/park, dogs should be on leash.

Dog owners can take their dogs to trails and capo beach. We don't want the tides to wash dog pee and poo into the ocean. Please do not allow dogs in any unsupervised beaches, beaches that have no lifeguard on a regular basis. Dogs should be kept on leashes so they are not disturbing beach goers. It's not out responsibility to educate disrespectful dog owners. I live in north beach and there is poo everywhere on the side walks, I don't that on the beach also.

My dog loves water but I prefer only k on leash... too many pit bull altercations if dogs are allowed off leash. My dog is a 12 pound dog.

Dogs on the beach shouldn't outweigh the health and safety of our children. Dogs poop where ever they are, and let's face it half of dog owners do not pick up after them. If you allow dogs on the beach our kids will be playing and swimming in dog poop.

Dog should be allowed always on-leash

Dog beach in Del Mar is very successful, they have limited off leash hours during summer months (i.e. early morning) and full day off leash hours during winter months.

Dog's should be allowed at any outside areas as long as dogs stay on leashes for everyone's safety:

A lot of the cities around us allow dogs on their beaches, as long as it's not one of the more crowded beaches, like the pier or t-street, I think it would be good. It could help with congestion on the beach trail since currently dog owners can only walk their dogs there.

As Capo Beach, the nearest dog beach, is unsafe and being swept away we should have another dog beach available. The next closest dog beaches are quite some distance. My do loves the beach, but hates the car. As a resident of San Clemente for 20 years, I love how dog friendly this city is. Having a dog beach would be amazing.

I see and I hear the debate on dogs on an off leash. I what people fail to acknowledge is the dogs need to socialize and their need for Positive socialization. If the city could promote more positive dog socialization events than the dogs and the owners would have more opportunities for the dogs in the area to build socialization skills, both in the dog and in the human. these events would allow dog trainers the opportunity to offer their services to people that owns dogs that might need their services. And it would increase the opportunities for dogs to interact with each other. I think most dogs are great off leash when they've been trying to be off leash. It's those dogs that have been trained to be protective and territorial unleash better than a problem.

It's a waste of time to allow dogs on the beach unless it is off leash. Dogs go to the beach to run, chase the frisbee, play in the water. Go to De Mar and look if you want to know what it all about.

Please allow dogs to be on beaches and city parks. I strongly believe all dogs should be on leashes for control purposes and heavily fine dog owners who don't pickup poops.

On-leash access to all beaches!

I live in MV, have a business in Dana point. I'm often at the beach with my dog but would love to do it legally and for my pup to socialize. I hope a dog beach will be considered.

Been waiting a long time for this. Let us walk our dogs in the beach at least in the off season or between hours of 6am-10am and 4pm-8pm. Thank you!

Dogs on leashes only!! Have 2 shiba inus and they love the beach but dont want to get fined for taking them, they are always on leashes.

Dogs on the beaches also increases the chances of dogs getting hit by trains, or luring children onto the tracks. The area between El Portal and Dije Court has a natural buffer of high boulders between the tracks and the beach, making this a logical place for a dog beach.

The North beach's: Dije, El Portal and Mariposa have limited areas to post up and enjoy the beach due to tidal conditions. With the passage a few years ago to open the street above (Buena Vista) to

short term rentals, that limited space is even more occupied.

People are passionate about their pets and sure it would be great to let them run the beach . It's astonishing to me that the council would consider this idea at these locations when there is very limited sand at the above stated locations .

I would like to think that the council is sensitive to the residents of Buena Vista and North Beach area quality of life and ability to spend the day at the beach. Isn't that why we live here? H.B and Del Mar's dog beach's are located on large beach areas with no immediate residents for a reason.

Again, the above locations are not logical locations. Let alone water quality, feces control and potential dog issues.

Do we not allow dogs on the beach in the Winter months when there are not many beach goers?

Not all dog owners will pick up after their dogs. That's just a fact. Dogs should have a small section of their own beach away from human beach goers

Most dog owners who take their dogs to the beach are responsible and pick up after them. There is no reason why dogs should not be allowed on the beach.

As a SC-DP Shelter volunteer and dog owner in the past, I believe dogs are family members. With that said, I still believe for the safety of the public in general, access to public areas needs to be limited.

Unfortunately, there too many irresponsible pet owners. Many do not train or restrain their animals and far too many refuse to pick up after their animals.

Providing and maintaining dog parks seems an acceptable compromise.

We already have people taking their dogs into stores, markets and other facilities here in San Clemente, abusing the laws that provide for service animals. Employees are reluctant to speak up even in food establishments since the dog may be considered an "emotional support dog".

Let dogs be free. Humans are free, why not dogs? Voltair says man is born free but everywhere he is in chains. Should we allow the same for dogs? Absolutely. Freedom.

I am not a dog owner, but I'm also not a dog hater. I love that people have companionship and are encouraged to get outside because they have a pet. This makes San Clemente the wonderful city it is. Unfortunately, not all dog owners are responsible dog owners. From what I've seen on the beach trail we should be very hesitant on allowing dogs on our actual beaches. There are two major issues I've seen with dogs on my daily beach trail walk.

The first issue being, not all dogs are trained. I've personally witnessed and have friends who have been bitten by someone's dog while walking on the trail. This is totally unacceptable. Along these lines, dogs don't respect people's personal space. This means that anyone who is laying out enjoying themselves on the beach will have to keep an eye out for any dog who decides to introduce himself uninvitedly.

The second and most prevalent issue is people not picking up after their animals. If you've walked the trail recently, you spend more time looking where you step to avoid poop rather than enjoying the view of the ocean/beach around you. By allowing dogs on the beach you'll have more people just burying their dogs poop rather than actually picking it up. A perfect example of this is OB Jetty in San Diego. It is a very popular dog beach, but because of that the smell is atrocious and you aren't able to lay down a towel without coming into contact with someone's buried dog treasure (poop).

In a perfect world, this would be a non-issue. But we don't live in a perfect world. And as any local knows, our city/beaches are getting more popular. I've lived here for 30 years and I can't believe how crowded our beaches are even during a pandemic. We can't expect that visitors will respect our town in the same way as locals. By allowing dogs on our beaches we are going to open ourselves up to a Pandora's Box of issues. We want our lifeguards saving lives and not spending their time monitoring people's animals.

There are always going to be irresponsible people whether with dogs or kids - don't follow the rules - however, the beaches and most dog owners who use them are responsible and pick up

after their pets, certainly more than parties who leave trash all over Open the beaches to let us run and e joy nature.

Giving people places to really exhaust their dogs makes them better neighbors, less barking and happier people and pets. Off leash ball catching runs would be great. Thank you for considering better dok access.

I understand that dog owners want to walk on the beach. However, I am constantly picking up dog waste on my own property, sidewalk, driveway and my lawn. It will be hard to trust dog owners to pick up after their dogs on the beach. And the plastic bags they do use, end up being left behind.

I'd like an area where we can throw a ball or frisbee for a off leash dog. Our dog also likes to get in the water.

Beach access should be on leash only and enforced

I love dogs but dog owners can't be relied upon to clean up after their dogs. Few things are grosser than stepping in dog sh*t on the sand.

I think it would be amazing to have a dog beach in sc. locals & tourists would love it.

The problem is Dog Poo my picked up, and then dogs running and knock down kids and Adults.

The residents(and pups) would San Clemente would be eternally grateful if dogs were allowed!!!

Maybe a license fee could be charged to each dog owner so cost of clean-up- whatever- could be shared buyers of dog-beach.

Would love something like the model in Del Mar. Dogs are allowed on beach from Memorial Day to Labor Day. They can run and play without leashes. Leashed dogs tend to be more aggressive than unleashed dogs. Besides, it sort of defeats the purpose of having a dog beach at all.

I would love to be able to walk my dog on the beach. I have a miniature dachshund so I am concerned about letting people let their dogs off leach as some with big dogs do not pay attention or don't care what their dogs are doing and have no control over their dogs. I do feel however that at the least we should be able to walk leashed dogs on the beach and maybe make an area where people can let their dogs off leash to run and play on the beach and in the water.

We live in Dana Point and either drive to Del Mar or Huntington to take the dogs to the beach. Maybe you could allow dogs on beaches off leash before 8am and after 6 or 7pm. Have poop stations available. We walk our dogs at Salt Creek and everyone is respectful and pick up after their dogs.

Dog owners don't follow the rules. They don't pick up after their dogs. I walk on Cap beach almost daily. Dogs are allowed in winter ON LEASH. Every day, I see dogs off leash. Every day. Is the city going to pay for enforcement of the rules?

Dogs need to run free! There should be more space for dogs to be dogs. Thank you!

It would be great to have more opportunities to allow our dogs to run, play and enjoy the beautiful space we offer. It would be owners responsibility to clean up after pets and be responsible and i think we have some lower traffic beach areas that would.offer a great place.

unless folks can be trusted to keep their dogs on a leash, we should not allow access. This is a really big issue.

Dog owners in San Clemente do not pick up after their dogs, even though there are plenty of dog bags and receptacles made available in the parks. Just take a walk along the green belt in Forster Ranch and you will see what I'm talking about. Please do not allow them to ruin our beaches. Also, people do not follow the "on leash" rule with their dogs on hiking trails. I doubt they will follow the rules on the beach.

The city of laguna beach had a great method that works. Dogs can be walked on the beach until a certain time in the morning after that no dogs. Also having a specific beach designated fir dogs off leash to play would be great. Perhaps during summer months this time is limited.

I'm agreeable to allow dogs to play on the beach for certain hours. Like 5 to 7 pm perhaps 3x a week.

If owners can be held accountable for dogs that are rude, I think dogs should be allowed everywhere. They're family.

Most of the dogs are NOT licensed in SC and there is no enforcement by setting up spot checks in the parks and on the streets.

There may be standards established, but as usual no funding is available for enforcement.

Without a funding source there is no need to establish rules because they will not be followed for the most part.

Beaches currently have water quality problems and adding dogs will only add to our current problem. Plus, you will have dogs from all the surrounding cities using the beach without any fees coming into the City for enforcement

During the summer you could do it after 6 and before 9 am as well. Laguna Beach has a pretty great dog policy.

Maybe dedicate one beach as a "dog beach" where dogs can play off leash.

Controlled dogs assuming they are cleaned up after should be allowed

This is not North Beach, we already have a handful of issues to solve before creating more. Let's solve our sand problem, and not trying and sweep it under the rug be turning it into a dog beach.

If we can mirror Laguna Bch, but not Huntington

We are fine the way it is. Take a drive up to HB and see what a mess people leave the beach (e.g. dog excrement; plastic bags; general trash). Moreover, permitting a dog beach will bring more congestion and traffic from inland areas, and our infrastructure is not apt to accommodate more people, vehicles, & trash.

If people feel the need is that great to have our dogs on the beach, San Onofre "Dog Patch" is just a short drive away. That's what most of us San Clememte families do.

I'm not a dog hater and have actually owned dogs most of my adult life.. I just hate dog owners who don't clean up after their dogs. And if leashes are required, many will not abide. Look at the beach at Trail 1 at the Bluffs. I'm sick of off leash dogs charging me while laying on the beach. People do the same at Sano where dogs are not allowed on the beach. No one enforces the laws.

Beaches are for people to enjoy not for careless dog owners to let their animals roam free to do as they please. There's dog parks for that.

Yay! Dog beach!!!

Follow Laguna Beach's guidelines perhaps:

Dogs are allowed on beach between 6pm and 8am, June 1 to September 16. The rest of the year, they are allowed on the beach from dawn until dusk. Dogs must be on a leash at all times.

We live in Capo Beach and drive down to Del Mar almost ever weekend to take our dogs to the beach. People pick up after their dogs, and the dogs are well behaved. Given the chance, I think most people in San clemente would do the same.

While most dog owners keep their dogs under control and following the dog laws, many do not and allow their dogs to attack people and dogs. Many dog owners do not clean up their dog's waste in the city sidewalks and will not clean up after them on the beach..

doesn't even enforce the current dog restrictions- I see dogs on the Pier and INSIDE Fisherman's all the time. If ANY further access is granted it will be mere minutes until we see dogs on every beach. If the City ever demonstrated the ability to actually enforce the current rules I might feel differently. We already lead SoCal in bacteria closures on our beaches, it would be a flat out dereliction of duty to allow dogs on ANY of our beaches.

Our dog park is a small mud field. There isn't a beautiful place for dogs to run off leash and play fetch and frisbee and play in the water. Thank you!

We really need more off leash spaces for dogs! San Clemente dog owners are responsible and respectful. Dogs need open space to play and socialize!

No dogs on beaches. Owners are not responsible enough, the amount of poop and poop filled bags I see in my own neighborhood is a problem. Furthermore, it will impact parking around a designated beach and also bring in people from neighboring cities who don't have dog beaches.

I think dogs should be allowed on all beaches early mornings and evenings to avoid the crowds and you could even do Labor Day thru Memorial Day.

Although I am not currently a dog owner, I love dogs and have many friends who do have them.

However, I am not in favor of allowing dogs on our San Clemente beaches, and certainly not in areas where people are using the beach for recreation or relaxation.

As a dog lover owning 2 dogs, my position on this issue is to keep our beaches "people friendly" and remain off-limits to dogs. There are already ample areas around our beautiful city with access for dogs.

There is almost no parking north of Linda Lane and half the time the tide is too high to even use the beaches between Linda Lane and North Beach. Why the council would pick that spot is unfathomable. Add to that the fact that little dogs might actually need to be carried up and down the long steps at El Portal and Dije makes that particular location among the worst considered.

Dogs should be allowed on certain parts of the beach. Even certain parts of the day would be great like laguna beach does.

The only issue I have is the owners need to pick up after there dogs!!!!

Walking dogs on the beach on leashes should be allowed as it already is in Laguna Beach - same access limits.

We would love a beach spot to be available; as you know, we self police and make sure the area is kept clean. Most dog owners go early am or later pm. Thank you!

Unfortunately many irresponsible pet owners live in San Clemente. There are already dogs running on the beach. I know this because I walk the beach north of the pier nearly every day. Owners do not clean up after their dogs as it is. And you want to draw more by actually allowing dogs on the beach? Unfettered male cats wander the neighborhood all hours of the night yowling and pissing on doors and furniture cushions. Constantly have to avoid dog poop on the sidewalks as it is.

Our beaches are small, we have limited parking, it's crowded during summer and there are no trash cans on the beach north of the pier. Where will even responsible owners put dog poop?

This is an ill advised idea that will draw nonresident dog owners to our beaches. Off leash dogs running on the beach during summer? Trying to find a poop free spot to sit? Poop between your toes when you walk with your SO on the beach at sunset? Floaters polluting the ocean? Really? Eew.

Does the city budget provide for an on site enforcement officer?

As someone who was brutally attacked and bitten by a neighbor's off leash dog in my own yard when I was a child, the safety of children mixed with dogs running and playing on the beach concerns me. I am so beyond thrilled this is being considered and will be closely watching and praying this passes! There is absolutely no reason that we should not be able to walk our dogs ON A LEASH in any public area. However there should be fines for those that do not clean up after their dogs.

I see dogs on the beach all the time whether they are permitted or not. People let their dogs roam free. I have two small children that are scared of dogs. I personally love all animals but they are still animals. Even the nicest, smallest or most gentle dog can scare a child or worst bite a child when they feel threatened. This ruins the beach experience. Plus, my kids play in the sand and the idea that the dogs will defecate in the same sand grossed me out. And I'd like to think ppl will clean up after their dog but trails and neighborhoods prove that there are a lot of lazy ppl that don't. This is unfortunate for responsible dog owners.

I think a trial should be done where beach access is allowed (similar to Newport Beach) dogs on leash are allowed s on beaches after 5 (for safety sake/sanitation, etc) - when the crowds die down.

If after 6 months or so people don't clean up after their pets or many problems are reported, cease the rights and go back to how it is now.

Otherwise make a more appealing dog park (especially the large dog side - it's terrible!!)

Stiff fines for owners not picking up after their dogs on the beach and elsewhere!

The less populous beaches (ie....those outside of the Pier and TStreet) should definitely allow dogs on leash AND?OR dedicate at least 1 or 2 more less populous beaches in San Clemente to dog access.

There are definitely not enough dog options for the city outside of the select dog parks and the beach

Even as a dog owner and lover I know that dogs can instantly change their temperament due to various circumstances. It isn't safe or sanitary for dogs to roam our beaches. The safety of people (especially children) needs to come first. There are plenty of spaces throughout our city for dogs to

This would make life so much better. We go down to watch sunset and it would be so nice to be able to bring our dogs for a walk at the same time. Health & happiness benefits for us and our pets. If there are naysayers, then they can have all the dog free zones around. If they are worried about poop, make the fine for not picking up dog poop steep. If you go to most dog beaches, there is not a lot of poop around. People are mostly good, and responsible when it comes to that. North beach seems ideal location for leash free play area, but make all beaches open for walking dogs after 5 or 6pm. If no one is around, we should be able to take them off leash to play.

Dog owners are not responsible enough presently in cleaning up after the animals as well as throwing away the poop bags. Our trails are littered with animal waste and poop bags and if dogs are allowed on the beach, then there is no incentive to clean up after their dog. Residents and visitors already violate the current posted signage of not having your dog on the beach and they will not respect having to leash their dogs which, from personal experience with dangerous dogs off leash, could be harmful or even fatal to people and especially children. There is a dog beach in Dana Point and having one in San Clemente is only catering to dog owners who choose not to travel a simple 15 minutes to Dana Point.

There are no beaches or parks where dogs are allowed off leash.

Other cities have designated times for dogs on the beach - 6 - 10 am and then maybe 4 pm on depending on the season. Summer could start later. This would be a good compromise. Most early riser / dog owners are responsible and clean up after their dogs.

Most dog owners clean up after them, but there are still quite a few that don't. This would produce unsanitary conditions for others using the beach.

NO DOGS on any of San Clemente beaches......

Because it seems like a large percentage of the population in San Clemente owns dogs, I think it's important to provide more than one location in town for the dogs to be off-leash. Although the beach is not ideal, an area like Dije will regulate itself with the tides and swell. It won't be accessible all day, every day like many of the other more popular people beaches. Also, an area like Dije has parking nearby at North Beach, but will probably not bring tons of people with dogs from out of town.

Carving out another off-leash area in a park, such as San Gorgonio or somewhere along the Forster Ranch open space should also be considered.

Please take into consideration the two biggest risks of off-leash dogs: aggressive behavior/biting and litter/failure to clean up after the pet. It's very easy for an owner to look the other way when their dog is off-leash, and then the dog jumps on someone or poops, and the owner has no idea that it happened. I've seen it frequently on the beach at Cyprus Shore where I live. I've seen dogs knock over beach walkers. I've watched owners ignore their squatting dog and never bother to pick up the poop.

There are already off leash dogs on the beach due to lack of enforcement. When running on the beach they run up to me and I can't tell if they're being aggressive or just want to play. Their sh*tty owners don't call for them either.

Our dogs love to play on the beach off leash. It would be so nice to have a place closer to home for them to play and not drive to San Diego or Huntington. Dog loving volunteers could form a group to make sure it's a safe and clean place for everyone to enjoy.

We would love a dog beach in San Clemente! We live in Dana Point and the closest dog beach is in Huntington or San Diego. A little bit of a drive, so it would be nice to have something closer! Thank you!

NO DOGS ON BEACHES!!!

Dogs on the beach is unsanitary and unnecessary.

What are the concerns? the usual anti-dog, sh*t in the sand rhetoric? How many fish swim in the ocean? Trillions? They all sh*t in the ocean. We shouldn't be too worried about a couple of dog turds. Just one in 20 people not picking up their dog's poop is a lot of poop. Off leash? At a park or beach with children? Are you kidding? Try a dog park.

We walk the beach and the trails in south SC. In the past year, unleashed dogs are everywhere. Some dog walkers bring up to 5-6 big dogs and let them loose. This is very intimidating to other dogs and walkers (scary at times). Dogs bring waste to the beach and ocean waters - well known - and they do not need access to the beach. No off-leash on populated beaches.

Honestly, I think we should follow Laguna Beach and Corona Del Mar's lead on this. They allow dogs on leash at certain times of the day year round and all day between Labor Day and Memorial Day (I think). We have had dogs bull over our kids many of times and scare them, as well as nip at our kids when we are at parks. Beach areas where dogs can play & be walked is quite viable as shown in most other beach cities throughout the State. Time restrictions may be appropriate depending on the area. Having more than one area will help with overcrowding.

Responsible pet owners should be able to walk their dogs in public areas

Good to communicate that dog owners should always clean up after their dogs. Often I see dog poop on the trail and pedestrian bridge.

The ideal dog beach is one without a parking lot nearby, otherwise we will have people from all over south OC bringing their dogs to the dog beach. It also should be a deep, sandy beach where there is only one access path. This will help keep dogs on the beach and avoid having them run up on the train tracks. There also ought to be dog poop bags and trash cans available so dog owners have no excuse for leaving poop behind.

I love dogs. I just do not love the many irresponsible dog owners. It is unbelievable that how much dog poop is found on sidewalks! I walk every day, and I find several EACH day! So what makes anyone think that this won't happen at the beach. Unfortunately many people are irresponsible!

Besides, we have too much waste on beaches already, so why add a potential of harmful dog feces issue that could harm adults and children. The city should think about potential lawsuits should someone get infected by dog urination or feces.

So. NO DOGS ON BEACHES! Period.

Would like to see what kind of enforcement there will be for picking up waste. All of these places are where surfers and kids walk and play without shoes. We moved here from HB thinking SC was dog friendly. HB has a nice dog beach and we were shocked SC didn't have one.

With so many people having dogs there needs to be more places where dogs can have the opportunity to run and play. I lived in Hawaii for many years where dogs are allowed off leash at many of the beaches. Even at lanikai beach which is one of the most famous beaches in the world. Rarely did I see any issues. For those few who will not keep their pet under control the solution is a serious fine. Money talks and most will abide by the rules when significant cash is at stake.

Encourage people to be sure and pick up after dogs to be able to have this priviledge. May need signs

Dogs should be leashed for their own safety, and that leash held by a person competent to maintain control of the animal, if needed.

One way simple way to assess a person's competence to control their animal is whether they're holding the leash at all. A dog with a leash on is not considered leashed under the law if that leash is not held.

While we love our dog dearly, but we want limitations of dogs in human spaces- stirs, beaches, parks. They can't help but pee and poop wherever they roam. Many dog owners are not responsible and their animals are aggressive and unruly. It is unfair to our children and adults alike, to have animals roaming around everywhere. People should be able to enjoy our city and it's beaches without dogs roaming everywhere. We need more children, less dogs.

I chose North Beach, because it has more parking than the other beaches listed.

Our dogs need at least a couple of off-leash areas, besides the dirt cages. Dogs need to run and play, not just walk on a leash. Other nearby cities have at least one off-leash beach and a couple of off-

leash park areas for dogs to play in. San Clemente is way too strict on dog laws and it's not fair to our residents or our dogs.

I feel that responsible dog owners should be able to have their dogs with them at a beach.

If the City decides to designate a specific location (e.g., El Portal) for dogs to play on the beach, then the City should install bag dispenser at each public entrance for that specific location, including a sign reminding dog owners to pick up after their dog, and that they will be fined if they do not pick up after their dog.

The sign should also state that burying dog waste in the sand does not count, and floating it away also does not count.

If ALL dog owners cleaned up after their pets, this might be worth discussing. Unfortunately that's not the case. Huge NO

1% of people allowing dogs on the beach would pick up the dogs feces. Horrible for beach, massive bacteria, pollution, NO DOGS ON BEACH. I've live here my entire life 69 years, and our beaches have never allowed dogs and for good reason. Not to mention being bitten.

Dogs must be on leashes that can not expand to be longer. They are animals and no one knows what they may react to. Sick of dogs attacking and/or running after a dog on a legal length leash.

Pooche is rarely visited by many residents - with the exception of July and August. This beach would be PERFECT for dugs. We live directly above this beach. We see animal control continually park nearby in anticipation of catching someone walking their dog on an otherwise empty beach.

APPRECIATE YOUR CONSIDERATION OF THIS REQUEST!!!!

Most people love dogs. Most owners would probably love to take their dogs to the beach to run around and play. If there was a designated area for dogs on a beach, especially a part of the beach people don't typically go to, then the people that don't want to be near dogs can avoid that area, and the people that want to experience the joy of watching their dog(s) play with or without other dogs on the beach can have a place to do that!

I live in San Juan Capistrano, however, I really enjoy the ability to have beach access for my dog and she loves it.

I would utilize it more often if it was available in San Clemente rather than going to Huntington Beach.

A good solution may be to have a beach be dog accessible from September or October to May. That way you are not limiting your beaches during the high season.

As a former dog owner I understand that well trained dogs are wonderful. However, most days I have to pick up doggie gifts from my yard and my sidewalk. I am afraid that our beaches and parks would be worse than they are now if we allow changes from our current practices.

All activities should be 'on-leash' where owners can responsibly walk there dogs and no worry about interaction with off-leash dogs.

Enforcement will be an issue that needs to be addressed, what are the fiscal impacts.

Parking impacts in need to be addressed.

Ocean water quality and sand cleanliness will be affected greatly! The dog beach in HB is nasty!

Migratory birds shore birds are severely effected by the very presence of dogs... leashed or unleashed.

If San Clemente choses this path, ALL dogs from everywhere will be allow.

I live in Capo Beach and access beaches in San Clemente often. I have no issues with dogs being walked on any and all beaches as long as they are leashed and the owner pick up their dog's waste. However, it would be good if there was a designated beach area where dogs can play in the water off leash.

The proposed location at Mariposa often has no sand during high tide! Dogs should be allowed in areas where there is more sand and less frequented such as North Beach, El portal and lost winds.

Dogs (and their owners) want to run/ play at the beach, having them be leashed sort of defeats the purpose!

Other cities such as Ocean Beach In San Diego County have had a dog beach for years with no significant problems. Owners know they need to clean up after their dogs, and when dogs are off leash they are much less likely to fight.

I'm not sure what the best spot would be, but it would be nice to be able to walk my dogs on the beach. I know Newport allows dogs on the beach before and after specific times.

I am a responsible dog owner and clean up after my pooch. If you simply stroll the beach trail you will see many many examples of owners not cleaning up after their pets. If you go to the dog park there are always piles of fecal matter left by dog owners. It is obvious that allowing dogs on the beach would add to this pollution.

It's too bad, cause I would love for my dog to frolic in the sand and water. Use the knowledge of the mess on the beach trail to not allow dogs on the sand.

Dog owners should big cognizant are their dogs behavior patterns and know whether it's safe, or not, to have their dog off a leash. The owners are always responsible for their dogs actions and behavior. All owners should always have bags to clean up after their dogs no matter where/what/when.

I commend the city of San Clemente for offering this survey and for considering adding another reason why everybody would want to live in San Clemente.

As the owner of a corner home lot, there are dog owners who still think it's ok to allow their pets to poop and not pick it up. Strict guidelines should be enforced like covid, too many dog poops should shut down the idea of a dog beach. Of course there are those who "surprisingly " forget their poop bags. If my rescue dog was still alive I would definitely give the dog beach a shot. Again STRICT code enforcement must be adhered to.

Dogs need to have the freedom to play and run on our beaches! People are concerned about dogs "relieving themselves causing contamination" of our oceans! However, the trash and refuse of what humans discard is far more polluting, including THEIR elimination and trash that is non bio-degradable and live in our oceans forever!!

I have had dogs in the past (mine just died), so I completely understand wanting to take dogs on the beach. However, I run on the beach, and often times I find dog poop after a dog who has not been on its leash. Unfortunately, not all dog owners are respectful and pick up the poop. Countless times I have been running on nearby trails and beaches, only to see dog poop and be thankful I didn't step in it. I don't want that on our beach. I am sorry. There are plenty of dog parks and dog-friendly parks in the area - dogs don't need to have access to the beach to get a good walk/run.

Since most dogs are considered family members, I think owners with their dogs should have access to our beaches...with 2 conditions. The most important revolves around safety and therefore dogs should be on a leash.

Owners who cannot abide by this rule should have strict penalties or fines. Picking up after your dog would be the other.

Although I want my dog to be able to run free, I and my friends have been victim to an unsuspecting and unleashed dog rushing and or attacking another animal...that is not right.

As a dog owner, my dog is part of my family and it's really painful that I can't have her on the beach with me. I have to drive all the way to Huntington Beach to play with my dog on the beach. That's not fair. As we've progressed as a society we should be more loving and accepting towards our dogs. Some of us can't have children and our pets are like our children. Leaving the dog at home while I go to the beach feels wrong. It's like going to a playground and leaving your kids at home. I've heard some concerns about dog poop. I've been to HB dog beach many times and never seen any droppings.

Dogs are not allowed on the beach now, but there are dogs off leach on the beach every day. If we allow dogs on the beach, how many more will there be off leash? How much is the extra enforcement going to cost? I say no dogs on the beach.

25% of the San Clemente residents have a licensed dog, and who knows how much higher a percentage this would be if counting unlicensed ones too, but likely substantial - could be 50% or more. Not providing this large segment just one city beach for dogs is a travesty for the humans and the dogs.

I'd venture to say most dog owners are cleaner (in terms of cleaning up after their dogs) than many other users of the beach who leave untold amounts of track on the beach.

I think it's a mistake to allow dogs on beach. It adds to more pollution in ocean from urine and feces.

Also people walk on the sand barefoot and there will be dog urine.

I own a dog and I think it's not sanitary.

99% of dog owners in San Clemente are responsible pet owners. I witness this firsthand every day as I live directly across the street from Leslie Park, a very common dog and dog owner destination. The dog owners in San Clemente have proven on a daily basis that they don't clean up after their dogs in public spaces.

We absolutely need to adopt these changes. Most beach cities are way more relaxed regarding dogs on the beach!

Owners should be accountable for any dog messes left on the beach with a stiff fine for rule breakers.

Have a dog beach would be a great idea, totally for it.

We need more spaces for dogs in San Clemente. The current dog park is really not dog friendly. It is small and not well maintained. Please consider expanding these offerings!

Many people don't pick up after dogs on trail, why would they do it on the beach. Now we would have to sit on waste while sitting on beach.

I do not like being accosted by dogs while I try to walk on the beach. I do not want my grandchildren being accosted while on the beach or playing in sand that has dog pee or dog poop on it.

Not everyone likes dogs, and dog owners tend to think their dogs are special and so shouldn't have to follow the rules, as evidenced by how many dogs are walked right past the no dogs allowed signs onto the beach. I have been bitten by a dog whose owner assured me would never bite, so I do not want to run that risk again while I'm trying to get exercise or enjoying the beach.

There are already so many dogs on the beach even though it isn't allowed, to allow dogs would make it impossible for people to enjoy the beach due to the number of dogs running around.

Encinitas has scheduled times for off-leash dogs that works beautifully!

It would be great to dogs allowed off leash on the beach during certain hours.

The last thing we need is dog poop on the beach. It currently is the only place you can walk in the whole city without (much) fear of stepping in dog poop. Also, I'm scared of big dogs due to a previous situation so I don't feel safe around off-leash dogs.

I love dogs. Dogs are not predictable. No risks should ever be taken where dogs may injure people, especially children, or other dogs. Not all dogs love to be approached by wildly friendly other dogs. Some can get acquainted slowly and carefully. Dog leashes provide the only hope for avoiding lots of accidents and injuries.

The Current regulations exist for those who cannot control their dogs and who do not pick up after their dogs. For those of us who are responsible dog owners, the current regulations are punitive and should be modified at least slightly. Having a dog beach in San Clemente would be amazing. I have 2 water dogs and having to drove to Carlsbad or Huntington Beach to get them in the water is a bummer. San Clemente has so many great features, why not a dog beach for all us dog lovers out there!

I live near the beach. I have seen, early morning, dogs on the beach. One day I saw a dog defecate on the beach and the owner covered it with sand. I know that not everyone cleans up after his dog. Sorry, but not everyone follows the rules.

Thank you for considering this idea.

I have owned a house in San Clemente since 2013.

I thank Council Members Knoblock and Ferguson for bringing this issue to the Council.

I looked at the proposed Dije Court and El Portal area of the beach. I also looked at parking access to both. They are residential areas. Citizens could park at Pico parking lot.

I also walked T Street Beach to Lasuen Beach. T Street has a small parking lot. Lasuen is a residential area.

I walk the beach path regularly. I have never seen dog feces left unattended on the beach path. I have never seen dog feces on the beach. I will concede that some dog owners do not pick up feces while perfunctorily walking their dogs in the residential neighborhoods. I do not believe these are the type of people who will gather their dog and schlep them down for a walk on the beach.

I would ask the Council to consider allowing leashed dogs on all beaches year-round before 9:00 a.m. and after 6:00 p.m. to be more in line with other local beach areas. If that proposal is rejected, then I suggest the Lasuen Beach to Califia Beach at all times. Of course, complying with the conditions as set out in the resolution for Item 9C from the March 16, 2021 City Council meeting.

Here are neighboring areas and their rules related to dogs on the beach:

Capistrano Beach Park:

June 15 to Sept. 10 dogs are not permitted on the beach between 9 a.m. and 6 p.m. Dogs must be on leash at all times.

Laguna Beach:

Almost all of the city and county beaches in Laguna Beach are dog-friendly if you abide by the rules. Dogs are not allowed on the beach between 9 a.m. and 6 p.m. from June 15th through September 10th. At all other times they must be on a leash.

Newport Beach:

Before 10 a.m. and after 4:30 p.m., dogs are allowed, if they are securely restrained by a substantial leash or chain not exceeding six feet in length and controlled by a person who is competent to restrain the dog.

Cardiff State Beach:

Cardiff State Beach is a dog-friendly beach on the San Diego Coast. Fido can join you on the sand, as long as they are on a leash under 6 feet. The beach is open every day from 6am to sunset.

North Beach Del Mar:

Nine months of the year, dogs are allowed along the entire two plus mile stretch of beach. Dogs must be leashed June 15th through Labor Day. Dogs able to run under voice control of owner from the day

after Labor Day through June 14th.

I look forward to hearing more about this issue.

The water near the San Clemente Pier has been rated "F" for at least the last couple of years. Do we want to add dog feces to that? If you walk the trails around San Clemente, you'll find that dog owners do a poor job of cleaning up after their dogs. DO NOT ALLOW THIS TO HAPPEN TO OUR BEACHES!

Dog owners in a lot of cases DO NOT pick up after their pets and leave the mess for others to step in or have their children get soiled. We do not need uncontrolled access to any of our disappearing beaches. How do you clean up when it is deposited in the water? Also, the waste left on the beach is washed into the ocean when the tide comes up.

A bad idea that should be of no further discussion.

Especially since the pandemic, there are exponentially increased numbers of dog owners in San Clemente. We need to provide places where they can play off leash.

We take our dog to the dog beach in Del Mar almost every weekend. She loves it, and more importantly the owners are courteous, the dogs well behaved, and everyone enjoys themselves. Signs designating the areas dogs can be off leash (or only on leash) are prominent, and owners abide by the rules.

I think the 204/Mariposa stretch of beach is appropriate for dogs because it is less generally populated than popular beaches like T -Street, the Pier, North Beach, Rivi and Calafia. But still has

Water quality tests are already bad along our beaches, we don't need added bacteria. People leave their soiled dog bags along our sidewalks and sometimes on the beach path.

I am a dog lover and former dog owner. My doggie has gone on to greener pastures. I am against dogs on the beach for a number of reasons.

- 1, Dog poop on the beach. People claim they are responsible and will clean up. Lets say 99% are responsible and 1% are not. Lets say 100 dogs visit the beach per day, and that is a conservative figure it you look at the beach trail. That means there will be 1 poop per day on the beach. After 1 week, there is 7 poops, 1 month....you get the idea. That is a lot of poop. If you think people will pick up after their dogs, just walk on the beach trail or the ridge trail on any given day, and I guarantee you will find numerous droppings in spite of trash cans and bags at convenient locations. I can recall when San Onofre beach opened in the 70's, dogs were allowed on the "Trails" beaches. The beach smelled of dog urine and feces. Flys were thick, and when you stuck your hand into the sand you often found a surprise....get the picture?
- 2. Dogs running untethered and even on a leash has the potential for disaster. You know that owners will let their dog off the leash and who knows how far they will run away and possibly bite a child or worse.
- 3. Enforcing the leash law or the beach restrictions will be a nightmare for lifeguards and police. Their eyes should be on the water and not maintaining the order of running dogs.
- 4. The beaches should be for the peaceful, quiet, safe enjoyment of the public. Allowing animals on the beach is a bad idea.

I do not believe dogs should be allowed on Sn Clemente beaches. One should be able to lay on the beach or leave their towel and belongings and not have to think about a dog near them. Some dog owners already bring their dogs on the beach anyway, I have seen people bring their small dogs and try to conceal them. I have also had an unleashed dog the beach run up to my stuff and got sand all over my fishing gear. Unfortunately pet owners are not always responsible, and finding feces on or in the sand would be horrible!! If dogs are ever allowed on any beach it should be only a specific designated beach.

The city of Del Mar in San Diego county has a north beach dedicated to dogs for play, walks and swim. It's wonderful. I moved to San Clemente in 1969 and recently moved to San Juan. Our north beach would be a perfect place as a dog beach.

The city needs to improve existing dog parks before it expands access. If the city cannot maintain what we have now, why should we expect it to maintain a new place for dogs when we already have filthy water. The water quality will only get worse and that rating will hurt our tourists economy so many businesses need. Expand/Improve what we have.

More and more people have dogs that want to be able to enjoy the Ocean San Diego has dog friendly beaches. That are excellent off leash beaches like Del Mar. we go once a week to fiesta Island and once a week to Del Mar.

Dogs consistently poop all over town. Most owners are good about cleaning it up, but many are not. There is no need to add to add this problem to our beaches. The idea of using the beach between Dije and El Portal is terrible, as there is frequently no beach at all and only a small one at lower tides. Dogs running around would make the beach much less relaxing for families with small children who regularly enjoy the area. If there really needs to be a dog beach, it should be at the south end of town where there is plenty of sand.

Too many dog owners are irresponsible and do not pick up after their dogs. The thought that our beaches would be open to owners who show no respect for others and our environment is very concerning and I do not support this consideration.

Councilman Knoblock's resolution states that dogs have to be on a leash, but does not state that the dog has to be under control of the owner, as all other leash law muni codes state. Dogs will run loose on the beach, possibly attacking other dogs and beach goers.

Who is going to enforce the restriction of dogs to a specific area of beach? Why are multiple locations for a dog beach listed in this survey, when the resolution specifies only one?

And it's 4 mikes from my home. The beach would be one of many great places where dogs can run on the sand and play in the water.

While I don't live within San Clemente city limits, I am a neighboring resident in Dana Point. I love being able to take my dog on hikes along the Sea to Summit trail, as well as others. I would hate to have that rescinded. And while i typically drive down to San Onofre State Park to bring my dog into the beach from time to time, it would be great if there was a small section of beach in San Clemente that offered the same allowance. I do find that when I take my dog on hikes I genuinely end up grabbing breakfast or lunch in the area afterwards, so maybe it is worth considering not only the benefits to locals, but also the increased revenue from visitors of neighboring cities. There really are not a ton of trails that dogs can be taken on in Orange County.

More access but additionally leash control...provide adequate pet waste bag stations

It is my opinion that dogs should be allowed to use the public spaces we all enjoy in San Clemente. (With obvious restrictions of course: no biting, aggressive behavior, or being out of voice and sight control)

If appetite for a dog beach area open to the public is not in high demand, I propose a compromise:

If dog owners in the area attend a class and get an off leash license, they can enjoy select beaches with their dog, knowing that other owners present also are aware of any rules or restrictions. This will also limit dogs visiting from neighboring cities, keeping the population lower.

The San Clemente dog park is not a pleasant place to spend time. It's way out of the way, it's not long enough to actually throw a ball and it's dirty:dusty. My dogs never have liked it so we don't even bother going there anymore.

There are so many apartment:multi-family housing dwellers in the town and they need to have places to take their dogs. The beach is ideal, but it needs to be somewhere that is enjoyable at all tides, not just super low tides.

No dog wants an on-leash dog beach. That's just pointless. Make it off leash. Let people and dogs play. Get rid of \$300+ dog fines. That's a terrible way to treat your people.

Kids are loud, messy and crazy, yet we have dozens of places for them to play off leash. Most dog owners are responsible and keep track of their dogs, most dogs are well behaved, yet they are only allowed on-leash and on sidewalks in the majority of the city. That's just nuts.

Poop is easy to clean from beaches. It's hard to clean from sidewalks! Let them be on the beach!

All I know is what is see. I walk the the beach trail several times a week and I see dog feces left on the trail by dog owners who do not police their dogs. What makes you think it is going to be any different if you allow dogs on the beach. With that being said, how are you going to do when a dog decides to urinate on the sand and minutes later a family with children park themselves right where the dog urinated. How does that work? I have lived in San Clemente over 30 years. I have talked to people in my neighborhood and friends regarding allowing dogs on the beach. Not one thought it was a good idea.

I'd like to see San Clemente become a "dog friendly" community with dogs on leashes allowed everywhere. Especially in the winter months - dogs should be allowed on all beaches. I'm okay with limited times for example in the mornings until 10:30 AM and after 6:00 PM. This way dogs could give way to sunbathers as there are more people on the beaches during the warmer parts of the day. Often in winter months there are very few people on the beach.

Having dog seasons and times has worked successfully on many beaches throughout California. State beaches & other cities like laguna beach & corona Del Mar allow dogs on the beach.

Long Beach has a dog access area where dogs are allowed and nowhere else. That way, those who prefer not to be around dogs can simply not set up in the dog area.

IS THERE NOT SOMEWHERE WE CAN GO WITHOUT BEING BOTHERED BY DOGS AND DOG POO?

There is already doggy poo all over the city.

Dogs are unpredictable and most times dangerous animals. Allowing dogs to run wild in any open public space, including beaches and parks, creates a safety hazard for all children and adults. Dog owners unfortunately do not follow the current laws of keeping dogs on a leash or cleaning up after their pet, creating dangerous and unhealthy environments for the public. I have witnessed several times on the beach trail, at the SC pier and other parks, dogs biting and lunging at unsuspecting children and adults. My husband was bitten by a dog that ran unleashed from their owner as we walked along a public San Clemente greenbelt. City Council also needs to step up and protect the safety of all humans by NOT permitting dogs in restaurants, grocery stores and retail establishments. It is scary and unnerving to be confronted by multiple dogs starring you down as you shop for supplies at Lowes or try to enjoy a meal at a restaurant. Human safety and health safety of the public needs to be the first priority! Dog owners should not be allowed to impede onto the public their choice to own a dog. Smoking has been banned in public spaces as it is a hazard to public safety. Dogs should also NOT be permitted at the beach, restaurants, grocery stores or retail stores for the same reasons.

I think that all beaches should be given access to beach before 10 am and after 6pm similar to Laguna. I think dog beaches are gross otherwise.

Please no dogs on the beach!! Not all dog owners pick up after their pet. I grew up in laguna beach where dogs are allowed off season and there was alaways dog poop all over the beach including hidden in the sand where pets just threw sand over the poop. Expanding access to dogs at public beaches and parks would result in significant negative impacts to existing biological resources, water quality, noise, traffic, and the health/safety of the community. A particular issue: the decreasing volume of sand at San Clemente beaches would constrict dogs and people into tighter areas. If dogs are allowed, the policy would be very difficult to reverse and/or enforce restrictions when negative impacts are realized. There are sufficient existing recreational opportunities for dogs and their dog owners at private locations and public dog parks. There is no accountability when someone allows their pet to freely run around or do not pick up after their pet.

Some bad apples make it rough but the dog owner should be held responsible if their dog misbehaves.

Or perhaps, follow the rules Laguna Beach follows.

I currently do not have a dog but had many in the 40 years I have lived here. I think most pet owners are responsible & pick up after their dogs. A few will always spoil it for others and that is not fair. Pet owners should be allowed access with their pets. Maybe a system for identifying slackers?

Dog owners don't clean up after their dogs in their own neighborhood so I don't expect them to clean up after their dogs at the beach. No dogs on beach! I enjoy our San Clemente beaches and don't think allowing dogs on the beach will have a positive affect on our environment.

Be known as a dog friendly city. It will increase tourisim, both for hotels, restaurants, shops and local sightseeing locations. Invest in helping the cleanup where negligent owners 'misbehave', because it is in the interest of the city. The current situation regarding bacteria levels at the beach seems to make it clear that more waste on the beach going into the ocean is not a good idea. There are far too many poop bags and unclaimed poop piles already around the area. While I sympathize with dog owners wanting to take dogs to the beach, I think allowing dogs onto the beach will create a draw that will not improve the cities reputation or cleanliness.

I hope San Clemente will focus on solving the water quality issues rather than compound them. Being a clean beach will have more positive effects economically than turning it into a dog centric beach.

I am very tired of dog owners not picking up after their dogs in parks, and especially along beach trails. We've been to San Onofre many times where dog droppings are common place and the stench was bad.

Dogs should only be allowed on the beach if there is a designated dog beach.

Santa Barbara runs a very successful Dogs on Beach policy. They have designated a stretch of beach (from Henry's beach to the south) which is used by dog owners to let their dogs run free and enjoy themselves. The dog owners are very responsible and clean up after their dogs. The city provides trash cans and doggie poop packet dispensers at the entrance to the beach.

Dogs should not be allowed on any of our small, severely eroded beaches. There is barely enough room for beach goers on busy Summer days without the addition of dogs. While most dog owners are thoughtful regarding the conduct of their dogs, a sizable minority of them are not. Unfortunately, this leads to dog feces and urine in our beaches and parks and dangerous action on the part of some animals i.e. pit bulls.. These are proven health issues as well as quality of life issues. The only way that additional dog access to our beaches and parks could be permitted would be with increased enforcement efforts on guilty dog owners. Although I completely understand that not everyone is responsible or owns a well balanced trained dog, therefore the on leash rules are very important, I would like the opportunity to let my dog off

leash in the permitted park areas when there is no-one else around.

I appreciate this opens the floodgates to the irresponsible owners by changing any off leash rules, so I'm not actually asking for that, more of a plea to Park Rangers to use their own discretion towards ticketing.

At the moment I make the journey to Huntington Beach occasionally for access to a permitted dog beach, so a small strip of beach in San Clemente for dogs would be great.

Pay license fees to SC.

Live in D.P. There should be a small part of beach in SC open to dogs. Similar to Ocean Beach, Sa Diego.

To be a dog owner in San Clemente means choosing between enjoying the beach of our home town or enjoying a day with your pet, but you can't do both. Dog owners are responsible people. They can be trusted to pick up after their pets.

I believe that dogs should be allowed on the beach, at the minimum, during non-summer months. This time of the year, there is rarely a crowd on the beaches so it seems very reasonable to allow dogs on the beach. I would not be opposed to summer months, however, I understand that a more crowded beach creates a logistical problem with dogs and beach goers. Perhaps mornings and evenings, during the summer, would be allowed as a compromise. This is similar to the dog rules in Labuan beach.

As a dog owner of high energy breeds walking them on leash is not enough for them to get the correct amount of exercise. Both my dogs have off leash training as a responsible dog owner I need somewhere they can run free.

I understand that there are concerns about having a dog beach and more off leash dog access but I think there should opportunities for people who need the access.

So many cities around us offer an off leash options. Either park or beach.

Please consider an option for us dog lovers!

I do not believe digs should be in the beach - having 2 dogs myself there are enough places we can go I do not feel dogs should be allowed on beaches. We have enough issues with water and bacteria. Walk the beach trail and you will see the dog owners don't all clean up after their dogs. This will happen at the beach too and I do not want to stop in feces at the beach or swim with it.

There are way too many dogs already in places they should not be, and disrespectful people of others

Dogs DO NOT belong on the SC beach's ! And I am a dog owner a disaster in the making. We already have a dog problem here - and this would make it so much worse . Thank you

As a parent to a 9 year old, I'm opposed to dogs at the beach snd parks because the majority of dog owners don't pick up after the poop. It's also a legal liability with kids and dogs. There are yo many irresponsible dog owners in our area to allow kids and dogs they are not familiar with together.

I support opportunities for dogs to be off-leash on a beach somewhere, but only on beaches that are generally less crowded and during times/seasons that don't negatively impact beach-goers.

Example: off-leash beach opportunities after Labor Day until Memorial Day and in mornings until 8am (maybe a couple evenings 6-8pm like Mon/Wed?)

If dogs can't be off-leash on a beach and only on-leash, I don't get the point.

I understand that many dog owners do not clean up after their pets and this is a real problem that would need addressed.

I do not wish for other communities to bring their dogs to San Clemente en masse, so this must be thought through.

I vote at the least have dogs be able to be walked on-leash at 1 designated

dog-friendly beach and along Beach trails. Provide stands with waste bags and trashcans. Would be nice to have designated times with off-leash play area too (assuming dogs are friendly and playful, no pitbull type breeds).

Only on leashes on the beach and no way on north beach. Too much homeless already and dogs would increase problems. Linda lane good idea. However, dogs need to be on leashes. Threat to children with irresponsible dog owners

I am allergic to dogs, and afraid of dogs, and protest dogs off leash in public areas.

Dogs live here too. They deserve access to our wonderful beaches. Under control.

Maybe from 7-10 am and after 5pm weekdays only when it's not too busy.

I would love to run my dog on the beach but know too many people won't clean up after their pet. That makes it an unhealthy place to recreate, especially for children.

I am a Veterinarian. The majority of dog owners are responsible and clean up after their pets. To be fair there are many non-pet owners who leave trash on the beach. and trail; and ride bikes with no regard to pedestrians and safety.

Many cities have set aside certain areas and times for dogs to be on the beach. I favor early morning such as 7-8 AM and early evening such as 7-8 PM which would not inconvenience the surfers and sun bathers.

Walking and exercising dogs is proven to help people physically and emotionally. I favor fines for people who don't clean up after their pets, buy don't penalize the majority of responsible pet owners for a few irresposible people. I bet if you took a vote that SC residents would approve of dogs on certain beach areas at certain times of the day and certain months of the year.

I love Dogs!

Dogs are the best of humans. Without them we are less kind and caring. They bring joy, a sense of normalcy and family to our lives! Having said this, dog owners are the only detriment to a dogs behavior. Having more freedom for our dogs means holding owners responsible for their behavior, and their dogs behavior. So yes to giving dogs more freedoms 100%!!!! Those owners who violate the rules should be ticketed (\$ for the city) and banned from participating after violations. Maybe a certification of dogs behavior and owner responsibility should be required (\$ for the city). Maybe, look at how Dana Point has managed to provide a dog friendly environment for their city!

Our beach is getting small enough - we do not need dogs on them / it would be different if we had beaches like LA & SD with a lot of sand we just don't have that kind of space!

Dogs are a large part of the community here in San Clemente. Being able to go anywhere with my four legged best friend would be an incredible addition to the already amazing lifestyle here. On top of that, I haven't met anyone in San Clemente that truly has a problem with dogs.

As a dog owner in San Clemente I find it extremely frustrating that the only place in our whole town to let your dog play off leash is at the dirty, small dog park at the end of Pico. I went to this park once and have never been back. The thought that there no place to let our dogs play is so sad. It's time to do something about this.

The city council and parks and recreation board need to be creative in their approach to off-leash areas for our dogs. Communities all over California, including beach areas, have figured out ways to improve the quality of life for dog owners who actually run their dogs responsibly. Off-hours, low- use times are available in all communities. Please be creative as you look at the options. We are tired of searching for safe and legal places to run our dogs for even a half hour. Thank you.

I love the dog friendly nature of the city residents, and am excited to see the city regulations align with or residents.

Candidly I've been taking my dog to Poches and then walking her north off leash once a month for the past 2 years (especially at low tide). I know it's against regulation, but I find if you act like a responsible owner (keep leash on in high traffic areas, clean up after the dog, keep the dog away from others enjoying their day), nobody has once started it was a problem. In fact, many comment how much fun it looks like she has in the waves.

I like the idea of picking a San Clemente beach and doing it on a trial basis. We would also need to publish that aggressive breeds are prohibited (Doberman, Rottweiler, Pitbull, etc.). I'd strongly recommend against the pier, heavy surf spots like T Street, or family beaches like Linda Lane. North Beach is underused and this could give the area a real boost. I am a little worried about too many out of town dog owners not acting responsibly. If this becomes the case, I could also see this being limited to specific times of year (October - April?) or time of the week if it starts becoming a problem.

Lastly, we would need to think hard about enforcement. OCSD and Lifeguards aren't equipped to tackle this.

Dogs allowed to safely play on beach with BIO - DEGRADABLE POOP BAGS available would be very helpful. NOT recommended on beaches during peak hours due to tourism but before 7am and after 6pm during summer and before 8am and after 4pm during winter.

Dog owners in my neighborhood are not responsible with their pets' waste. Please don't permit the potential for more contamination of our public water space.

I currently have one dog a German shorthaired pointer his name is Duke of San Clemente! Year around we will pack up our beach gear and head to the city of Del Mar, Laguna Beach certain hours or Huntington Beach. Besides going to the dog beach is in these other towns we will also go to restaurants that are dog friendly shop at the local stores. We would much rather stay off the roads and stay in San Clemente and go to our local restaurants and shops also pay for parking to the city. Hopefully we will have a Dog, beach in San Clemente soon.

Park on the south end of the muni by the tennis courts should be a dog park!

We are a responsible dog owner and feel most people in San Clemente would be the same if dogs were given this opportunity.

The only resource I have as a large dog owner is the dog park in San Clemente. The large dog side of the park is all rough dirt where the small dog side is nice grass. I can't take my large lab to the small

dog side because small dog owners get upset and when I take him to the large dog side he rips up his paw pads and bleeds a lot when we get home and cries when he walks on them the next day (I'm not the only one with this issue!) I think there should be a dog beach in San Clemente where dogs and play and have the same rules as the dog park. Or a well grassed area where large dogs can run like the grass area behind the boys and girls club (which we were kicked out of by a park ranger when we brought our dog there to play and not get his paw pads ripped up)

From previous experience living elsewhere that dogs were allowed at the beach, the situation was far from ideal. As a dog owner I would enjoy being able to bring my dogs to the beach, but irresponsible dog owners are just one of the massive issues that can greatly impact the beach. My dogs are well behaved, one being that I've taken great pride in being a good companion to them, but not all dogs are the same. The impact animals have on a ecosystem is serious.

The past beach I was at had lots of owners not cleaning up after their dogs or leaving behind feces. It is a serious issue that is not easily resolved with posted signs or enforcement.

One, I'm not behind any measure to spend city's money on an issue that is not as prevalent as others. Increased parking, environmental impacts and wreckless/lazy dog owners are a danger to the beach. We walk our dogs everyday in our neighborhood & are diligent about cleaning up after them, but the hard truth is that many people aren't. Our sidewalks & adjacent areas are consistently littered w/poop, which I often pick up to keep it away from our precious ocean. Our ocean is a balanced ecosystem that supports amazing sea life & it's already over burdened with plastics, pollution & yes, animal & human waste. We have spent a lot of time & money trying to determine

the cause of contamination in the pier area. Allowing dogs on the beach would only add to these problems.

Provide a park area (besides the existing dog park) where owners can let their dog off leash to run & fetch. Then, when waste accumulated, the city can hire help to clean it up & the tide won't have washed it away.

I agree with having parks and large gated areas for dogs to run.

I DO NOT agree with allowing dogs on the beach because most people will not pick up after their dogs. I do not want to have dog poop on the sand or in our water. So many So Calif communities have dog beaches, and San Clemente should be one of those. Many cities have both on-lease and off-lease options. I think the southern section of beach is the best, and it has the least sunbathers. T-Street and south. Maybe during the peak summer season, the hours for the dog access could be restricted (like many other communities have in place), like before 9p and after 6p. The elderly, handicapped, and small children already have limited places to go to exercise and recreate now. Bikes and dogs already create walking hazards on the beach trail. They appear with no warning and expect pedestrians to get out of their way, when they may not be be able to move quickly enough to do so. Dog walkers may have multiple animals, which create noise and block pathways. Dogs may also instill fear in the young and the old, especially if there is a dog fight, which

happens, and create non-sanitary conditions as there is no no way to fully clean up pee and poop. Bacteria builds up over time. Thus, why would we want to legitimize the contamination of our beaches?

Dogs can be walked in neighborhoods and on hilly park trails where walking is too demanding for the young and old. They have other options not available to the young and elderly. You can't argue people will be respectful as they have not been so during the pandemic, most failing to wear masks during the height of the epidemic. Thus, many old time San Clemente residents felt they had to go elsewhere to exercise. We also have a growing tourist industry which populates the beaches and creates trash. How many wounds can we self inflict on our citizens who pay for facilities they can't use, and that's not even mentioning the addition of huge numbers of out of area people an open beach dog park will attract?

We have a horrible fecal bacteria problem. Adding a bunch of dog urine and feces isn't going to make that issue magically go away.
