#### 8. PUBLIC HEARING

A. <u>111 West Avenida Palizada – Conditional Use Permit 21-001 – Inka Mama's</u> (Webber)

A request to consider the sale and on-site consumption of beer, wine, and distilled spirits in conjunction with a full-service restaurant. The restaurant previously operated at Talega Village Center holding a Type 47 license and proposes to relocate to Old City Plaza within Suite 303. Business hours are proposed on weekdays from 11:00 a.m. to 9:00 p.m., and weekends from 11:00 a.m. to 10:00 p.m. Project also includes major interior remodel of existing unit space.

Kyle Webber, Assistant Planner, narrated a PowerPoint Presentation entitled, "Inka Mama's, Full Alcohol, CUP 21-001, dated July 7, 2021." A copy of the Presentation is on file in Planning Division.

Chair Crandell opened the public hearing, and there being no public testimony, closed the public hearing.

IT WAS MOVED BY COMMISSIONER MCCAUGHAN, SECONDED BY VICE CHAIR TYLER, AND UNANIMOUSLY CARRIED TO ADOPT RESOLUTION NO. PC 21-012 A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF SAN CLEMENTE, CALIFORNIA, APPROVING CONDITIONAL USE PERMIT 21-001, INKA MAMA'S FULL ALCOHOL, A REQUEST TO ALLOW FULL ALCOHOL SERVICE FOR ONSITE CONSUMPTION IN DOORS AT A RESTAURANT LOCATED AT 111 W. AVENIDA PALIZADA, STE. 303.

B. <u>127 Avenida Miramar – Conditional Use Permit 20-009 – Miramar Off-Site</u> Parking Agreement (Carrillo)

A request to establish off-site parking agreements between a parking lot at 127 Avenida Miramar, and businesses within 300 feet of the subject parking lot, including tenants in Old City Plaza located at 111 West Avenida Palizada. The agreements would allow businesses to use off-site parking spaces at 127 Avenida Miramar to comply with City parking requirements.

David Carrillo, Assistant Planner, narrated a PowerPoint Presentation entitled, "Miramar Off-Site Parking Agreements, CUP 20-009, dated July 7, 2021." A copy of the Presentation is on file in Planning Division.

Chair Crandell opened the public hearing.

Cecilia Gallardo-Daly, Community Development Director, reported that the writer of an email regarding this matter requested the email not be read

aloud during the Planning Commission meeting, but instead delivered to City Council.

Chair Crandell closed the public hearing.

Discussion ensued regarding potential to require the applicant to provide low level lighting for the parking lot. Staff advised addition of lighting would be a separate application, and the Commission agreed on the need for public comment in the event lighting was proposed. The Commission also discussed potential to condition the project to have staff review and report at regular intervals and/or when new parking agreements are made for the site, but concluded the lack of problems/issues on the site in its history do not indicate the scrutiny is warranted. The Commission requested staff keep an eye out for complaints related to safety and use of the lot, and if any complaints arise that the complaints are addressed and reviewed by staff, including review by Code Compliance and Orange County Sheriff's Department.

IT WAS MOVED BY CHAIR CRANDELL, SECONDED BY COMMISSIONER PRESCOTT-LOEFFLER, AND UNANIMOUSLY CARRIED TO ADOPT RESOLUTION NO. PC 21-011, A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF SAN CLEMENTE, CALIFORNIA, APPROVING CONDITIONAL USE PERMIT 20-009, MIRAMAR OFF-STIE PARKING AGREEMENTS, TO ALLOW OFF-SITE PARKING AGREEMENTS BETWEEN A PARKING LOT AT 127 AVENIDA MIRAMAR AND BUSINESSES WITHIN 300 FEET OF THE SUBJECT PARKING LOT, INCLUDING TENANTS IN OLD CITY PLAZA LOCATED AT 111 WEST AVENIDA PALIZADA.
