City Council Acceptance and Notice of Completion for Street Rehabilitation for Via Pico Plaza, Project No. 13315; and Street Rehabilitation for Calle De Los Molinos, Calle De Industrias and Avenida Navarro, Project No. 16352 and 16353; and for Street Rehabilitation for

Avenida Pico, Project No. 17326.

Fiscal Impact: Yes. The total project cost is \$1,992,509, which is within the approved total

budget of \$2,639,466 from the Street Improvement Fund.

Summary:

All American Asphalt has completed the contract work for the Rehabilitation for Via Pico Plaza, Project No. 13315; and Street Rehabilitation for Calle De Los Molinos, Calle De Industrias and Avenida Navarro, Project No. 16352 and 16353; and for Street Rehabilitation for Avenida Pico, Project No. 17326 in accordance with the contract documents. Staff recommends that the City Council accept the project.

Background:

On August 18, 2020 the City Council approved a construction Contract with All American Asphalt, from Corona, California for the purpose of constructing Rehabilitation for Via Pico Plaza, Project No. 13315; and Street Rehabilitation for Calle De Los Molinos, Calle De Industrias and Avenida Navarro, Project No. 16352 and 16353; and for Street Rehabilitation for Avenida Pico, Project No. 17326. The purpose of the project was to rehabilitate:

- Calle De Los Molinos from Avenida Pico to Avenida Navarro
- Calle De Industrias from Avenida Pico to Calle De Los Molinos
- Avenida Navarro from Avenida Pico to Calle De Los Molinos
- Avenida Pico from Via Pico to Calle De Los Molino
- Via Pico Plaza from Avenida Pico to the end of Via Pico Plaza

Project cost summary is as follows

Engineering Design and Construction Management \$ 68.872 Construction 1,923,637 **Total Project Cost** \$1,992,509

The project was funded through the Street Improvement Fund. Approximately \$647,000 will remain in the fund account available for future projects.

The proposed Notice of Completion (Attachment 2) will be filed with the County Recorder's Office certifying the project completion.

Recommended

Action:

STAFF RECOMMENDS That the City Council:

- 1. Accept the Rehablilitation for Via Pico Plaza, Project No. 13315; and Street Rehabilitation for Calle De Los Molinos, Calle De Industrias and Avenida Navarro, project No. 16352 and 16353; and for Street Rehabilitation for Avenida Pico, Project No. 17326;
- Authorize the Interim Public Works Director to execute and record the Notice of Completion for the Rehabilitation for Via Pico Plaza, Project No. 13315; and Street Rehabilitation for Calle De Los Molinos, Calle De Industrias and Avenida Navarro, project No. 16352 and 16353; and for Street Rehabilitation for Avenida Pico, Project No. 17326;
- 3. Authorize the City Clerk to release the Payment Bond 35 days from the recordation of the Notice of Completion upon verification with the Engineering Division that no liens have been levied against All American Asphalt, Inc.; and
- 4. Authorize the City Clerk to release the Performance Bond upon receipt of a Warranty Bond in the amount of 25% of the construction cost.



CONSTRUCTION CONTRACT AWARD TO ALL AMERICAN ASPHALT FOR STREET REHABILITATION FOR VIA PICO PLAZA, PROJECT NO. 13315; CALLE DE INDUSTRIAS AND AVENIDA NAVARRO, PROJECT No. 16352; CALLE DE LOS MOLINOS, PROJECT No. 16353;

AND AVENIDA PICO. PROJECT No. 17329.

Fiscal Impact: Yes. An additional \$687,805 will be needed to complete the subject project as discussed below. There is funding available in the Street Improvement Fund for this additional cost.

Summary:

Staff recommends that the City Council approve a construction contract with All American Asphalt, in an amount not to exceed \$1,990,098 for the purpose of performing pavement rehabilitation. The project location and limits are depicted in Attachment 1.

Background:

In general, the scope of work for the project includes selected full pavement section reconstruction, repair of failed pavement areas, asphalt grinding and new overlay installation of new curb ramps and upgrade existing curb ramps, traffic signal head replacements, replacement of deficient curb and gutter, installation of new sidewalk and re-striping. The project street segments include the following:

- Calle De Los Molinos from Avenida Pico to Avenida Navarro;
- Calle De Industrias from Avenida Pico to Calle De Los Molinos;
- Avenida Navarro from Avenida Pico to Calle De Los Molinos:
- Avenida Pico from Via Pico Plaza to Calle De Los Molinos; and
- Via Pico Plaza from Avenida Pico to the end of Via Pico Plaza.

Discussion:

The project construction contract was previously terminated on March 2, 2020 due to unforeseen site conditions and revisions were made to the project design, plans, and specifications based on the City Council recommended action (Attachment 2). The project was re-advertised on June 11, 2020, bids were opened on July 2, 2020, and the results are presented on the attached Bidder's Listing (Attachment 3). The lowest responsive bidder was All American Asphalt of Corona, California, with a total bid amount of \$1,990,098. Based on the low bid, the total estimated project cost is \$2,338,993 as summarized below:

The existing project budget of \$1,651,188 is not adequate for estimated expenditures. The project was estimated several years ago but was deferred until completion of the I5/Avenida Pico interchange project and completion of the overhead utility undergrounding project on Calle De Los Molinos north of Pico. Additionally, the project design has changed to improve existing drainage issues and sidewalk accessibility. To fund the additional cost of \$687,805, staff recommends a supplemental appropriation from the Street Improvement Fund, which has available fund balance for this expense. The break down by project is described below:

- \$247,153 to Project Number 13315: Via Pico Plaza from Avenida Pico to the end of Via Pico Plaza
- \$98,208 to Project Number 16352: Calle De Industrias from Avenida Pico to Calle De Los Molinos and Avenida Navarro from Avenida Pico to Calle De Los Molinos
- \$325,493 to Project Number 16353: Calle De Los Molinos from Avenida Pico to Avenida Navarro
- \$16,951 to Project Number 17329: Appropriate and transfer from the Street Improvement Fund to the Gas Tax Fund for Avenida Pico from Via Pico Plaza to Calle De Los Molinos

Staff recommends proceeding with the project now using available Street Improvements funds so that this work can be completed before the coming winter.

As required by City Policy and State Law, the Contractor will be required to provide performance and payment bonds simultaneously with execution of the construction contract (Attachment 4). A warranty bond will also be required prior to City Council acceptance of the project. Project plans and specifications are on file in the City Clerk's office.

Recommended

Action: STAFF RECOMMENDS THAT the City Council:

- Approve the plans and specifications for the Street Rehabilitation for Via Pico Plaza, Project No. 13315; Calle De Industrias and Avenida Navarro Project No. 16352; Calle De Los Molinos, Project No. 16353; and Avenida Pico, Project 17329;
- 2. Approve a supplemental appropriation of \$247,153 to the Via Pico Plaza, Project Account No. 042-848-45300-000-13315; \$98,208 to the Calle De Industrias and Avenida Navarro Project Account No. 042-848-45300-000-16352; \$325,493 to the Calle De Los Molinos, Project Account No. 042-848-45300-16353 from the undesignated fund balance;
- Approve a supplemental appropriation and transfer of \$16,951 to the Avenida Pico, Project Account No. 012-861-45300-000-17329 from the Street Improvement Fund undesignated fund;

4. Approve and authorize the Public Works Director to execute, Contract No. ______, by and between the City of San Clemente and All American Asphalt, in the amount of \$1,990,098.13, for the Street Rehabilitation for Via Pico Plaza, Project No. 13315; Calle De Industrias and Avenida Navarro Project No. 16352; Calle De Los Molinos, Project No. 16353; and Avenida Pico, Project 17329.
