CITY COUNCIL ACCEPTANCE AND NOTICE OF COMPLETION FOR FY 2021 MAJOR

STREET MAINTENANCE, PROJECT No. 21302.

Fiscal Impact: Yes. The total project cost is \$515,042, which is within the approved budget of

\$550,000 from the General Fund.

Summary:

Hardy & Harper has completed the contract work for the FY 2021 Major Street Maintenance, Project No. 21302, in accordance with the contract documents.

Staff recommends that the City Council accept the project.

Background:

On March 16, 2021 the City Council approved a construction Contract with Hardy & Harper from Lake Forest, California, for the purpose of constructing FY 2021 Major Street Maintenance, Project No. 21302. The purpose of the project was to rehabilitate Steed Memorial Park and Pier Bowl parking lots.

Project cost summary is as follows

Engineering Design and Construction Management	\$ 44,613
Construction	470,429
Total Project Cost	\$ 515,042

The project was funded through the General Fund. Approximately \$35,000 will remain in the project account available for future projects.

The proposed Notice of Completion (Attachment 2) will be filed with the County Recorder's Office certifying the project completion.

- Engineering Division that no liens have been levied against Hardy & Harper; and
- 4. Authorize the City Clerk to release the Performance Bond upon receipt of a Warranty Bond in the amount of 25% of the construction cost.

CONSTRUCTION CONTRACT AWARD TO HARDY & HARPER. FOR FY 2021 MAJOR STREET

MAINTENANCE, PROJECT No. 21302.

Fiscal Impact: Yes. The estimated total project cost of \$550,000 is equal to the approved budget

amount of \$550,000.

Summary:

Staff recommends that the City Council approve a construction contract with Hardy & Harper, Inc. in an amount not to exceed \$455,000 for the purpose of constructing FY

2021 Major Street Maintenance, Project No. 21302.

Discussion:

This project includes grinding and overlaying, asphalt removal and replacement. routing, crack sealing, surface sealing, construction of sidewalk and handicap ramps and striping Steed Park Memorial Park and Pier Bowl parking lots. (see Location Map in Attachment 1).

The project was advertised for public bidding on February 4, 2021 and February 11, 2021 using the City's Planet Bids System. Bids were opened on February 25, 2021 and the results are presented on the attached Bidder's Listing (Attachment 2), Bids ranged from \$455,000 to \$576,000. The lowest responsive bidder was Hardy & Harper, Inc of Lake Forest, CA with a total bid amount of \$455,000. Based on the low bid, the total estimated project cost is \$550,000 as summarized below:

#### Project Budget Summary

Construction Design, Management & Inspection (approx.	10%)	49,500
Project Contingency (approx. 10%)	,	45,500
Estimated Total Project Cost		\$550,000

The current combined approved project budget is \$550,000.

As required by City Policy and State Law, the Contractor will be required to provide performance and payment bonds simultaneously with execution of the construction contract (Attachment 3). A warranty bond will also be required prior to City Council acceptance of the project. Project plans and specifications are on file in the City Clerk's office.
