An Adjourned Regular Meeting of the San Clemente City Council was called to order on July 27, 2021 at 6:05 p.m. in the San Clemente Community Center Auditorium, located at 100 N. Calle Seville, San Clemente.

1. HUMAN AFFAIRS COMMITTEE INTERVIEWS/APPOINTMENTS

MOTION BY COUNCILMEMBER KNOBLOCK, SECOND BY MAYOR PRO TEM JAMES, CARRIED 4-0, to appoint Art Carter to the Investment Advisory Committee for a term to expire June 30, 2023 and to appoint Ryan Bourque to the Investment Advisory Committee for a term to expire June 30, 2022.

3. PUBLIC SAFETY COMMITTEE INTERVIEWS/APPOINTMENTS

City Clerk Baade announced that Colleen Courtney-Wilson withdrew her candidacy for the Public Safety Committee; advised that Municipal Code Section 2.46.010 requires that Council appoint technical professionals to the Public Safety Committee that have a public safety background (such as a retired police, fire or marine chief, officer, lifeguard, etc.); related that City Attorney Smith has opined that Council can interpret the term "public safety" broadly, but the term "professional" means that candidates received compensation for their expertise. In response to Council inquiry, City Clerk Baade advised that if Council does not fill all five technical professional vacancies this evening, it can either direct her to readvertise for applicants or direct that the position(s) be left vacant.

MOTION BY MAYOR PRO TEM JAMES, SECOND BY MAYOR WARD, CARRIED 4-0, to re-appoint Nicholas Berkuta, Joseph Janis and Rick Loeffler to the Public Safety Committee.

Council interviewed Charles Hightower.

MOTION BY COUNCILMEMBER KNOBLOCK, SECOND BY MAYOR PRO TEM JAMES, CARRIED 4-0, to appoint Charles Hightower to the Public Safety Committee.

Council interviewed Donna Vidrine.

Council determined that Ms. Vidrine does not meet the definition of "technical professional" as required by the City's Municipal Code.

MOTION BY MAYOR WARD, SECOND BY COUNCILMEMBER KNOBLOCK, CARRIED 4-0, to limit the Public Safety Committee to the four members appointed this evening and to not direct the City Clerk to readvertise to fill the fifth position.

MOTION BY COUNCILMEMBER KNOBLOCK, SECOND BY MAYOR PRO TEM JAMES, CARRIED 4-0, to appoint Nicholas Berkuta and Charles Hightower to the Public Safety Committee for terms to expire June 30, 2023, and to appoint Joe Janis and Rick Loeffler to the Public Safety Committee for terms to expire June 30, 2022. The City Clerk will advertise to fill three openings on the Public Safety Committee as part of the Year 2022 recruitment effort (i.e., the unfilled position as well as the two positions filled by Joe Janis and Rick Loeffler that will expire on June 30, 2022).
