A. Proposed Parking Prohibitions on N. El Camino Real and W. Avenida Santiago (Farivar)

Staff Recommendation

Staff recommends that Planning Commission forward to the City Council a recommendation to approve parking prohibitions at the following locations:

1. North El Camino Real, south side, east of Avenida Presidio for additional 40 feet;
2. a) Avenida Santiago, on the west side of a property's driveway exit located at 1010 West Avenida Santiago for a distance of 10 feet; b) Avenida Santiago, from the southeast curb return of El Camino Real southerly 40 feet.
