- 1. To begin, overall how would you rate the quality of life in the City of San Clemente? Is it excellent, pretty good, only fair or poor?
- 2. Generally speaking, how would you rate the quality of health care available today in your area of San Clemente? Is it excellent, pretty good, only fair, or poor?
- 3. As far as you know, is there a hospital that is open in the City of San Clemente?
- 4. Next, do you feel that the closest (SPLIT SAMPLE A: "emergency room")(SPLIT SAMPLE B: "hospital") to your home is much too far away, a little too far away, or not too far away?
- 5. Have you heard, read, or seen anything recently about the City's search for a new healthcare provider to run a local hospital in San Clemente?

(IF O5 = "YES")

- 5a. Have you heard, read, or seen a lot about it, some, or just a little?
- 6. Generally speaking, do you strongly favor, somewhat favor, somewhat oppose or strongly oppose creating a new hospital in San Clemente?
- 7. As you may know, the Saddleback Memorial Medical Center on Camino de los Mares in San Clemente closed in 2016 and there are currently no hospitals or emergency rooms open in the city of San Clemente. The City has explored many options for attracting a healthcare provider to take over the former Saddleback Memorial Medical Center. All of the experts who have analyzed the building have said that it would take approximately \$200 million to either rebuild the closed hospital, or to knock it down and build a new one that meets the city's current needs and hospital standards, or to build a new hospital at a different location.

11. Next, you will be reading some statements that could be made by potential supporters and opponents of the proposed ballot measure you read about earlier to (SPLIT SAMPLE C – OLD HOSPITAL: "replace the existing Saddleback Hospital building with a new, up-to-date hospital") (SPLIT SAMPLE D - TALEGA: "build a new hospital in the Talega area of San Clemente").

First, here are some statements from supporters of the measure. After reading each statement, please indicate if it makes you much more inclined to vote yes on the measure, somewhat more inclined, or less inclined to vote yes. If you do not believe the statement, or if it has no effect on your thinking one way or the other, please indicate that instead. (RANDOMIZE ORDER OF STATEMENTS)

- []a. Studies have shown an increase in patients dying in a local community when their emergency room shuts down. Seconds count in an emergency, but currently, paramedics have to take San Clemente residents 20 to 40 minutes away to reach an emergency room. This measure would ensure that, rapid response, life-saving, quality medical treatment for victims of heart attacks, strokes and other emergencies is available much more quickly in our own community.
- []b. This measure contains strict accountability provisions by requiring annual independent financial audits, public disclosure of all spending, local oversight, and ensures that all funds are used only for the purpose of building and equipping a new hospital in San Clemente and cannot be used for other purposes or taken by the County or by Sacramento.

[]c. This bond measure will improve the quality of health care services in San Clemente by providing easier and greater access to specialists, attracting and retaining top quality doctors and nurses, and keeping up with advances in medical technology for emergency, cardiac, cancer, and stroke care, among other critical services.

(SPLIT SAMPLE B ONLY)

[]d. In the event of an earthquake or other natural disaster, we need a modern, local hospital that is up to current seismic standards that will protect the safety of patients, doctors, nurses and other staff, can care for emergency room patients and serve as a local command center.

(ASK SPLIT SAMPLE C ONLY - OLD HOSPITAL)

[]e. The City has done extensive research on the options for a hospital, including asking healthcare providers to bid on running the old site and touring the site several times with those groups. All of the hospital industry experts who visited the site agreed that the existing hospital building is so outdated, it would cost at least as much to repair and restore it, and upgrade it to current earthquake safety standards, as it would to build a new hospital.

(ASK SPLIT SAMPLE C ONLY – OLD HOSPITAL)

[]f. Something needs to be done with the old Saddleback Hospital building that has been closed down for more than five years. This location is too important to be left as a vacant, run-down hospital. This plan will replace an eyesore, abandoned building with an up-to-date hospital to serve our community.

(ASK SPLIT SAMPLE C ONLY – OLD HOSPITAL)

[]g. Upgrading and reopening Saddleback Hospital makes sense because many of the existing doctor's offices and specialty pharmacies in town are located near it, as are several senior living communities. Our city needs a hospital and the best place to put it is where there has been a hospital in San Clemente since 1971.

(ASK SPLIT SAMPLE D ONLY - TALEGA)

[]h. This Saddleback Hospital building has been closed down for more than five years and is now just a vacant, run-down, unsafe building with asbestos problems that doesn't meet earthquake safety standards. This measure gives us a fresh start on the kind of hospital that our community needs.

(ASK SPLIT SAMPLE D ONLY - TALEGA)

[]i. This measure will fund the plan to build a hospital on vacant land in an area that is easily reached by residents all over San Clemente and is close to a fire station and the police station at City Hall. It gives all residents better access to rapid-response, emergency, life-saving medical care within a few minutes of their home.

(ASK SPLIT SAMPLE D ONLY - TALEGA)

- []j. Building a new hospital in this area will also create a new location from which ambulances can be dispatched. In times of critical medical emergencies, having better ambulance service coverage throughout the city will improve ambulance response times and help save lives.

- 13. - []a. This bond measure puts all of the tax burden of building the hospital on San Clemente residents, even though it is going to serve residents from all over South Orange County, as well as tourists. Others need to be paying their fair share for the hospital too.
- []b. If this measure goes through, it is going to lead to years of construction noise, dirt, truck traffic, increased commute travel times and other impacts on the neighborhoods where the hospital will be (SPLIT SAMPLE C OLD HOSPITAL: "demolished and") built.

[]c. It doesn't make sense for the City of San Clemente to get involved with building a hospital. With all of the challenges facing our city right now, we should leave the building of a hospital to the companies and non-profit organizations that run hospitals and know how to do that work.

[]d. This bond measure just covers the cost of building the hospital. (SPLIT SAMPLE C – OLD HOSPITAL: "It would cost tens of millions of dollars more to buy the old hospital property. And") Buying all the equipment and paying for all the staff on an ongoing basis is going to require even more money and probably another tax measure.

(SPLIT SAMPLE B ONLY)

[]e. This measure would cost the average San Clemente homeowner about \$230 a year for the next 30 years, which will also get passed down to renters. Most San Clemente taxpayers are already getting hit hard by rising local, county, state and federal taxes. Residents should reject this new tax increase because we simply cannot afford to pay even higher taxes right now.

(SPLIT SAMPLE B ONLY)

[]f. Many of us like living in San Clemente because of its small-town feel. Building a new regional hospital is going to bring more people to this area leading to growth and development that transforms our community, greater traffic and congestion, crime, and strain on city services and infrastructure.

(SPLIT SAMPLE C ONLY - OLD HOSPITAL)

[]g. There is no need to build a hospital in San Clemente. We had one and it closed because there weren't enough people who wanted to use it. And a new hospital in town will not even be a trauma center so it won't even handle many emergencies. Even if it's a good idea to build a hospital in San Clemente, it has already been proven that the location of the Saddleback Hospital does not work for our community. That's why it closed in the first place.

(SPLIT SAMPLE D ONLY - TALEGA)

[]h. There is no need to build a hospital in San Clemente. We had one and it closed because there weren't enough people who wanted to use it. And a new hospital in town will not even be a trauma center so it won't even handle many emergencies. Even if it's a good idea to build a hospital in San Clemente, this measure calls for developing one of the few natural areas of open space left in San Clemente and the City would have to pay at least \$5 million just to level the ground and bring in brand new water, sewer and electrical lines.
