I have twenty years of experience in youth sports and worked with city administrators together to implement positive alterations that benefited both the sports programs and the city.

As the retired financial director of the USC Alzheimer's Center, I have experience in grant writing, research, and collaborating on multi-levels simultaneously. As a former youth soccer board member (at a city level, area and Southern California) of almost 20 years, I have experience in balancing the use and needs of many fields for many sports, collaborating with many individuals to resolve conflicts, and providing creative solutions that are beneficial to the sports programs and city. Personally, I am an athlete that enjoys playing volleyball, pickle ball and running. I want to ensure that the parks and beaches are maintained not just for my enjoyment but the entire community. I have also started to surf. Learning about swells and currents has been interesting but also sand erosion has been detrimental to our local beaches. As a member of the Ocean Institute, in Dana Point, I have reached out to them to educate myself on resiliency. I am also in contact with Jorine Campopiano to better comprehend stormwater and ocean water quality and simply how to get sand back on the beaches.

6. Please explain any expertise that you may have in the area of ocean water quality and/or beach environmental stewardship.

Upon moving to San Clemente, I joined the Ocean Institute not only because of my science interests but also to help with cleaning up the beaches. Recently the Sunrise Rotary Club has committed to cleaning up the San Clemente Beaches on the first Saturday of the month. My home is located in Shorecliffs and our beach club is at Poche Beach. We recently had to install multiple sand bags and tons of rocks in an effort to prevent further erosion. At the Ocean Institute, I have learned that ocean water quality, presence or absence of pollutants, effects not only the sea life but humans too. This seems so basic but the sedimentation, sewage, and heavy metals really require more monitoring and public policy change. My background is in public policy and working with others to accomplish positive results.
