8. PUBLIC HEARINGS

A. Code Amendment (Chapter 13.12 Section 13.12.010-13.12.110) — Water Conservation and Declaration of a Water Shortage Level 2 Water Alert

Public Hearing to consider an ordinance establishing water management requirements necessary to conserve water, enable effective water supply planning, assure reasonable and beneficial use of water, prevent waste of water, prevent unreasonable use of water, prevent unreasonable methods of use of water within the City of San Clemente in order to assure adequate supplies of water to meet the needs of the public, and further the public health, safety, and welfare, recognizing that water is a scarce natural resource that requires careful management not only in times of drought, but at all times. Due to continued drought conditions within the State of California and in response to State Mandates, the City is recommending a Water Shortage Level 2 Water Alert.

Mayor James opened the Public Hearing.

<u>Al Cullen</u>, San Clemente, commented on the urgency of the item and spoke on water conservation.

There being no one else desiring to speak, the Public Hearing was closed.

F. Code Amendment - Enacting Local Campaign Contribution Limits and Policy Regarding Contractor Disclosure of Political Contributions (Agendized at the May 25, 2022 City Council Meeting by Mayor James with the support of Council).

Report from the City Clerk concerning enacting local campaign contribution limits and a policy regarding contractor disclosure of political contributions.

City Clerk Baade, City Manager Sund and IT Manager Brower responded to Council inquiries.

During the course of discussion, Council expressed an interest in considering the following:

- Link on the City's home page to access Form 460 submittals.
- Make Form 460s searchable by name, contributor, and amount, if feasible.
- Staff to publish contributions to candidates in the Public Notices section of an adjudicated newspaper in the City.

Council determined to defer this issue to the Council meeting of June 21, 2022 to enable Staff to complete the following:

- Modify the proposed ordinances to include brackets to enable Council to choose between either a \$500 contribution, or \$1,000 contribution limit, with each option to include a provision allowing Consumer Price Index (CPI) Adjustments.
- Modify the Administrative Report to indicate whether or not contribution limits can be set for different groups, e.g., individual, corporate and PACs.

MOTION BY MAYOR JAMES, SECOND BY COUNCILMEMBER KNOBLOCK, CARRIED 4-0 (COUNCILMEMBER FERGUSON ABSENT) to defer this item until the June 21, 2022 City Council Meeting.

G. Removal of Signs Regarding Face Masks (Agendized at the May 25, 2022 City Council Meeting by Councilmember Knoblock, with the support of Mayor James).

Mike (no last name provided), San Clemente, opined that mask signs are politically motivated.

City Manager Sund stated that he intends to direct that all signs regarding face masks be removed from City facilities no later than June 10, 2022.
