1. APPROVAL OF MINUTES

A. Approval of Minutes of the Regular Meeting held May 6, 2021

MOTION BY COMMITTEE MEMBER DIVEL, SECOND BY COMMITTEE MEMBER AZZOLLINI, AND CARRIED 6-0-1, WITH COMMITTEE MEMBER REGAN ABSTAINING, to approve the minutes of the regular meeting held May 6, 2021.

2. PUBLIC INPUT

<u>Teresa Longoria</u>, San Clemente resident, expressed concern regarding errant balls on Avenida Magdalena near hole #13 citing broken vehicle windows; expressed concern regarding the potential for an errant ball to hit a person; and encouraged the #13 tee to be moved to the other side of the ravine.

<u>Terri Wiley</u>, San Clemente resident, expressed concern regarding errant balls near hole #13; stated there is an increase in pedestrian and vehicle traffic on Avenida Magdalena and an increase in errant golf balls; stated individual golfers do not claim errant balls; encouraged the senior and men's tees be moved up 15 yards or moved to the other side of the ravine; and stated there was a previous recommendation to move the tee to the other side of the ravine.

Committee Member Regan shared communication from Linda Chitwood expressing concern regarding errant balls on Avenida Magdalena near hole #13, and encouraging the tees to be moved to the other side of the ravine or forward.
