4. NEW BUSINESS

A. Tree Policy Review at the Municipal Golf Course

Samantha Wylie, Beaches, Parks and Recreation Director, summarized the contents of the administrative report and responded to Committee Member inquiries.

- A tree policy that is specific to the Golf Course should be created.
- Trees that have been removed used to frame holes aesthetically.
- Alternative varieties of trees might be more suitable for course replacements.

MOTION BY COMMITTEE MEMBER VEALE, SECOND BY COMMITTEE MEMBER AZZOLLINI, AND CARRIED 4-0, to direct staff to draft a separate tree policy specific to the Golf Course.

<u>Samantha Wylie</u>, Beaches, Parks and Recreation Director, provided an update on capital improvement projects and errant golf balls.

A. Greens Subcommittee Report

Committee Member Veale reported the Greens Subcommittee will be meeting to review the Course.

B. House Subcommittee Report

Vice Chair Hamilton reported the House Subcommittee will be meeting with Wedgewood; and Committee Members discussed concerns regarding Wedgewood operations.

C. Committee Member Items

Committee Members discussed course operations and maintenance activities including greens fees, painting of fences to indicate out of bounds near 15 and 5, indication of areas of grounds under repair, cart path improvements near 16, back of 7, use of ropes to prevent carts driving up to greens, course marshal enforcement, water use on the course, golf course budget, and inspection of silver and gold tees.
