


I listen to learn, because I do not know it all, and am bold enough to ask questions. I will partner with others to bring realistic solutions forward in a nonpartisan fashion.

I will continue to support strong police and fire services for our neighborhoods, schools and business communities. I will resist any effort to defund our police or weaken our police, fire or paramedic services.






