ACCEPTANCE AND NOTICE OF COMPLETION FOR THE FY 2021 STREET IMPROVEMENT PROGRAM AND FY 2022 MAJOR STREET MAINTENANCE, CIP PROJECT NOS. 11306 AND 22303

Fiscal Impact:

Yes. The project was completed within the approved budget of \$1,333,351.

Summary:

Roy Allan Slurry Seal, Inc. has completed the construction contract within budget and staff recommends Council acceptance.

Background:

The construction contract was awarded to Roy Allan Slurry Seal, Inc. on February 15, 2022 to construct the subject project in the areas shown in the location map provided in Attachment 1 and other locations throughout the City. The purpose of the contract was to perform various types of roadway maintenance to extend the service life of the pavement.

Project cost summary is as follows:

Administration and Engineering Design (rounded up)	\$34,000
Construction Management and Inspection (rounded up)	47,000
Construction (rounded up)	1,157,000
Total Project Cost (rounded up)	\$1,238,000

- 3. Authorize the City Clerk to release the Payment Bond 35 days from the recordation of the Notice of Completion upon verification with the Engineering Division that no liens have been levied against the Contractor, Roy Allan Slurry Seal, Inc.; and
- 4. Authorize the City Clerk to release the Performance Bond upon receipt of a Warranty Bond in the amount of 25% of the construction cost.





CONSTRUCTION CONTRACT AWARD TO ROY ALLAN SLURRY SEAL, INC. FOR FY 2021 STREET IMPROVEMENT PROGRAM AND FY 2022 MAJOR STREET MAINTENANCE, CIP

PROJECT Nos. 11306 AND 22303

Fiscal Impact: Yes. The estimated total project cost of \$1,333,351 is within the approved budget amount of \$1,450,000 available from the FY 2021 Street Improvement Program CIP Project No. 11306 and FY 2022 Major Street Maintenance CIP Project No. 22303.

Summary:

Staff recommends that the City Council approve a construction contract with Roy Allan Slurry Seal, Inc., in an amount not to exceed \$1,139,616 to provide for the pavement rehabilitation and slurry seal on various streets, including the parking lots at San Clemente Municipal Golf Course and Vista Hermosa Sports Park as shown on the location map (Attachment 1).

Discussion:

This project includes pavement grinding and overlaying, asphalt removal and replacement, crack sealing and slurry seal, and other miscellaneous concrete work and pavement striping.

Bids were opened on January 27, 2022 and the results are presented on the attached Bidder's Listing (Attachment 2). Bids ranged from \$1,139,616 to \$1,798,813

The lowest responsive bidder was Roy Allan Slurry Seal, Inc. of Santa Fe Springs, California with a total bid amount of \$1,139,616.

Based on the low bid, the total estimated project cost is \$1,333,351 as summarized below:

The current combined approved project budget available is \$1,450,000.
