FIRST AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT FOR MARINE STRUCTURAL ASSESSMENT FOR T-STREET OVERPASS

Section 1.1 of the Agreement is hereby amended by increasing the total compensation from Eleven Thousand Seven Hundred Fifty Dollars (\$11,750) to Twenty Two Thousand Two Hundred and Fifty Dollars (\$22,250). In addition to the services to be performed by Consultant as referenced in Exhibit A to the Agreement, Consultant shall also perform those services described in Exhibit "A" to this First Amendment, which exhibit is attached hereto and incorporated herein by this reference.

Except as expressly amended by this First Amendment, the remaining portions of the Agreement shall remain in full force and effect.
