**Subject:**

Consideration of Pilot "Green Line" Trolley Route

**Fiscal Impact:**

The City Council has previously authorized a supplemental appropriation of \$59,230 to account # 021-808-43690 (Other Professional Services) for continued weekend Trolley operations between January and March of 2023 on the red line and \$34,000 for two trolleys on a pilot route for up to 12 weeks prior to Memorial Day weekend.

**Summary:**

Staff recommends that a pilot route connect to a stop that is shared or near to the Red Line. The two busiest stops on the Red Line route are at the San Clemente Outlets and at the San Clemente Pier. Staff has provided two alternatives for consideration: an inland route linked to the Outlets (Attachment 2) and a southern route linked to the Pier (Attachment 3).

**Background:**

At its December 20, 2022 regular business meeting, the City Council authorized an extension of the trolley operations contract with LAZ for the 2023 season, adding Saturday and Sunday service on the red line for January through March and approving a pilot route for the two Blue Line trolleys, which would otherwise be out of service until Memorial Day weekend. The Council asked staff to return with example routes for consideration at their regular meeting on January 17, 2023.

**Discussion:**

To maximize the effectiveness of the temporary pilot route ("Green Line"), staff recommends that either it connect to the Red Line's Pier or Outlets stop, which are the two busiest loading points for the Trolley and have access to public parking. The existing red and blue line routes are shown in Attachment 1.

**Timeframe.** Staff recommends that the pilot "Green Line" operate from Saturday, March 11 until Sunday, May 21, 2023. The following weekend, Memorial Day weekend, the trollies will return to their regularly scheduled Blue Line route as required by the City's Measure V Grant Agreement with OCTA. Staff recommends a target driving time of 25 minutes for the pilot route. With two trolleys operating, this would keep headways between 15-20 minutes at each stop, consistent with the wait times at the Red Line stops.

**Inland Route.** The proposed inland route, shown in Attachment 2, would begin at the Outlets with loading at the same location normally used to service the Blue Line during the summer. Staff recommends the following stops:

- Marblehead Inland Park
- Vista Hermosa Sports Park
- Plaza Pacifica
- Rancho San Clemente Park
- Outlets at San Clemente

These stops were selected because of their proximity to shopping, parking, recreation, and accessibility to inland neighborhoods, including Marblehead, Forster Ranch, Talega, and Rancho San Clemente. This route has a projected drive time of 26 minutes. With operations limited to Saturday and Sunday, staff does not recommend stops in the business parks or at the high school, which are mostly vacant on those days. Other nearby stops that staff considered include the Talega Village Center, Richard T. Steed Park, and the Gateway Village Plaza (near the high school). They were removed, however, to maintain the desired 15-20 minute headways along the route.

**Southern Route.** The southern route, shown in Attachment 3, would begin in the Pier Bowl and proceed in a loop to the south with stops at or near the following locations:

- Dorothy Visser Senior Center
- Ralph's / Zebra House Coffee
- S. El Camino Real / Ramona (near America's Best Value Inn and Surfbreak Hotel)
- S. El Camino Real / Magdalena Off Ramp (near Travelodge and Calafia Inn)
- San Clemente Inn / Raya's Paradise
- San Clemente State Beach (Calafia)
- Ola Vista at Valencia
- T-Street Beach Access
- Pier Bowl

These stops were selected because they provide additional public beach access and access to other visitor serving locations, such as hotels along South El Camino Real and the State Park campground off Avenida Calafia. This route has a projected drive time of 23 minutes. There is public parking at the Pier, T-Street, and near the Dorothy Visser Senior Center; however, the other stops would predominately be on-street stops that are near commercial areas that have restricted private parking. Other stops considered by staff include the Riviera Beach access and the San Clemente Municipal Golf Course.

### ***Recommended Actions:***

#### **Staff Recommendation**

Staff recommends that the City Council:

1. Establish the operating timeframe of March 11 through May 21, 2023 on Saturdays and Sundays for the pilot "Green Line" Trolley; and
2. Direct staff to pursue the inland route or the southern route for the pilot "Green Line" Trolley; and
3. Direct city staff to collaborate with LAZ to establish the precise curb locations and signage for the temporary pilot route.

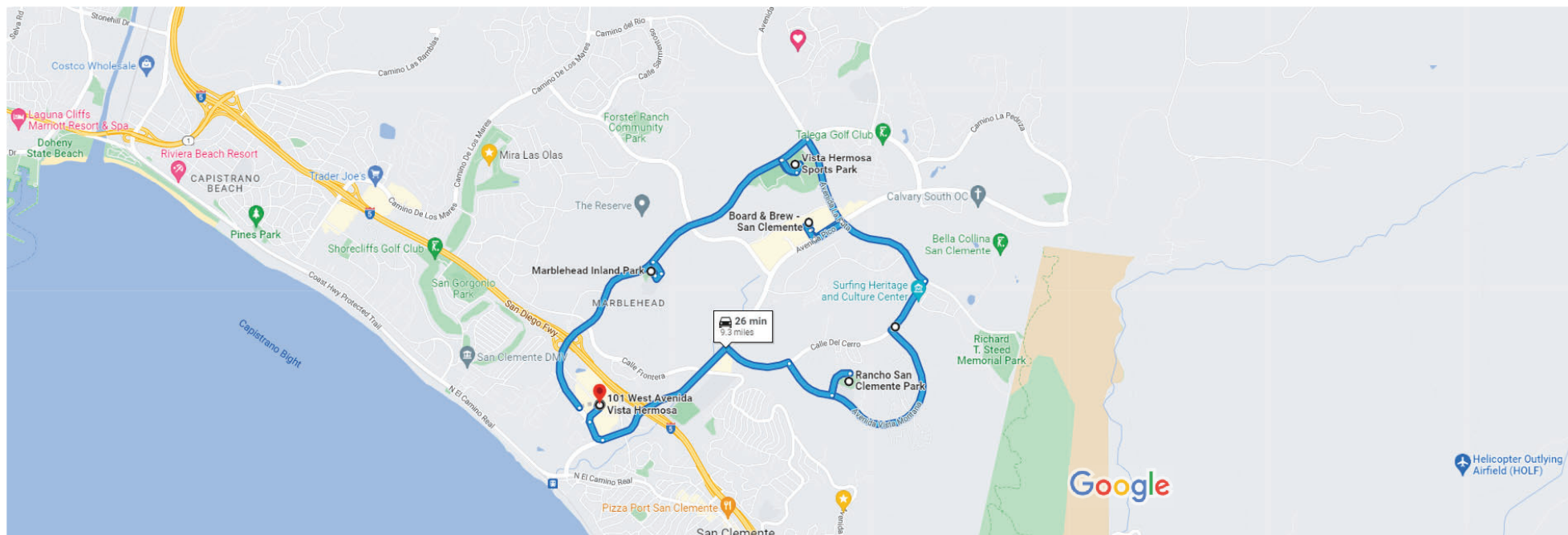

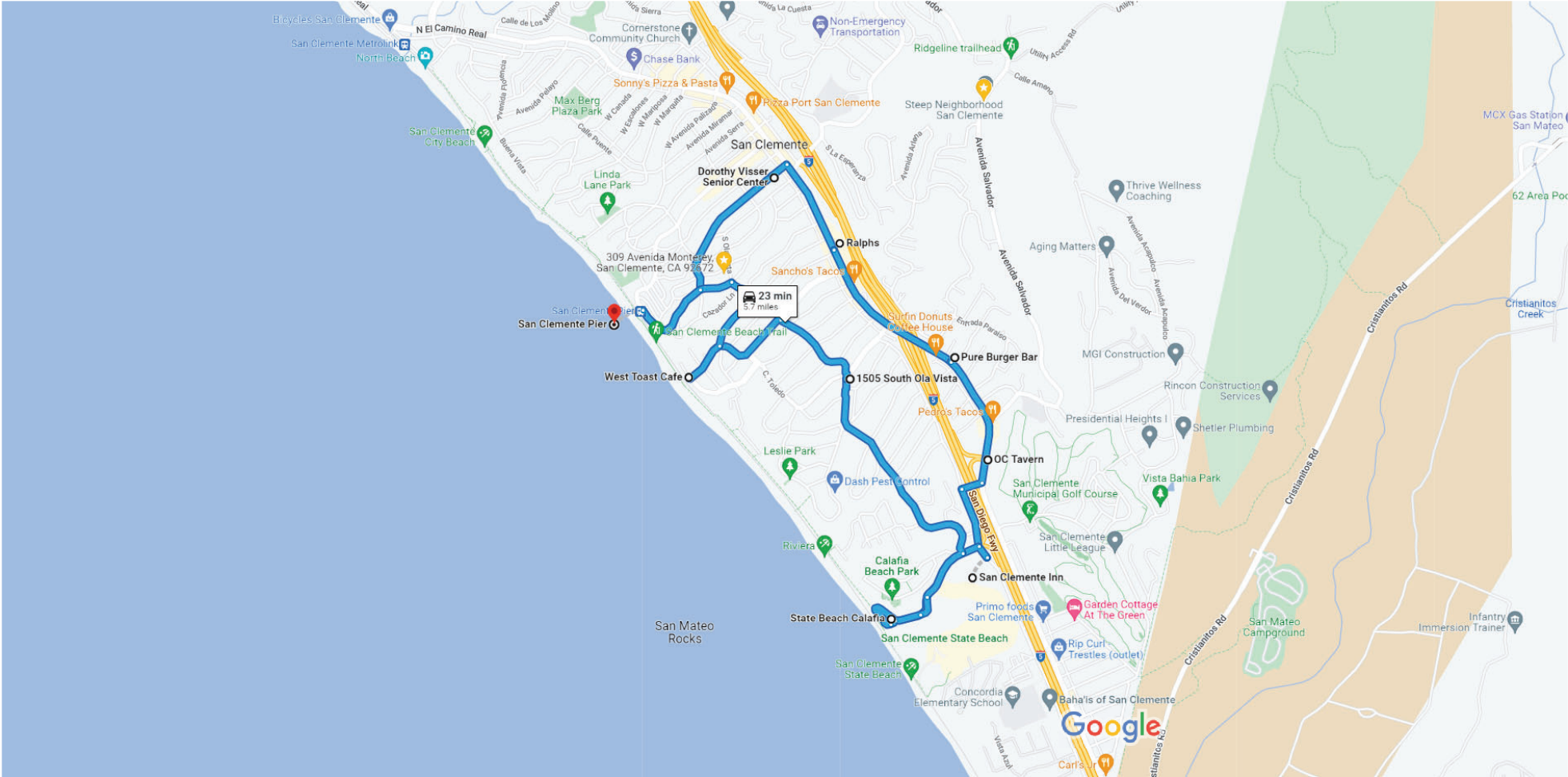
