<u>Donna Vidrine</u> voiced concern with homeless individuals in the cold weather; urged Council to open a temporary emergency weather homeless shelter.

<u>Brad Malamud</u> urged Council to allow the public to be able to review financial reports 14 days in advance of the meeting date; expressed concerns regarding a budget deficit; opined on action Council should take concerning the budget.

Temporary Weather Activated Emergency Homeless Shelter

Mayor Duncan, with the support of Councilmember Enmeier and Mayor Pro Tem Knoblock, directed staff to present options at the March 7, 2023 City Council meeting concerning inclement weather shelter options for San Clemente's homeless. Staff is also to research available resources from non-profit and faith based organizations.

Reduction of General Fund Reserve Balance
