ACCEPTANCE AND NOTICE OF COMPLETION FOR TREE AND PALM PLANTING ON CALLE DEL CERRO AND AVENIDA VISTA MONTANA, PROJECT 12306

Fiscal Impact:

The project cost is \$394,011.58, which is within the approved budget of \$426,259.00 from the Fiscal Year 2023 Capital Improvements Program (CIP) budget 042-848-45300-000-12306.

Summary:

Marina Landscape, Inc. has completed the contract work for the Tree and Palm Plantings on Calle Del Cerro and Avenida Vista Montana, Project No. 12306, in accordance with the contract documents. Staff recommends that the City Council accept the project.

Discussion:

On February 15, 2022, the City Council approved a contract (#C22-09) with Marina Landscape, Inc. from Orange, California to plant 416 trees and palms in medians and parkways on Calle Del Cerro and Avenida Vista Montana. The purpose of the project was to plant new trees and palms to replace previously removed trees, which were causing damage to roadway pavement and other City hardscape as well as to replace trees that were dead or dying from untreatable pest infestation.

The project was funded through the Fiscal Year 2023 Capital Improvements Program (CIP) budget 042-848-45300-000-12306. The proposed Notice of Completion (Attachment 2) will be filed with the County Recorder's Office certifying the project completion.



CITY COUNCIL APPROVAL FOR CONTRACT AWARD FOR CITY TREE AND PALM PLANTING ON

CALLE DEL CERRO AND AVENIDA VISTA MONTANA, PROJECT NO. 12306

Fiscal Impact: Yes. The total project cost is \$426,259.00 with a base bid of \$370,660.00 and a 15% contingency of \$55,599.00. This amount is within the approved total budget of \$1,500,000 for Project No. 12306 in the Fiscal Year 2022 Capital Improvements Program

(CIP) budget 042-848-45300-000-12306.

Summary:

This is a request to award a Public Works contract as further described below.

Background:

Fiscal Year 2022 Street Rehabilitation/Slurry Seal CIP project includes the replacement of median trees causing damage to the roadway pavement. In addition to these trees, staff has identified many trees in the parkways of Calle Del Cerro from Ave. Pico to Ave. La Pata and Ave. Vista Montana between Calle Del Cerro and Calle Pastadero that were dead or dying from an untreatable pest infestation. The removal of these trees has already been completed through a separate bid process that came before the City Council.

The tree selection was based on feedback from the Rancho San Clemente Community Association and City staff, which includes an International Society of Arboriculture Certified Arborist. The tree planting will be scheduled prior to the street work that will be done. The planting plan for Calle Del Cerro (see attachment 1). The planting plan for Avenida Vista Montana is based on replacement of removed trees.

At the December 21, 2021 meeting, City Council rejected all previous bids on this contract in order to clarify responsibility of Department of Industrial Relations (DIR) prevailing wage determination and then rebid the project.

The project was placed on the City's electronic bid platform, PlanetBids, from January 6 through 26th, 2022. An advertisement was also placed in the San Clemente Times on January 13 and 20th, 2022.

The City received five proposals from qualified contractors. Marina Landscape, Inc. was the lowest responsible bidder at \$370,660.00. Staff confirmed Marina Landscape, Inc. references and like contracts with other public agencies (see attachment 2).

STAFF RECOMMENDS THAT the City Council approve and authorize the Public Works Director/City Engineer to execute Contract No. _____ by and between the City of San Clemente and Marina Landscape, Inc. in the amount not to exceed \$426,259 for Tree and Palm Planting on Calle Del Cerro and Avenida Vista Montana.





SECTION 00500 CONTRACT

THIS CONTRACT is made this _____ day of _____, 2022, in the County of Orange, State of California, by and between the City of San Clemente hereinafter called City, and Marina Landscape, Inc., hereinafter called Contractor. City and the Contractor for the considerations stated herein agree as follows:

ARTICLE 1. SCOPE OF WORK. The Contractor shall perform all Work within the time stipulated the contract and shall provide all labor, materials, equipment, tools, utility services, and transportation to complete all of the Work required in strict compliance with the Contract Documents as specified in Article 5 below for the following Project:

TREE AND PALM PLANTING ON CALLE DEL CERRO AND AVENIDA VISTA MONTANA

The Contractor and its surety shall be liable to City for any damages arising as a result of the Contractor's failure to comply with this obligation.

ARTICLE 2. TIME FOR COMPLETION. The Work shall be commenced on the date stated in City's Notice to Proceed. The Contractor shall complete all Work required by the Contract Documents within SIXTY (60) working days from the commencement date stated in the Notice to Proceed. By its signature hereunder, Contractor agrees the time for completion set forth above is adequate and reasonable to complete the Work.

ARTICLE 3. CONTRACT PRICE. City shall pay to the Contractor as full compensation for the performance of the Contract, subject to any additions or deductions as provided in the Contract Documents, and including all applicable taxes and costs, an amount not to exceed Four Hundred Twenty-Six Thousand, Two Hundred Fifty-Nine Dollars (\$426,259.00), which includes a 15% contingency of Fifty-Five Thousand, Five Hundred Ninety-Nine Dollars (\$55,599.00). Payment shall be made as set forth in the General Conditions.

At any time during the term of the Contract. City may, pursuant to the terms and provisions of the Contract Documents, request that the Contractor perform additional work. Contractor shall not perform, nor be compensated for, additional work without written authorization from the City pursuant to the terms and provisions of the Contract Documents.

ARTICLE 4. LIQUIDATED DAMAGES/EARLY COMPLETION INCENTIVE. In accordance with Government Code section 53069.85, it is agreed that the Contractor will pay City the sum of five hundred dollars (\$500.00) for each and every calendar day of delay beyond the time prescribed in the Contract Documents for finishing the Work, as Liquidated Damages and not as a penalty or forfeiture. In the event that Liquidated Damages are not paid, the Contractor agrees City may deduct that amount from any money due or that may become due the Contractor under the Contract. This Article does not exclude recovery of other damages specified in the Contract Documents.

The Contractor shall complete the Work in strict accordance with all of the Contract Documents.

All of the Contract Documents are intended to be complementary. Work required by one of the Contract Documents and not by others shall be done as if required by all. This Contract shall supersede any prior agreement of the parties.

ARTICLE 6. PROVISIONS REQUIRED BY LAW. Each and every provision of law required to be included in these Contract Documents shall be deemed to be included in these Contract Documents. The Contractor shall comply with all requirements of applicable federal, state and local laws, rules and regulations, including but not limited to, the provisions of the California Labor Code and California Public Contract Code which are applicable to this Project.

ARTICLE 7. INDEMNIFICATION. Contractor shall provide indemnification as set forth in the General Conditions.

ARTICLE 8. PREVAILING WAGES. Contractor shall be required to pay the prevailing rate of wages in accordance with the Labor Code which such rates shall be made available at City of San Clemente Public Works Department Office or may be obtained online at http://www.dir.ca.gov/dlsr. and which must be posted at the job site.

IN WITNESS WHEREOF, this Contract has been duly executed by the above-named parties, on the day and year above written.
