A. General Plan Consistency Finding for Fiscal Year 2024 Proposed Capital Improvement Program

A request for the Planning Commission to find the Fiscal Year 2024 Capital Improvement Program is consistent with the Centennial General Plan.

Christopher Wright, Associate Planner II, briefly reviewed the Program, and distributed a handout at the dais indicating projects that have been revised, added or deleted on the 2024 version of the Capital Improvement Program. The handout was also printed and made available to the public and is on file with the Planning Division.

- 2) Adopt Resolution no. PC 23-008, entitled, "A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF SAN CLEMENTE, CALIFORNIA, FINDING THE FISCAL YEAR 2024 CAPITAL IMPROVEMENT PROGRAM CONSISTENT WITH THE SAN CLEMENTE GENERAL PLAN."

8. PUBLIC HEARING

A. Conditional Use Permit 23-072, North Beach Villa Full Alcohol, 1410 Calle Mirador

A request to allow a full range of alcohol service at an existing bed and breakfast inn with one manager’s unit and three guest rooms. The site is in the Neighborhood Commercial 2 Zoning District and Architectural, Affordable Housing, and Coastal Zone Overly Districts (NC2-A-AH-CZ) at 1410 Calle Mirador.

David Carrillo, Assistant Planner, narrated a PowerPoint presentation entitled, "North Beach Villa Alcohol Service, CUP 23-072," dated May 3, 2023. A copy of the Presentation is on file in Planning Division.

Chair McKhann opened the public hearing.

Eric Spink, applicant, provided an overview of the inn’s operations; responded to Commission comments/suggestions; provided details on service of alcohol and food offerings; noted that he and his wife have completed the required responsible alcoholic beverage service provider’s training; recapped positive public response to the inn to date.

1) Determine the Project is Categorically Exempt from the requirements of CEQA pursuant to CEQA Guidelines Section 15301 (Class 1: Existing Facilities) and;

2) Adopt Resolution no. PC 23-006, entitled, “A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF SAN CLEMENTE, CALIFORNIA, APPROVING CONDITIONAL USE PERMIT 23-072, NORTH BEACH VILLA ALCOHOL SERVICE, LOCATED AT 1410 CALLE MIRADOR AND FINDING THE PROJECT IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) UNDER SECTION 15301 OF THE CEQA GUIDELINES (14 CCR § 15301, CLASS 1: EXISTING FACILITIES).”
