

CITY OF SAN CLEMENTE MINUTES OF THE REGULAR GOLF COURSE COMMITTEE MEETING

A regular meeting of the Golf Course Committee of the City of San Clemente was called to order on Thursday, February 2, 2023, at 5:58 p.m. at the City Hall Council Chambers located at 910 Calle Negocio, San Clemente, CA.

1. APPROVAL OF MINUTES

A. Approval of Minutes of the Regular Meeting held November 3, 2022

MOTION BY COMMITTEE MEMBER AZZOLLINI, SECOND BY VICE CHAIR HAMILTON, AND CARRIED 5-0, to approve the minutes of the regular meeting held November 3, 2022.

Ryan Clancy, San Clemente resident, commented concern regarding errant balls near homes and recent tree loss near hole #5.

4. **NEW BUSINESS**

A. Review of Future Golf Course Improvement Projects, FY 23-24

Jordan Gilmore, Golf Course Manager, summarized the contents of the administrative report and responded to Committee Member inquiries.

Committee Members either individually or in agreement commented:

- The restroom replacement should be a City project.
- The cart path (#5) is a good idea.
- The new mower should be ordered right away.
- The City should take the lead on timing of restroom replacement with the Course contributing to the cost.

- All items are part of the maintenance of the Course, and need to be done.
- Items #2 and #6 are recommended priorities, with other items prioritized by maintenance and City.
- Future tree problems could be avoided through trimming.
- Tree maintenance is risk mitigation.

MOTION BY COMMITTEE MEMBER VEALE, SECOND BY VICE CHAIR HAMILTON, AND CARRIED 5-0, to prioritize projects presented in the agenda report as "2: Replace trees that fell from storm on January 23", "3: Reconstruct wood fence by #9 green", and "6: New rough mower", and leave the other items for staff to schedule as available.

i. Storm Damage to Trees

Jordan Gilmore, Golf Course Manager, and Samantha Wylie, Beaches, Parks and Recreation Director, provided an update on trees damaged in the recent storm on January 23 and responded to Committee Member inquiries.

Committee Members either individually or in agreement commented:

• The trees that most impact the play of the Course should be prioritized.

MOTION BY COMMITTEE MEMBER PAGE, SECOND BY COMMITTEE MEMBER AZZOLLINI, AND CARRIED 5-0, to recommend the City Council approve funding to replace damaged trees prioritizing the trees on #2 green, #3 right, #5 left, and #8 left.

ii. Maintenance Update

Jordan Gilmore, Golf Course Manager, provided an update on golf maintenance activities including irrigation damage and repair, upcoming aerification, new tee box on #12, and geraniums on #6 and #3.

Samantha Wylie, Beaches, Parks and Recreation Director, reported an update on capital improvement program and budget preparation.

Committee Member Page presented a golf course tour report noting tree loss, irrigation damage, #1 tee box improvements, staffing, vandalism, new equipment needs, e-bikes, and #16 tee box improvements.

Committee Members discussed course operations and maintenance activities including golf rates, deflection board on #17, bunker sand, and height of the rough.
