5. MINUTES

A. Minutes from the Regular Planning Commission Meeting of May 3, 2023.

IT WAS MOVED BY VICE CHAIR COSGROVE, SECONDED BY COMMISSIONER PRESCOTT-LOEFFLER AND CARRIED 3-0-2, WITH COMMISSIONER CRANDELL AND CHAIR PRO TEM CAMP ABSTAINING, (COMMISSIONER DAVIS AND COMMISSIONER MCCAUGHAN BEING ABSENT) TO RECEIVE AND FILE THE MINUTES FROM THE MAY 3, 2023, PLANNING COMMISSION REGULAR MEETING AS SUBMITTED.

Chair McKhann acknowledged two written communications already received and invited comments from the public.

<u>Pamela Goodman</u>, resident, described the dangerous traffic conditions on this portion of Avenida Presidio; requested signs and posts in the road for pedestrians and those traveling to/from the facility.

<u>Debra Marsing</u>, resident, supported the traffic calming measures recommended by staff.

Seeing no more members of the public wishing to provide testimony, Chair McKhann invited the Commission to provide final remarks/action on the project.

IT WAS MOVED BY VICE CHAIR COSGROVE, SECONDED BY COMMISSIONER CRANDELL AND UNANIMOUSLY CARRIED TO:

- 1) Recommend to the City Council to determine that the project is categorically exempt from the requirements of the CEQA pursuant to CEQA Guidelines Section 15306 (Class 6, Information Collection) and 15301.k (Class 1, Existing Facilities) of the State CEQA Guidelines; and
- 2) Forward a recommendation of approval to the City Council for the proposed traffic calming measures as follows:
 - a) Install an electronic speed feedback sigh, red curb, and edge lines.
 - b) Appropriate the required funds from the traffic calming budget.
 - c) Request Police Services to consider increasing the speed enforcement near the apartment complex at 105 Avenida Presidio.

C. <u>Training on Due Process</u>

Gena Burns, Deputy City Attorney, distributed a handout and reviewed the information therein.
