Committee Chair Loeffler called the Regular Meeting of the Public Safety Committee of the City of San Clemente to order at 3:00 p.m.

5. MINUTES

A. Minutes from the Regular Public Safety Committee meeting of April 25, 2023

MOTION BY MEMBER GREENWALD, SECOND BY VICE CHAIR HIGHTOWER AND CARRIED 3-0-2, Members Berkuta and Roeber absent, to approve the minutes from the Public Safety Committee meeting of April 25, 2023, amended to change "under the bed bags" to "under the bed bags (gobags)" in Section 4, 3rd paragraph and correct Tower to Hightower in Section 9.A.2, 2nd paragraph.

6. ORAL AND WRITTEN COMMUNICATION

Bill Kreutinger, Technical Director for Tri-cities RACES, made an announcement regarding the installation of digital emergency data equipment in the surrounding communities.

7. REVIEWS AND RECOMMENDATIONS

A. Care Ambulance Performance Measure FY 2023 Q2

Member Greenwald expressed concern with the lack of performance measures in the contract.

Vice Chair Hightower expressed concern about the response time goal not being met, and inquired about the efforts being made to reduce the response time.

Vishal Raj, representing Care Ambulance, addressed the Committee regarding inquires to FY2023 Q2 Performance Measures. He discussed response times and the need for additional staffing.

Chair Loeffler stated Member Roeber would be contacting them regarding the discrepancy between the OCFA and ambulance data.

B. Marine Safety Performance Measures FY2023 Q2

Chief Cheyene Maule summarized the FY 2023 Q2 Performance Measures.

In response to Chair Loeffler, Chief Maule discussed a recent call involving an unconscious male.

C. OCSD Performance Measures FY 2023 Q2

Chair Loeffler questioned the workload output calculation. He stated that the City Council considered hiring a security company, but ultimately decided to hire four deputies to patrol a key designated area.

Vice Chair Hightower pointed out the percent change in Group A crimes resulting from a new calculation method. He then requested that Captain Christian provide clarification regarding the reference to dividing effectiveness by zero.

9. <u>UNFINISHED BUSINESS</u>

A. Public Safety Committee Annual Work Plan FY2022-2023

1. Communications and Disaster Preparedness Project Update

Vice Chair Hightower discussed various efforts related to emergency preparedness, including the Red Cross Emergency Shelter; Emergency Food Supply and Distribution (Abound Food Care); Wireless Priority Service (WPS); and Government Emergency Telecommunications Service (GETS).

Chair Loeffler explained that the Emergency Food Supply and Distribution was tabled due to Councilmember Cabral wanting additional information on the process.

Deputy Director Atamian stated Public Works is working on the wireless priority service.

8. <u>Technology Review</u>

Vice Chair Hightower discussed mobile security system technology that has proven effective for addressing problems at City beaches, parks and illegal RV parking. He stated presentations were received from Live View Technologies and Covert Law Enforcement and the cost per year was quoted at \$92,042. He suggested use of mobile and fixed autonomous surveillance systems to maintain public safety at North Beach and other areas in the City.

Chief Maule stated he did not have experience with the proposed system.

Captain Mellott discussed the existing cameras, which he found to be very effective.

Deputy Director Atamian stated staff was not available to watch live footage.

MOTION BY VICE CHAIR HIGHTOWER, SECOND BY CHAIR LOEFFLER AND CARRIED 3-0-2, Members Roeber and Berkuta absent, to bring back an item on autonomous security cameras and invite the IT Manager to discuss the existing camera system.

7. E-Bicycle/Traffic Safety

Vice Chair Hightower discussed a complaint regarding e-bikes on the trails by Rancho San Clemente. He discussed two relevant bills, namely AB 1946 requiring the CHP to establish an e-bike program, and AB 1909, a bicycle omnibus bill allowing cities to regulate e-bikes. Additionally, he made reference to the City of Carlsbad's code concerning the use of e-bikes on trails.
