#### Subject:

CONSIDERATION OF A RESOLUTION APPROVING THE STRATEGIC IMPLEMENTATION PROGRAM FOR FISCAL YEAR 2023-2024

#### Fiscal Impact:

None. The Strategic Implementation Program does not commit specific financial resources towards projects. Funding for implementation measures of the General Plan typically occurs through the City's Capital Improvement Program or annual budget process.

#### Summary:

The City's General Plan Strategic Implementation Program (SIP) is updated each fiscal year. The SIP lists and prioritizes distinct projects and ongoing programs approved by City Council that align with specific General Plan goals and policies to help achieve San Clemente's vision. Every year, each department or division updates the list by modifying the status of projects, marking projects as complete, or adding new projects for both Planning Commission and City Council review. The updated SIP reflects the priorities in the Fiscal Year 2023-2024 Budget. The updated SIP guides the City in determining future budget planning through the prioritization of projects. Approving this agenda item will update the General Plan Strategic Implementation Program (SIP) for Fiscal Year 2023-2024.

#### Background:

On February 4, 2014, the City Council adopted the Centennial General Plan, the City's comprehensive long-term policy document comprised of goals and policies for achieving San Clemente's vision. Since General Plan adoption, the City made progress on the General Plan Strategic Implementation Program (SIP) that lists and prioritizes projects and ongoing programs to implement General Plan goals and policies, known as "Implementation Measures" (IMs). Housing IMs are listed and evaluated separately in the Housing Action Plan. The SIP describes and ties implementation measures to elements and policies, and identifies the status, priority, and lead department for each action item. The City updates the SIP each year to:

- Ensure the General Plan responds to changing needs and conditions, and to commit resources to the community's long term vision;
- Evaluate progress towards goals by reviewing the status of IMs underway or completed;
- Determine IMs to implement in the next fiscal year;
- Identify the department or entities to lead and/or help carry out IMs.

#### Discussion:

#### Priority and Status of Implementation Measures:

The SIP includes IMs that are both one-time projects and reoccurring activities (on-going). Four categories are used to rank the priority of IMs:

- 1) "**High priority**" are projects required by law, needed for public health or safety, or a Council mandate to be initiated and completed, where applicable, within a 3-year timeframe.
- 2) "**Medium priority**" are important, non-urgent projects, which are to be initiated and completed, where applicable, within a 5-year timeframe.
- 3) "Low priority" are non-urgent projects essential to a department's overall mission, and require several years of planning and design, and should be initiated and completed, where applicable, in a 5+ year timeframe.
- 4) "On-going" are regular, recurring activities with no specified end.

Table 1 below summarizes the status count of the current SIP for Fiscal Year 2022-2023 (FY23) compared to the proposed SIP for Fiscal Year 2023-2024 (FY24). Refer to **Attachment 1 Exhibit A** for the proposed SIP that provides a description and status of each "One-time" IM still to be completed. IMs labeled as "on-going" are continual efforts included in current operating or Capital Improvement Program budgets, and are listed separately in **Attachment 1 Exhibit B**. Costs related to IMs not previously approved by Council will either be presented as a future Decision Package item or incorporated into the budget delineated with relevant costs. **Attachment 4** provides a list of IMs completed since 2014 including the nine (9) IMs completed within FY23.

#### <u>Proposed Changes to the Strategic Implementation Program:</u>

Staff recommends changes to the SIP based on a review of resources, staff capacity, prior Council direction, community needs and interest, opportunities for efficiencies, and other criteria. The manager or lead position for each division or department makes the recommended changes to their own IMs. Refer to **Attachment 2** and **3** for recommended changes to the IMs provided in tracked changes format. Below is a summary of notable proposed changes:

- Completed IM Economic Development Element policy (ED-2.02, 2.04), by coordinating training and grant program with the Small Business Development Center to support local small businesses with improving their online presence. Staff has also participated in meetings with the San Clemente Chamber of Commerce to host a job fair in association with Orange County Workforce Development and explore expanding workforce services and programs locally.
- Completed IM Governance Element policy (G-2.04), by pursuing grants for sidewalk improvements, housing/homeless services, parking management, historic preservation, and sand replenishment. The City applied for the 2023 Clean Mobility Options grant and anticipates applying for OCTA's next call for applications for Measure V funding to further support the SC Rides and Trolley programs.
- Completed IM Land Use Element (LU-1b), updating Specific Plans for City areas outside and within the Coastal Zone to be consistent with the Centennial General Plan and Coastal Land Use Plan.
- Completed IM Land Use Element policy (LU-8.01, 8.02) by updating the Rancho San Clemente and Talega Specific Plan Business and Industrial Park automotive use regulations to streamline the relocation of automotive uses away from the El Camino Real area.

#### Environmental Review/Analysis:

#### Environmental Review/Compliance

At its meeting on April 19, 2023, the Planning Commission completed an environmental assessment for the SIP update in accordance with the California Environmental Quality Act (CEQA) and determined, through the adoption of Resolution No. PC 23-005, that the SIP update does not require further environmental analysis because the SIP update: 1) is not a "project" within the meaning of the term in State CEQA Guidelines Section 15378, and 2) is exempt under Section 15061(b)(3), the general rule exemption. The SIP is limited to an organizational and administrative government activity to list, prioritize, and to direct resources through the budget process to meet City goals. SIP projects are separately processed and evaluated according to CEQA.

#### **RESOLUTION NO. 23-68**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, APPROVING THE GENERAL PLAN STRATEGIC IMPLEMENTATION PROGRAM FOR FISCAL YEAR 2023-2024

WHEREAS, the State of California requires cities to have an adopted General Plan to provide guidance on land use decisions; and

WHEREAS, on February 4, 2014, the City Council approved the Centennial General Plan, dated February 2014, and certified Final Environmental Impact Report (FEIR), State Clearinghouse (SCH) No. 2013041021, mitigation monitoring and reporting program, and statement of overriding considerations;

WHEREAS, the City of San Clemente Centennial General Plan ("General Plan") is the City's comprehensive long-term policy document comprised of goals and policies for achieving San Clemente's vision. The plan guides land use and physical development of the geographic area of the incorporated City limits; and

WHEREAS, the General Plan contains the seven State-required elements and six additional elements, as follows: 1) Land Use; 2) Urban Design; 3) Historic Preservation; 4) Economic Development; 5) Mobility and Complete Streets; 6) Housing, 7) Beaches, Parks and Recreation; 8) Natural Resources; 9) Coastal; 10) Safety; 11) Public Services, Facilities and Utilities; 12) Growth Management; and 13) Governance; and

WHEREAS, each General Plan element has goals and policies that are intended to achieve specific objectives. The City's General Plan Strategic Implementation Program (SIP), updated each fiscal year with the budget, lists and prioritizes specific projects and ongoing programs or "Implementation Measures" that align with goals and policies in General Plan Elements, excluding Housing. For the Housing Element, implementation measures are included in a Housing Action Plan certified by the California Department of Housing and Community Development (HCD) with the Housing Element; and

WHEREAS, the City has prepared a SIP for Fiscal Year 2023-2024 (FY2023-24 SIP) to achieve the goals and policies of the General Plan; and

WHEREAS, on April 19, 2023, the Planning Commission held a duly noticed public hearing on the Project, completing an environmental assessment on the FY2023-24 SIP according to the California Environmental Quality Act (CEQA), and adopted PC Resolution No. 23-005, finding that the FY2023-24 SIP does not meet the definition of a "project" pursuant to CEQA Guidelines Section 15378 and therefore does not require further environmental analysis.

WHEREAS, on April 19, 2023 the Planning Commission held a hearing on the Project, considered information presented by staff, and received input from other interested parties, and recommended the City Council approve the FY2023-24 SIP; and

WHEREAS, on July 18, 2023, the City Council of the City of San Clemente held a duly notice public hearing on the FY2023-24 SIP, considered written and oral comments, and facts and evidence presented by City staff, and other interested parties.

NOW, THEREFORE, the City Council of the City of San Clemente does hereby find, resolve and determine as follows:

Section 1. Incorporation of Recitals.

The City Council hereby finds that all of the facts in the Recitals are true and correct and are incorporated and adopted as findings of the City Council as fully set forth in this resolution.

<u>Section 2.</u> General Plan Consistency Findings

The FY2023-24 SIP is consistent with the Centennial General Plan, in that:

- A. The SIP is a set of implementation measures to ensure the goals and policies of the Centennial General Plan are carried out over a long period of time through the implementation of day-to-day activities and short-term actions;
- B. The SIP will help evaluate policies, procedures, and projects to ensure that they are working towards the goals and policies set forth in the Centennial General Plan;
- C. The SIP will help identify projects to be included in the annual budget, based on yearly evaluation of priorities, to ensure appropriate funding, resources, and time are given to implement the various implementation measures; and
- D. The SIP will help make the Centennial General Plan a "living document" that is able to evolve over time and respond to the changing needs of the community over time.

Section 3. Approval of FY2023-24 Strategic Implementation Program

Based on the entire record, including all written and oral evidence presented to the City Council, and the findings made and evidence discussed in the staff report and this Resolution, the City Council approves the FY2023-24 SIP set forth in Exhibit A and Exhibit B, which are incorporated herein fully by reference.

### RESOLUTION NO. PC 23-005

A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF SAN CLEMENTE, CALIFORNIA, RECOMMENDING THAT THE CITY COUNCIL APPROVE THE GENERAL PLAN STRATEGIC IMPLEMENTATION PROGRAM (SIP) FOR FISCAL YEAR 2023-2024

WHEREAS, the State of California requires cities to have an adopted General Plan to provide guidance on land use decisions; and

WHEREAS, on February 4, 2014, the City Council approved the Centennial General Plan, dated February 2014, and certified Final Environmental Impact Report (FEIR), State Clearinghouse (SCH) No. 2013041021, mitigation monitoring program, and statements of overriding consideration;

WHEREAS, the City of San Clemente Centennial General Plan ("General Plan") is the City's comprehensive long-term policy document comprised of goals and policies for achieving San Clemente's vision. The plan guides land use and physical development of the geographic area of the incorporated City limits; and

WHEREAS, the General Plan contains the seven State-required elements and six additional elements, as follows: 1) Land Use; 2) Urban Design; 3) Historic Preservation; 4) Economic Development; 5) Mobility and Complete Streets; 6) Housing, 7) Beaches, Parks and Recreation; 8) Natural Resources; 9) Coastal; 10) Safety; 11) Public Services, Facilities and Utilities; 12) Growth Management; and 13) Governance; and

WHEREAS, each General Plan Element has goals and policies that are intended to achieve specific objectives. The City's General Plan Strategic Implementation Program (SIP), updated each fiscal year with the budget, lists and prioritizes specific projects and ongoing programs or Implementation Measures that align with goals and policies in General Plan Elements, excluding Housing. For the Housing Element, implementation measures are included in a Housing Action Plan certified by the California Department of Housing and Community Development ("HCD") with the Housing Element; and

WHEREAS, the City has prepared a SIP for Fiscal Year 2023-2024 ("FY2023-24 SIP") to achieve the goals and policies of the General Plan; and

WHEREAS, the Planning Division completed an environmental assessment on the FY2023-24 SIP according to the California Environmental Quality Act (CEQA), and recommends that the Planning Commission finds the FY2023-24 SIP does not require further environmental analysis because the FY2023-24 SIP: 1) is not a "project" within the meaning of the term in State CEQA Guidelines Section 15378, and 2) is exempt under Section 15061(b)(3), the general rule exemption; and

WHEREAS, on April 19, 2023, the Planning Commission of the City of San Clemente held a public meeting on the FY2023-24 SIP, considered written and oral comments, and facts and evidence presented by City staff, and other interested parties. The FY2023-24 SIP is Exhibit A and Exhibit B incorporated herein by reference.

NOW, THEREFORE, the Planning Commission of the City of San Clemente does hereby resolve as follows:

### Section 1. Incorporation of Recitals.

The Planning Commission hereby finds that all of the facts in the Recitals are true and correct and are incorporated and adopted as findings of the Planning Commission as fully set forth in this resolution.

### Section 2. CEQA Findings.

Based upon its review of the entire record, including the Staff Report, any public comments or testimony presented to the Planning Commission, and the facts outlined below, the Planning Commission hereby finds the FY2023-24 SIP does not require further environmental analysis because the FY2023-24 SIP: 1) is not a "project" within the meaning of the term in State CEQA Guidelines Section 15378, and 2) is exempt under Section 15061(b)(3), the general rule exemption. The FY2023-24 SIP is limited to an organizational and administrative government activity to list and prioritize General Plan implementation measures, evaluate progress, and to direct resources through the budget process to meet City goals. General Plan implementation activities are separately processed and evaluated according to CEQA.

### Section 3. General Plan Consistency Findings

The Planning Commission hereby finds that the FY2023-24 SIP is consistent with the Centennial General Plan and the Plan's goal to achieve continuous progress in implementing the City's Five-Year "Strategic Implementation Program", in that:

- A. The SIP is a set of implementation measures to ensure the goals and policies of the Centennial General Plan are carried out over a long period of time through the implementation of day-to-day activities and short-term actions;
- B. The SIP will help evaluate policies, procedures, and projects to ensure that they are working towards the goals and policies set forth in the Centennial General Plan;
- C. The SIP will help identify projects to be included in the annual budget, based on yearly evaluation of priorities, to ensure appropriate funding, resources, and time are given to implement the various implementation measures;

- D. The SIP will help make the Centennial General Plan a "living document" that is able to evolve over time and respond to the changing needs of the community over time;
- E. Consistent with the Governance Element, the SIP assists City Council in preparing the Long Term Financial Plan and Strategic Priorities to implement the General Plan priority actions in a timely manner; and
- F. Consistent with the Governance Element, the SIP completes the City's objective in tracking and reporting progress with achieving the goals of the Centennial General Plan by evaluating the effectiveness of Implementation Measures and by complying with State requirements to prepare a City-wide Annual Progress Report.

### Section 4. Approval of FY2023-24 Strategic Implementation Program

Based on the entire record, including all written and oral evidence presented to the Planning Commission, and the findings made and evidence discussed in the Staff Report and this Resolution, the Planning Commission hereby recommends the City Council approve the FY2023-24 SIP set forth in **Exhibit A** and **Exhibit B** incorporated herein by reference.

Staff noted that the Long Range Planning team is currently working on the Local Coastal Program, and that considerations of this issue could be addressed under that work program..
- Suggestion to revise the Special Activities Permit request process, including
  potential to allow for approval of several activities at the same time rather
  than limiting it to one approval per year. Also suggested that certain types
  of Special Activities Permits may require Planning Commission review to
  ensure that proper notification is occurring for events and additional scrutiny
  for events in sensitive areas.. Staff clarified that Special Activities Permits
  are managed by the Planning division for activities on private property, while
  Special Event Permits are managed by the Beaches Parks and Recreation
  Department for activities on City Properties, including City-sponsored
  events.
- Consideration of revising the appeal process to allow the Planning Commission to appeal projects approved at the Zoning Administrator level.
- Established from staff that any testimony provided by a Planning Commissioner at higher level meetings can only be presented as a private citizen unless permission has been granted to speak for the Commission.
