Summary: Staff is seeking Commission recommendations on an FY 2023-24 Beaches, Parks &

Recreation Commission Work Plan. The purpose of the Work Plan is to gain approval

on fiscal year project priorities and Commission objectives from the City Council.

Discussion: At its August 8, 2023, regular meeting, the Beaches, Parks & Recreation Commission

continued the work plan item with direction to have each commissioner provide a list of proposed items to the Beaches, Parks & Recreation Director to be compiled and

reviewed at a later date.

The comprehensive listing of items received is provided below with the last name of the Commissioner who proposed the item listed at the end.

Maintenance and Operations

- a. Add refrigerated drinking foundation/water bottle refill stations on the beach trail (Elliot)
- b. Beautify San Clemente: collaboration with garden club and local nurseries to beautify our parks by planting succulents, flowers, and beautiful plants (Johnson)
- c. Inclusive/sensory playground equipment for children with special needs (Johnson)
- d. Install more workout equipment on beaches
- e. Furniture (tables and benches) replacement at San Gorgonio Park and Pier (Kweskin)
- f. Replace basketball court backboards at San Gorgonio Park (Kweskin)

Capital Projects/Development

- a. Restroom installation at Linda Lane Park (Ambrose)
- b. Redevelopment of soccer field at Vista Hermosa (level field, etc.) (Johnson)
- c. Redevelopment/repairs of the multipurpose field at San Gorgonio Park (Kweskin, Johnson)
- d. Establish a pump track (Johnson)
- e. Pursue/support development of miniature golf facility (Johnson)
- f. Develop community gardens (Johnson)

g. Bocce ball facility at San Luis Rey Park at former lawn bowling site (Kweskin, Johnson)

- h. Roller skate rink site (Kweskin, Johnson)
- i. Develop a space to display restored military equipment and include a small memorial recognizing the names of San Clemente fallen soldiers (Johnson)
- j. Erect a statue of Ole Hanson at Casa Romantica or name a park "Ole Hanson Park" (Johnson)
- k. Establish a "Professional Surfers Recognition Plaza", recognizing San Clemente professional surfers who have made a significant contribution to the community through various charity project initiatives (Johnson)
- I. Build an off-leash dog park south of golf course property on State Park property (Kweskin)

- b. Consider exceptions to the 10 p.m. beach curfew for seasonal beach activities, such as the grunion run (Elliot)
- c. Implement options for dog access on beaches (Feuerstein)

- e. Improve park reservations (Johnson)
- f. Funding and sponsorships committee (Feuerstein)
- g. Collaborate with Human Affairs Committee to cohost health and resource fairs (Johnson)
- h. Take no action or further review on the master plan updates (Ambrose)

- Placemaking at North Beach Review of options for the use of the lot located at North Beach (1832 N. El Camino Real) and consideration of playground replacement at North Beach
