CONSIDERATION OF A RESOLUTION APPROVING THE 2022-2023 CONSOLIDATED ANNUAL PERFORMANCE EVALUATION REPORT (CAPER) FOR EXPENDITURE OF COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS

Fiscal Impact:

There is no fiscal impact related to filing the CAPER.

Summary:

This is the review and approval of the Fiscal Year 2022-23 CAPER Report, which summarizes the Community Development Block Grant (CDBG) program's expenditures and accomplishments. Each year, the City submits an Annual Action Plan in May and the CAPER in September to satisfy federal grant requirements to continue to receive funding from the Department of Housing and Urban Development (HUD). During the 2022-23 reporting period, the City received \$297,860 in CDBG funds. In addition, \$133,597 in prior year uncommitted funds and \$28,922 in program income (i.e., housing rehabilitation loan repayments) were also available. Additionally, in 2020, the City received \$654,596 in Community Development Block Grant-Coronavirus (CDBG-CV) funds from HUD. These funds were authorized under the CARES Act of 2020. The City has three years to expend 80 percent of CDBG-CV funds and six years to spend 100 percent of grant funds. The City continued to expend CDBG-CV funds during FY 2022-23.

Background:

Each year, HUD determines the amount of CDBG funds that the City is entitled to receive based on population, income, and housing needs. To continue receiving CDBG funds, the City Council must approve the CAPER, which summarizes program expenditures and accomplishments for each CDBG-funded activity for the prior year, i.e., the FY 2022-23 reporting period. The City must submit the CAPER to HUD within 90 days after the end of the fiscal year.

The CAPER requires a 15-day notice period to allow the public to submit comments in writing. Residents may also provide comments at the October 3, 2023 City Council meeting. A public meeting is required twice a year to receive Federal CDBG grants. The first meeting is for adopting the Annual Action Plan, typically submitted in May, to use funds during the following fiscal year. Through the Annual Action Plan, the City outlines the projects, activities, and programs it will undertake to meet the goals identified in the City's Consolidated Plan. A second meeting is held at the end of the fiscal year to review the CAPER and evaluate how the funds were spent; this meeting meets the latter requirement.

Discussion:

Every five years, the City prepares a Consolidated Plan describing the proposed use of CDBG and other applicable federal program funds. The Consolidated Plan, which was updated and adopted in May 2020, identifies the City's overall vision and strategy for addressing housing and non-housing needs with CDBG funds. At the end of each year, the City is required to submit to HUD its year-end performance report, the CAPER.

One of the high-priority needs identified in the City's Consolidated Plan is to provide programs to meet low-and moderate-income San Clemente residents' housing needs. The City has provided loans and grants for Home Rehabilitation since 1994 and continues to do so with CDBG funds. During Fiscal Year 2022-23, six owner-occupied housing units were rehabilitated.

CDBG funds were also utilized to improve the City's public infrastructure. The 2022-23 Fiscal Year Action Plan provided additional funding to reconstruct sidewalks and ADA-compliant curb ramps on the 100 and 200 blocks of Avenida Cabrillo. This capital improvement project represented approximately 60 percent of CDBG funds spent during the FY 2022-23. The project was initially funded in FY 2019-20; design and engineering were completed in January 2022, and construction began in March 2022. The contractor discovered buried concrete during excavation, delaying the project demolition. Work was suspended in May 2022 due to project supply issues, but resumed in June 2022. The project was completed in June 2023.

CDBG funding is also allocated to support various public service programs. Public service programs benefit the community, families, and individuals by addressing housing, health, and social service needs. During the 2022-23 fiscal year, service providers assisted 4,995 residents through services funded by CDBG. Additionally, CDBG Program Administration funds were allocated to the Fair Housing Foundation and for CDBG program consultants, who help the City administer the grant and the City's Housing Rehabilitation Program. The CAPER summarizes the following funded programs and identifies how program goals were met.

- 1. During the reporting period, \$90,000 was reallocated to Housing Rehabilitation from the Cabrillo Park Project.
- 2. A total of \$925,018 in CDBG was allocated to the project over four years a four-year total of \$817,642 was spent on the project. Unspent funds will be reprogrammed.

Typically, some funding is not entirely spent on projects and activities. During the year, the City also receives repayments of past home rehabilitation loans. Unspent funds are carried over to the following fiscal year to help fund additional eligible activities or housing rehabilitation loans.

Additionally, during the FY 2022-23 reporting period, the City continued to implement activities to prevent, prepare for, or respond to local impacts of the COVID-19 pandemic. Under the CARES Act of 2020, HUD allocated the City \$654,596 in CDBG-Coronavirus (CDBG-CV) funds in two funding rounds. In 2020, the City allocated CDBG-CV funds for services that assisted lower-income San Clemente residents at risk of losing housing or utility services due to a COVID-19-related financial impact. Funds were also allocated to provide homeless outreach and engagement services. The latter services were critical to linking the homeless to COVID-19 testing, vaccinations, and other service and housing interventions. During the FY 2022-23 reporting period, 168 homeless individuals were assisted by the City's Homeless Outreach Team, which CDBG-CV partially funded. Over three years, 1,797 San Clemente residents and 40 businesses have been helped with CDBG-CV funding. Table 2 summarizes expenditures and the number of residents served with CDBG-CV funds during FY 2022-23.

Initially, HUD required that 80 percent of CDBG-CV funds be spent within three years and 100 percent spent within six years; however, in April 2023, HUD issued a notice waiving the three-year/80 percent expenditure threshold. The City expended 100 percent of CDBG-CV funding by June 30, 2023.

CR-05 - Goals and Outcomes

Progress the jurisdiction has made in carrying out its strategic plan and its action plan. 91.520(a)

The City of San Clemente is a recipient of Community Development Block Grant (CDBG) funds from the U.S. Department of Housing and Urban Development (HUD). CDBG funds may be used for various activities, provided the primary beneficiaries meet HUD's definition of a low- and moderate-income individual. To receive CDBG funds, the City is required to prepare a strategic plan that identifies housing and community needs, prioritizes needs, and identifies programs and goals to address priority needs. This strategic plan is known as the Consolidated Plan. The current Consolidated Plan was approved by the City Council in May 2020 for the five years of Fiscal Year (FY) 2020-21 through FY 2024-25. On an annual basis, the City prepares an expenditure plan (the Annual Action Plan) that lists specific activities the City will carry out with CDBG funds that meet the housing and community needs identified in the Consolidated Plan. At the end of each fiscal year, the City is required to prepare an accomplishment report. This report is the Consolidated Annual Performance and Evaluation Report (CAPER). In addition to comparing planned versus actual accomplishments for the respective fiscal year, the CAPER tracks the City's progress toward meeting the 5-year goals established in the Consolidated Plan.

The 2022-2023 CAPER summarizes the CDBG-funded activities undertaken by the City from July 1, 2022, through June 30, 2023 (FY 2022-23). FY 2022-23 is the third year of the five years covered by the current Consolidated Plan. Accomplishment highlights for the year include the following:

- Infrastructure and Facility Improvements: 4th year of funding for sidewalk improvements at the 100 and 200 Block of Avenida Cabrillo between El Camino Real and Calle Seville. Design and engineering were completed in January 2022, and construction began in March 2022. The contractor discovered buried concrete during excavation, delaying the project demo. Work was suspended in May 2022 due to project supply issues but resumed in June 2022. The project was completed in June 2023.
- Housing Rehabilitation: Six homeowners were assisted during the reporting period.
- Public Social Services: Approximately 2,800 lower-income San Clemente residents were assisted during the reporting period.
- At-risk of Homelessness: Over 2,180 individuals were provided financial assistance and support services (e.g., case management, foodbank) to prevent homelessness.
- Administration: CDBG funds were used to provide program oversight and coordination and fair housing services to 57 households
- The Orange County Housing Authority (OCHA) reports that it assisted 130 San Clemente households with a rental assistance voucher or certificate during the reporting period.

Pursuant to the CARES Act of 2020, HUD allocated the City \$654,596 in CDBG-Coronavirus (CDBG-CV) funds. HUD requires that CDBG-CV funds be used to prevent, prepare for, or respond to local impacts of the Coronavirus pandemic. HUD requires that the City spend 80% of CDBG-CV funds in three years and 100% in six years; however, in April 2023, HUD waived the 80% expenditure requirement.

During the FY 2022-23 reporting period, the City used CDBG-CV funds to provide homeless outreach and engagement services. These services were critical to linking the homeless to COVID-19 testing, vaccinations, and other service and housing interventions. During the FY 2022-23 reporting period, 168 individuals were assisted. The City has used 100% of CDBG-CV funding.

Detailed expenditure and accomplishment information for FY 2022-23 CDBG and CDBG-CV activities undertaken during the reporting period is provided in **Attachment 1**.

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

As summarized in Table 1, the City used CDBG funds to address the priority needs identified in the Consolidated Plan, including safety net programs for lower-income households:

- Camino Health Center provides reduced-cost medical and pediatric dental care services for lower-income households, including the uninsured and the homeless – 2,448 individuals were served during FY 2022-23.
- Family Assistance Ministries (FAM) provides housing and support services for households at risk
 of becoming homeless and those already homeless. FAM provided case management and food
 for 2,050 lower-income San Clemente residents, including 12 individuals who received rent or
 utility assistance.
- The Fair Housing Foundation (FHF) provides services to overcome impediments to accessing safe and decent housing. The FHF provided outreach, education, and enforcement services for tenants, landlords, and property managers 57 households were served during FY 2022-23.
- Fun on the Run, a City-sponsored program, provides after-school and summer recreation services for lower-income youth; 316 youths were assisted during the FY 2022-23 reporting period.
- Laura's House provides various support services for domestic violence victims, including a 24-hour hotline, referrals, safe house planning, and transitional housing 137 individuals were served during the reporting period, including 22 with transitional housing.
- Parentis Foundation provides reading intervention tutoring for elementary-age children.
 Parentis links local senior volunteer tutors with children not reading at grade level. A total of 26
 San Clemente youths were assisted during the FY 2022-23 reporting period.

The City offered housing rehabilitation assistance to qualified homeowners and rental property owners. The programs aim to preserve and improve the City's existing housing stock. Improvements typically include installing new energy-efficient windows, termite treatment, new water heaters, and other housing health and safety improvements. During the reporting period, housing rehabilitation assistance was provided to six homeowners. As previously reported, OCHA provided rental assistance to 130 San Clemente renter households. Accomplishments for the CDBG grant are summarized in **Attachment 1**.

City Public Works staff completed sidewalk improvement to the 100 and 200 blocks of Avenida Cabrillo. The project was initially funded in FY 2019-20. Design and engineering were completed in January 2022, and construction began in March 2022. The contractor discovered buried concrete during excavation, delaying the project demo. Work was suspended in May 2022 due to project supply issues but resumed in June 2022. The project was completed in June 2023.

With respect to CDBG-CV funding, the City utilized \$63,558 to support homeless outreach and referral services - 168 individuals were assisted with CDBG-CV funds during the reporting period.

Accomplishments for the CDBG-CV grant are summarized in **Attachment 1**.

Narrative

According to the U.S. Census Bureau, most San Clemente residents are racially White – 79.5% (2021 American Community Survey 5-Year Estimates). This data source also reports that 16.4% of the City's population is Hispanic/Latino – the City's largest minority population.

Based on Table 2, approximately 85% of program participants are White; 51% are reported to be ethnically Hispanic/Latino. A closer look at the accomplishment data from individual activities provides additional insight. A significant percentage of safety net program participants, such as medical care and youth recreation services, are lower-income Hispanic/Latino households. Accomplishment data provided by CDBG sub-recipients also indicates that over 89% of program beneficiaries are from extremely low-income households (i.e., a household with income less than 30% of the County median income). While data from the Consolidated Plan indicates no one San Clemente minority population is disproportionally experiencing a housing cost burden (i.e., households paying more than 30% of monthly income for housing), data from Table 2 and sub-recipients indicates that, in general, lower-income households may be economically unstable and seek services to help to stabilize their economic situation.

Performance data for CDBG-CV-funded activities are similar to data from CDBG-funded activities. Approximately 94% of assisted residents are White, and 15.5% are Hispanic/Latino. Overall, 100.00% of assisted residents are extremely low-income.

Narrative

According to the City's 2022-23 Annual Action Plan, the City anticipated utilizing \$431,457 in CDBG program resources comprised of its 2022 CDBG Annual Allocation of \$297,860, plus \$133,597 in Prior Year Funds. The City did not anticipate receiving CDBG Program Income funds during the reporting period (i.e., Revolving Loan funds generated by the repayment of prior CDBG-funded housing rehabilitation loans). During the reporting period, the City received its 2022 CDBG grant of \$297,860 and had access to \$133,597 in Prior Year funds. Additionally, the City received \$28,922 in program income. As identified in Table 3, the City spent \$668,505 in CDBG funds during the reporting period.

In 2020, the City received \$654,596 in CDBG-CV funding in two rounds. The City expended \$63,558 in CDBG-CV funds during the FY 2022-23 reporting period. Cumulatively, the City has spent all CDBG-CV funds. A detailed summary of CDBG and CDBG-CV expenditures is provided in **Attachment 2 (PR26: Financial Summary Reports)**.

Narrative

Table 4 indicates that most CDBG expenditures during the 2022-23 reporting period were used in CDBG-eligible neighborhoods. All CDBG-CV funds were spent citywide. A list of the City's CDBG-eligible areas is provided in **Attachment 3**.

Leveraging

The City of San Clemente made an effort to leverage CDBG funds to the greatest extent possible. During the reporting period, \$120,300 in other funds were used to support activities consistent with Consolidated Plan goals:

Cabrillo Av Sidewalk Improvements: \$90,200 - Street Improvement Fund
 Community Service Grants: \$30,000 - American Recovery Plan Act

There is no match requirement for the CDBG program.

Discuss the difference between goals and outcomes and problems encountered in meeting these goals.

The City exceeded planned housing rehabilitation program goals for the 2022-23 reporting period. The 2022-2023 Annual Action Plan set a one-year goal to rehabilitate three owner-occupied housing units. During the reporting period, program staff assisted with rehabilitating six owner-occupied units.

Discuss how these outcomes will impact future annual action plans.

During the FY 2016-17 report period, the City undertook a comprehensive re-writing of its housing rehabilitation program. The revised program policies and procedures were necessary to ensure program participant eligibility and proper underwriting (to protect the public's investment), and to increase program participation. Program staff prepared new program information materials for dissemination in target neighborhoods, and program funding was increased. The result has been an unprecedented number of program applicants and the City expects this trend to continue.

Narrative Information

Table 7 provides information regarding the households that received housing rehabilitation assistance during FY 2022-23. As previously reported, OCHA provided 130 lower-income San Clemente households with rental assistance during the 2022-23 reporting period.

The City is not a recipient of HOME funds.

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

No CDBG funds were allocated during the 2022-23 reporting period for homeless outreach; however, the City used CDBG-CV funds to provide street outreach services for persons experiencing homelessness. During the 2022-23 reporting period, the City's Homeless Outreach staff assisted 168 homeless individuals. Street outreach and engagement services were enhanced to provide COVID-19-related information, referrals, and assistance (e.g., COVID-19 testing, vaccination, and housing referrals). The Orange County Sheriff and regional homeless service providers such as Family Assistance Ministries (FAM) have also established outreach programs that engage homeless families. These efforts align with the regional Continuum of Care and its outreach and assessment strategy.

Addressing the emergency shelter and transitional housing needs of homeless persons

During the 2022-23 reporting period, the City allocated CDBG funds to Laura's House to provide emergency shelter, transitional housing, and support services for victims of domestic violence. Laura's House provided transitional shelter to 22 individuals during the reporting period.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

The City's homeless strategy delineated in the Consolidated Plan calls for providing safety net services that help prevent individuals and families from becoming homeless. To this end, during the 2022-23 reporting period, CDBG funds were allocated to programs that assisted lower-income San Clemente households in maintaining shelter and meeting basic needs. Family Assistance Ministries (FAM) used CDBG funds to assist 12 lower-income San Clemente residents with financial assistance to prevent eviction or utility shut-offs. FAM also provided case management and food bank services to 2,038 lower-income San Clemente residents. OCHA reports providing rental assistance to nine disabled homeless households with Continuum of Care Permanent Supportive Housing Certificates. Four formerly homeless veterans received Veterans Affairs Supportive Housing (VASH) housing vouchers, and eight households received Emergency Housing Vouchers to address a COVID-19 impact.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

During the 2022-23 reporting period, no CDBG funding was allocated to fund permanent housing activities for homeless persons. However, as reported above, OCHA provided nine homeless households with Continuum of Care Permanent Supportive Housing Certificates, four homeless veterans received Veterans Affairs Supportive Housing (VASH), and eight San Clemente households received Emergency Housing Vouchers to address a COVID-19 impact.

The 2022-2023 Annual Action Plan indicates that the City would address barriers to affordable housing by considering the following actions:

- **Housing Resources:** Inclusionary Housing in-lieu fees are available to help nonprofit agencies purchase land or existing housing units to create long-term affordable housing opportunities.
- **Environmental Review:** City staff is available to assist property owners and developers in navigating environmental review regulations to help reduce holding costs associated with the time needed to comply with environmental reviews.
- Planning and Development Fees: The City typically does not offer fee waivers; however, the
 City Council can approve a waiver, offer deferred or reduced fees, or supplement fees with
 public funds for affordable housing projects.
- Permit and Processing Procedures: For an affordable housing project, City staff is available to
 interact with project sponsors to help determine project feasibility and guide a developer
 through the entitlement process.
- Land Use Controls: In general, land use controls are necessary to protect public health, safety, and welfare and maintain the quality of life. The City has implemented reasonable controls that are appropriate for the community.
- Tax Policies: There is no local tax.

One affordable housing development project was initiated during the reporting period that accessed these policies. The Memorial Care Senior Housing & Medical Office project will contain 250 units - 20 units for very low-income senior households. The project received a density bonus and modified development standards for height and number of stories.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

The City recognizes that special needs populations face challenges due to low income and their unique conditions (e.g., a disability). These factors make such individuals more likely to become homeless and often require housing and supportive services. The City considers supportive services and housing for special needs populations a priority. Supportive services are also considered a high priority in the Continuum of Care of Orange County. During FY 2022-23, the City-funded public service agencies provided a social safety net to help at-risk households. Services included access to reduced health care for lower-income San Clemente residents. Other special needs services funded during the reporting period include counseling and safe housing for domestic violence victims. These services became increasingly crucial during the reporting period in response to the social and financial impacts of the COVID-19 virus on San Clemente residents.

CAPER 2022-2023

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

The Residential Lead-Based Paint (LBP) Hazard Reduction Act of 1992 changed the federal approach to addressing LBP by emphasizing preventing childhood lead poisoning through housing-based approaches. In response, the City includes lead-based paint hazard reduction as an eligible activity in its housing rehabilitation programs.

All application packets for the City's housing rehabilitation program include a notice to educate residents about the health dangers of lead and encourage screening of children for elevated blood-lead levels. All existing units are screened for lead-based paint before using federal funds. Housing units identified as having lead-based paint hazards are treated so the lead-based paint hazards are abated per federal requirements. The City's housing rehabilitation program is also designed to ensure safe work practices, as dictated by HUD, are implemented to address lead-paint hazards. One housing unit rehabilitated during FY 2022-23 was constructed after 1978; therefore, it is exempt from lead-based paint hazards compliance. The other units rehabilitated during the reporting period were exempt from Lead-based paint compliance.

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

According to the U.S. Census Bureau, approximately 5.3% of San Clemente residents have incomes below the poverty level. This figure includes approximately 4.6% of City residents aged 65 and older and 2.7% of children under 18.^[1] The Consolidated Plan and Annual Action Plan indicate that the City will support social services and housing activities for households below the poverty line in recognition that income enhancement services can help to increase household stability.

Recognizing that poverty-level households may need assistance, the City funded several activities to assist lower-income residents. For example, Camino Health Center, which provides reduced-cost medical and pediatric dental services for lower-income San Clemente residents, reports that approximately 83% of the program's FY 2022-23 beneficiaries have extremely low incomes. As previously reported, approximately 95% of households assisted by Family Assistance Ministries with food, rent, and utility assistance are extremely low-income. It is evident from this data that CDBG and CDBG-CV resources were critical resources in the community and assisted many individuals living in or near poverty.

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

During FY 2022-23, the City continued efforts to eliminate institutional gaps and coordinate programs within the community and regionally. For example, the City partnered with local nonprofits to deliver public services. City departments also worked together to evaluate projects funded in whole or in part with CDBG funds that address priority needs. The City assisted OCHA by participating in the Cities Advisory Committee – a quarterly meeting of cities and OCHA to discuss federal rental housing assistance and regional housing issues. On a regional basis, the City supported the Orange County Continuum of Care (CoC) as it prepared the County's CoC Homeless Assistance grant application for HUD consideration.

The City also supports the CoC's efforts to develop the County's plan to end chronic homelessness and the regional discharge plan.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

As indicated above, the City participated in regional coordination of services by participating in the quarterly Cities Advisory Committee held by OCHA to discuss federal rental housing assistance issues and as a member of the Orange County CoC Forum. Furthermore, through its CDBG and general fund grant programs, the City has coordinated the delivery of social services to the community that address various needs. The City has also established relationships with residential for-profit and nonprofit developers that may be prepared to respond to local affordable housing development opportunities.

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

Consolidated Plan regulations require CDBG recipients to (1) examine and attempt to alleviate housing discrimination within their jurisdiction; (2) promote fair housing choice for all persons; (3) provide opportunities for all persons to reside in any given housing development, regardless of race, color, religion, sex, disability, familial status, or national origin; (4) promote housing that is accessible to and usable by persons with disabilities; and (5) comply with the non-discrimination requirements of the Fair Housing Act. HUD encourages jurisdictions to consult with one another and initiate metropolitan-wide fair housing planning. The **Analysis of Impediments to Fair Housing Choice (AI)** is the primary document for this purpose.

During the FY 2020-21 reporting period, the City participated as one of 20 jurisdictions in preparing the Orange County 2020-2024 Analysis of Impediments to Fair Housing (OC-AI). The OC-AI identified various actions that can be implemented over five years to address regional and local barriers to fair housing. The City contracts with the Fair Housing Foundation to provide fair housing outreach, education, and enforcement services and help the City address the impediments to fair housing identified in the OC-AI. A summary of AI-related actions is provided in **Attachment 4**.

The City's monitoring program has been designed to provide program staff with information to verify the accuracy of data supplied by sub-recipients, ensure that sub-recipients are carrying out individual activities as described in their contracts, and ensure that sub-recipients use appropriate accounting and record-keeping methods to manage CDBG funds. CDBG program policies help ensure sub-recipients receive training regarding CDBG grant management, CDBG program goals, and subrecipient obligations. Due to the COVID-19 pandemic, training was not held during the FY 2022-23 reporting period; however, it is anticipated that this training will be held during FY 2023-24.

On-site monitoring of sub-recipients is conducted biennially unless program or administrative issues are identified or the grant recipient is new to CDBG. The City conducted on-site monitoring during the FY 2021-22 reporting period. In general, sub-recipients are complying with program requirements. Staff anticipates that sub-recipient monitoring will take place during FY 2023-24.

During the reporting period, program staff worked closely with City departments to ensure CDBG program regulations and other federal requirements were implemented. City departments and public service grant sub-recipients submit quarterly accomplishment reports. Subrecipients are also required to provide documentation to support CDBG reimbursement requests. Program staff conducts a desk monitoring of this information to ensure CDBG program compliance.

The City also made every effort to comply with CDBG and Consolidated Plan regulations. The City's Citizen Participation Plan ensures that community input is considered before undertaking a substantial amendment or submitting an annual update to HUD. It also provides residents the opportunity to review and comment on annual performance. Construction, professional service, and subrecipient agreements have been prepared to ensure compliance with applicable federal regulations. Additionally, the City has implemented an open procurement process that encourages bidding from minority and women-owned businesses.

To encourage resident participation in the City's CDBG program, the City published a notice in the *San Clemente Times* on September 14, 2023, announcing a 15-day public comment period and public hearing for the 2022-23 CAPER. The CAPER was available for public review on the City's website (www.san-clemente.org/department-services/social-services/housing-services). An additional opportunity for public comments was availed at the October 3, 2023, San Clemente City Council meeting.
