INTRODUCTION OF ORDINANCE NOS. 1765, 1766, AND 1767 CODE AMENDMENTS - CHANGE LOCATION OF CITY COUNCIL MEETINGS, CHANGE OF CIVIC CENTER ADDRESS AND CHANGE THE POSTING LOCATION OF OFFICIAL CITY DOCUMENTS

## Summary:

The City Council moved to its permanent meeting location in the City Council Chambers located at 910 Calle Negocio, 2<sup>nd</sup> Floor, San Clemente in September 2022. As a result of this move, it is necessary to update San Clemente Municipal Code Section 2.04.020 to reflect the change in address.

Additionally, updates are needed to San Clemente Municipal Code Section 1.04.070 which references the previous Civic Center located at 100 Avenida Presidio, and San Clemente Municipal Code Section 1.04.080 which designates posting locations for official City documents.

Below is a summary of the changes, as reflected in the Ordinances provided as attachments in this agenda report:

## Ordinance No. 1765

Change San Clemente Municipal Code 1.04.070 to designate the Civic Center as located at 910 Calle Negocio, San Clemente, California 92673.

## Ordinance No. 1766

Official City documents will be posted on the bulletin board at City Hall, located at 910 Calle Negocio, San Clemente, California 92673 and on the City website.

## Ordinance No. 1767

Designating the City Council Chambers located at 910 Calle Negocio, 2<sup>nd</sup> Floor as the permanent meeting location of the City Council.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING CHAPTER 1.04.070 OF THE MUNICIPAL CODE OF THE CITY OF SAN CLEMENTE, RELATING TO THE CIVIC CENTER LOCATED AT 910 CALLE NEGOCIO, SAN CLEMENTE, CALIFORNIA 92673

**WHEREAS,** City staff no longer occupies the building located at 100 Avenida Presidio.

**WHEREAS,** with City Administration permanently occupying the City owned property located at 910 Calle Negocio, this location shall hereby be designated as the Civic Center;

**WHEREAS**, this change requires an amendment to the San Clemente Municipal Code (SCMC); and

**NOW, THEREFORE**, the City Council of the City of San Clemente, California, hereby ordains as follows:

<u>Section 1:</u> Chapter 1.04.070 of the SCMC, relating to the designation of the Civic Center shall hereby be changed to 910 Calle Negocio.

<u>Section 2:</u> If any section, subsection, subdivision, paragraph, sentence, clause or phrase added by this Ordinance, or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Ordinance or any part thereof. The City Council hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more subsections, subdivisions, paragraphs, sentences, clauses or phrases are declared unconstitutional, invalid or ineffective.

Section 3. This Ordinance shall become effective on January 4, 2024.

<u>Section 4.</u> Upon this Ordinance becoming effective, all previous Ordinances and Resolutions that are inconsistent herewith are hereby repealed to the extent of such inconsistency.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING CHAPTER 1.04.080 OF THE MUNICIPAL CODE OF THE CITY OF SAN CLEMENTE, RELATING TO DESIGNATING PUBLIC PLACES FOR POSTING OFFICIAL CITY DOCUMENTS AND REPEALING ORDINANCE NO. 93

**WHEREAS,** the Civic Center is designated at 910 Calle Negocio, and as result, all official City documents shall be posted on the bulletin board located at the Civic Center;

**WHEREAS,** this change requires an amendment to the San Clemente Municipal Code (SCMC); and

**NOW, THEREFORE**, the City Council of the City of San Clemente, California, hereby ordains as follows:

<u>Section 1:</u> San Clemente Municipal Code Chapter 1.04.080 related to the posting of official documents shall hereby be changed to the bulletin board located at the Civic Center at 910 Calle Negocio.

<u>Section 2:</u> If any section, subsection, subdivision, paragraph, sentence, clause or phrase added by this Ordinance, or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Ordinance or any part thereof. AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING CHAPTER 2.04.020 OF THE MUNICIPAL CODE OF THE CITY OF SAN CLEMENTE, RELATING TO LOCATION OF CITY COUNCIL MEETINGS AND REPEALING ORDINANCE NO. 411

**WHEREAS,** with the City Council Chambers being located at the Civic Center at 910 Calle Negocio, the location of City Council meetings must be changed;

**WHEREAS,** this change requires an amendment to the San Clemente Municipal Code (SCMC); and

**NOW, THEREFORE**, the City Council of the City of San Clemente, California, hereby ordains as follows:

<u>Section 1:</u> Chapter 2.04.020 of the SCMC, relating to location of City Council meetings shall hereby be changed to the City Council Chambers, located on the 2<sup>nd</sup> Floor of the Civic Center at 910 Calle Negocio.

<u>Section 2:</u> If any section, subsection, subdivision, paragraph, sentence, clause or phrase added by this Ordinance, or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Ordinance or any part thereof.
