Levels of Review and Timeframes

Planning staff will work with you to review your application as quickly as possible. Depending on the project, a zoning permit may require a staff level decision or a public hearing decision.

Staff level decisions.

The Zoning Code allows staff to decide on the following types of zoning services because are considered minor without significant public concern or impacts. This type of permit is reviewed by staff without a public hearing. For staff level decisions, usually the review is limited to verifying your project meets requirements and following up with you. In most instances, applications are reviewed within one-to-two weeks, but may involve more time if an application is missing information or a review involves discussion with other City staff, such as building and engineering.

Public hearing decisions.

The Zoning Code requires a public hearing decision to allow projects when the City has determined there is potential for public concern or land use impacts to warrant additional review and a transparent decision with public input and notice. For a public hearing decision, more steps are involved, such as a staff meeting, environmental review, design review, and public hearings. - Zoning Administrator 6 weeks from complete application to hearing.
- Planning Commission 14 weeks from complete application to hearing.
- City Council 19 weeks from complete application to hearing.
